**Control Persons;** Shares held by DCG International Investments Ltd., a wholly owned subsidiary of Digital Currency Group, Inc. The person controlling Digital Currency Group, Inc. is Barry E. Silbert as founder and CEO and in such capacity has voting and dispositive power over the securities held by such entity. Mr. Silbert's address is c/o Grayscale Investments, LLC, 290 Harbor Drive, 4th Floor, Stamford, CT 06902.

**Ownership;** As set forth in the Limited Liability Company Agreement for the Issuer, investors in Grayscale Products do not have controlling ownership or interests (and therefore do not hold a class of voting security) to be deemed a control person. The shareholders do not participate in the management or control of the Fund; and in fact, authorize the Manager to perform and engage in matters that arise without further approval or vote of shareholders.

Due to the nature of Grayscale's structure and the structure of its products, OTC Markets Group has exempted Grayscale from displaying shareholders with an ownership less than 10%. Such shareholders do not have any controlling ownership, controlling interests or power, nor do they hold a class of voting securities. The disclosure of 10%+ownership accounts for the limited individuals/entities that have such capacity regarding voting and dispositive power over the securities held by an issuer. Transfer agent records are used to determine the disclosure of 10%+ ownership accounts and does not include the individual holders who have bought/sold Shares on OTCQB or transferred their eligible Shares to their brokerage accounts.
