The OSCE is assisting the Government of Moldova in fulfilling commitments in good governance and anti-corruption, as well as aligning its national standards with the UN Convention against Corruption, the Istanbul Anti-Corruption Action Plan, and other international standards and good practices.

Corruption is a major threat to Moldova's stability and security. There is a strong popular demand for consistent anti-corruption actions aimed at strengthening the integrity of public administration and countering systematic patterns of both high-level and petty corruption. In recent years, the Government of Moldova has made visible efforts to adapt adequate strategies in order to tackle the issue of corruption, however, the number of cases involving prosecution of corruption remains low.

#### **Anti-corruption at the OSCE**

Promoting good economic governance and preventing and combating corruption are key elements of the OSCE's comprehensive approach to security, and one of the main priorities of the Office of the Co-ordinator of OSCE Economic and Environmental Activities (OCEEA).

The OCEEA has been mandated by the participating States to combat corruption and money laundering through a holistic and cross-dimensional approach to security.

Moldova has taken decisive steps toward reforms, particularly in the justice sector, where anti-corruption remains a key pillar. As part of its EU accession process, Moldova is committed to conducting proactive and efficient corruption investigations, with an emphasis on establishing a credible track record of prosecutions. Additionally, the country is aligning its efforts with international standards and commitments, specifically those set by the OSCE, the UN Convention against Corruption (UNCAC), and the Istanbul Anti-Corruption Action Plan.
