INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

The delegation of Hungary, in its capacity as EU Presidency, passed the floor to the representative of the European Union, who delivered the following statement (also on behalf of the United States of America):

"In connection with the Permanent Council decision on the timetable of the Thirty-First Meeting of the OSCE Ministerial Council, the European Union would like to make the following interpretative statement under the relevant provisions of the Rules of Procedure:

The European Union welcomes the adoption of the Permanent Council decision on the timetable for the Thirty-First Meeting of the OSCE Ministerial Council, in line with the Rules of Procedure. However, we regret that consensus could not be reached on the draft Permanent Council decision which included both the timetable and organizational modalities as initially proposed by the Maltese Chairmanship. The EU found this proposal acceptable, as it was based on the last agreed relevant Permanent Council decision.

In the absence of a Permanent Council decision on the organizational modalities for this Ministerial Council meeting, we reaffirm that representatives of international organizations, institutions and initiatives should be invited to participate, deliver oral interventions, or distribute written contributions according to the previously agreed list. We do not see any new developments that would warrant expanding this list at this time.

We request that this interpretative statement be attached to the decision and to the journal of today's meeting.

The United States of America aligns itself with this statement.
