3. Chair's announcements concerning Coordinators' decisions

At the meeting on 14 November, PETI Coordinators adopted the following decisions:

3. Adoption of the draft agenda of the PETI meeting of 2-3 December 2024

Coordinators approved the draft agenda of the PETI Committee meeting of 2-3 December 2024.

4. Calendar of PETI meetings for 2025

Coordinators endorsed the proposed calendar for PETI Committee meetings in 2025.

5. Proposals for future meetings

Coordinators decided to apply the urgency procedure to Petition No 1098/2024 and include it in the agenda of the committee meeting of January 2025 (EPP request).

Coordinators decided to include in the agenda of the committee meeting of January 2025 the following petitions: Petitions Nos 0679/2024, 0087/2020, 149/2020, 289/2020 and 0718/2023 (EPP request), 0607/2024 and 0793/2024 (S&D request).

Coordinators decided to include Petition No 1056/2016 on the tabling of petitions in national sign languages (Patriots for Europe request) in a forthcoming meeting agenda of PETI committee as soon as DG ITEC finalises the requested work on the Petitions Portal. The Coordinator of the P/E Group called for setting the deadline for DG ITEC at the end of January 2025.

Coordinators decided not to include Petitions Nos 0644/2024, 0799/2024 (ECR request), 0960/2023 and 1345/2023 (GREENS/EFA request) in the agenda of PETI committee meeting of January 2025.

6. Attendance at Coordinators' meetings

Coordinators agreed on the following protocol of attendance in Coordinators' meeting: Chair, Coordinators, political group advisors who follow the activities of the committee, including a representative of the secretariat of the non-attached Members, Parliament's officials whose functions justify their presence (e.g. committee secretariat staff, representatives of the Legal Service and the relevant policy department and representatives of the Private Offices of the President and the Secretary-General) and maximum one assistant for each Coordinator present.

7. Decision to be taken on Petitions 0920/2011 and 0103/2023 (B-Items from PETI Committee meeting of 3 October 2024) and on the procedure to be taken in case of multiple requests on the same B-item

The majority of Coordinators decided to close the petitions Nos 0920/2011 and 0103/2023 and to update point 15(c) of PETI guidelines on the treatment of B-items as follows: in the case of multiple requests on the same B-item, which include a request to give the petitioner 2 months to provide additional information, Coordinators vote on all requests, including the 2 months request.

The Coordinators of the S&D, Greens/EFA and The Left Groups disagreed with both decisions.

8. Request for Public Hearings first half of 2025

Coordinators decided to organise the following two public hearings in the first semester 2025:

- Public hearing on the suspension of procedures for evictions and squatting (based on Petitions 1535/2020, 1124/2021, 0503/2022, 0112/2023), with 4 experts (EPP request);

- Public hearing on border checks and future of Schengen area (based on petitions 0585-2023, 0509-2024), with 4 experts and LIBE involvement (ECR request).

9. Requests for fact-finding visits for the first half of 2025

Coordinators decided to hold the following two Fact-Finding Visits in the first semester 2025:

- FFV to Salzburg (Austria) based on petitions 1055/2019, 0827/2020, 1102/2020, 0772/2023 with regard to the wolf population (EPP and ECR requests) and based on petition 0798/2024 on amending the EU Deforestation Regulation (EPP request). Coordinators decided to conduct this FFV in the green week of April 2025.

- FFV to Algeciras and Barbate (Spain) based on petition 1407/2023 on labour rights of police officers in the EU (Pfe request). Coordinators decided to conduct this FFV in the green week of Mai 2025.

10. Hearing of the candidates for the European Ombudsman Office - Election of the Ombudsman 2024

Coordinators endorsed the proposed procedure and the draft agenda of the Hearing scheduled for 3 December 2024 during the PETI committee meeting.

11. Approval of the program of the PETI Annual Workshop on Disabilities (2 December 2024)

Coordinators endorsed the draft programme of the PETI Annual Workshop on Disabilities scheduled for 2 December 2024.

12. Request by the GREENS' Group to allow MEP Cristina GUARDA to attend remotely PETI Committee Meeting on 2 December 2024

Coordinators decided to authorise MEP Cristina GUARDA to attend remotely PETI Committee Meeting on 2 December 2024 (Application of Rule 222 RoP).

The Chair informed the Greens' Coordinator that the request to allow MEP Guarda to attend remotely the hearing of the European Ombudsman candidates should be addressed to the President of the EP.

13. Appointment of PETI Members for the Gender Mainstreaming Network

Coordinators decided to appoint MEP Joanna SCHEURING-WIELGUS (S&D) and MEP Cristina GUARDA (Greens/EFA) respectively as PETI permanent Member and substitute Member in the Gender Mainstreaming Network.

14. Requests concerning B-items

Coordinators decided to deal with the requests concerning B-items by written procedure.
