After consultation of the coordinators, on 19 March 2024, AGRI Committee has decided to appoint, Mr. Juozas Olekas (S&D) as EP representative for the aforementioned selection jury and for the ceremony on 23 September next.

Since Mr. Olekas was not re-elected, the Socialist Group designated Mr Nardella as a replacement by email to the Secretariat dated 22 July.

The Secretariat will communicate this nomination to the Commission with a letter from the AGRI Chair.
