The Committee on Rules, having had under consideration House Resolution \_\_\_\_, by a record vote of 8 to 3, report the same to the House with the recommendation that the resolution be adopted.

### SUMMARY OF PROVISIONS OF THE RESOLUTION

The resolution provides for consideration of H.R. 8997, the Energy and Water Development and Related Agencies Appropriations Act, 2025, under a structured rule. The resolution waives all points of order against consideration of the bill. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees. The resolution provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print 118-42 shall be considered as adopted and the bill, as amended, shall be considered as read. The resolution waives all points of order against provisions in the bill, as amended. The resolution makes in order only those amendments printed in part A of the report, amendments en bloc described in section 3 and pro forma amendments described in section 4. Each amendment shall be considered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be

debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment except as provided by section 4 of the resolution, and shall not be subject to a demand for division of the question. All points of order against the amendments printed in part A of the report or amendments en bloc described in section 3 of the resolution are waived. The resolution provides that the chair of the Committee on Appropriations or his designee may offer amendments en bloc consisting of amendments printed in part A of the report not earlier disposed of. Amendments en bloc shall be considered as read, shall be debatable for 20 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees, shall not be subject to amendment except as provided by section 4 of the resolution, and shall not be subject to a demand for division of the question. The resolution provides that the chair and ranking minority member of the Committee on Appropriations or their respective designees may offer up to 10 pro forma amendments each at any point for the purpose of debate. The resolution provides for one motion to recommit. The resolution further provides for consideration of H.R. 8998, the Department of the Interior, Environment, and Related Agencies Appropriations Act, 2025, under a structured rule. The resolution waives all points of order against consideration of the bill. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees. The resolution provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print 118-41 shall be considered as read. The resolution waives all points of order against provisions in the bill, as amended. The resolution makes in order only those amendments printed in part B of the report, amendments en bloc described in section 8 and pro forma amendments described in section 9. Each amendment shall be considered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment except as provided by section 9 of the resolution, and shall not be subject to a demand for division of the question. All points of order against the amendments printed in part B of the report or amendments en bloc described in section 8 of the resolution are waived. The resolution provides that the chair of the Committee on Appropriations or his designee may offer amendments en bloc consisting of amendments printed in part B of the report not earlier disposed of. Amendments en bloc shall be considered as read, shall be debatable for 20 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees, shall not be subject to amendment except as provided by section 9 of the resolution, and shall not be subject to a demand for division of the question. The resolution provides that the chair and ranking minority member of the Committee on Appropriations or their respective designees may offer up to 10 pro forma amendments each at any point for the purpose of debate. The resolution provides for one motion to recommit.

SUMMARY OF THE AMENDMENTS TO H.R. 8997 IN PART A MADE IN  
ORDER

1. Beyer (VA), Trahan (MA), Lofgren (CA): Increases and decreases funding for the DOE's Office of Science fusion materials and fuel cycle research and development to reflect needs identified in the Bold Decadal Vision for Commercial Fusion Energy. (10 minutes)
2. Bilirakis (FL), Sarbanes (MD): Increases and decreases funding for the Eastern Mediterranean Energy Center, as established under section 204(c) of the Eastern Mediterranean Security and Energy Partnership Act of 2019 (22 U.S.C. 2373 note) in International Affairs under the Departmental Administration account by \$6,000,000. (10 minutes)
3. Blunt Rochester (DE): Increases and decreases the Energy Efficiency and Renewable Energy Account by \$1,000,000 to highlight the continuation of activities within the Federal Energy Management Program that support AFFECT grant funding, Energy Savings Performance Contracts, and Utility Energy Service Contracts. (10 minutes)
4. Brecheen (OK): Prohibits funds to reinstate the general license for export of nuclear material to China. (10 minutes)
5. Comer (KY), Bost (IL), Budzinski (IL): Increases and decreases funding for salaries of the Office of the Assistant Secretary of the Army for Civil Works by the same amount for the purpose of stipulating claims in *Riverview Farms v. United States* and *Angelly v. United States* are the taking of private property for a public purpose and settling such claims. (10 minutes)
6. Costa (CA), Harder (CA), Thompson (CA), Lofgren (CA), Panetta (CA), Fong (CA): Increases the Bureau of Reclamation's Water and Related Resources account by \$3 million offset by a \$3 million reduction to the Departmental Administration account to support technical assistance and financial assistance related to groundwater recharge projects, aquifer storage and recovery projects, or water source substitution for aquifer protection projects. (10 minutes)
7. Dingell (MI): Increases and decreases DOE's Office of Energy Efficiency and Renewable Energy by \$25,000,000 for an industry-led consortium to accelerate the development of advanced, non-battery, automotive materials. (10 minutes)
8. Duarte (CA), Costa (CA), Fong (CA), Harder (CA): Increases and decreases funding for the Operation and Maintenance account of the U.S. Army Corps of Engineers – Civil to conduct a study on the sediment build-up in rivers and streams in the San Joaquin River Watershed and to make recommendations to Congress on actions to improve channel flows, reduce flood risk to communities, and improve riverbanks. (10 minutes)
9. Flood (NE): Prohibits funding for lab-grown meat at the Department of Energy. (10 minutes)
10. Garamendi (CA): Prohibits funds made available for this Act to be used for the W87-1 modification program. (10 minutes)

11. Garamendi (CA): Prohibits funds made available by this Act to be used for the Savannah River Plutonium Modernization Program. (10 minutes)
12. Gluesenkamp Perez (WA): Increases and decreases funding for the Department of Energy's Weatherization Assistance Program to encourage prioritizing grants available for manufactured housing skirting, awning, and other traditional means of energy efficiency. (10 minutes)
13. Gonzales, Tony (TX): Increases funding by \$1 million to \$6 million for the Southwest Border Regional Commission, offset by the DOE Departmental Administration account. (10 minutes)
14. Gonzalez, Vicente (TX): Increases the Water and Related Resources by \$2,000,000 to highlight the importance of the WaterSMART Program for drought resilience and canal lining. Decreases funding from Policy and Administration account. (10 minutes)
15. Gottheimer (NJ): Increases and decreases funding for Flood Control and Coastal Emergencies for the Army Corps of Engineers to conduct dredging of water reservoirs to prevent flooding. (10 minutes)
16. Greene (GA): Eliminates funding for the Office of Clean Energy Demonstrations. (10 minutes)
17. Griffith (VA): Increases funding for the Department of Energy's Fossil Energy and Carbon Management program by \$8,750,000 while reducing funding for Departmental Administration by \$8,750,000. (10 minutes)
18. Hageman (WY): Prohibits the Department of Energy from implementing the Industrial Decarbonization Roadmap. (10 minutes)
19. Houlihan (PA), Bergman (MI), Garbarino (NY), Bacon (NE), Schrier (WA): Increases and decreases funding for the Grid Deployment account by \$150 million to emphasize the need to address domestic shortages of large power transformers and distribution transformers through authorities within the Defense Production Act. (10 minutes)
20. Jackson (TX): Prohibits funds from being used by the NNSA to halt the construction of the HE Synthesis, Formulation, and Production facility at Pantex. (10 minutes)
21. Jackson (TX): Increases funding for the HESFP at Pantex by \$5 million to ensure the project remains on schedule. (10 minutes)
22. LaMalfa (CA): Prohibits any of the funds in this Act from being used by the Department of the Interior or its subagencies to take possession or pursue removal of the Keno Dam in Oregon. (10 minutes)
23. Luna (FL): Prohibits funds from being made available to implement or enforce Corps of Engineers memorandum CERE-AP, issued by the South Atlantic division on July 9, 1996, relating to "Approval of Perpetual Beach Storm Damage Reduction Easement as a Standard Estate." This memo requires easements to be perpetual and include public access. (10 minutes)
24. Massie (KY): Increases and decreases the Army Corps of Engineers operations and maintenance account by \$1 million to direct the Secretary to actively maintain Kentucky boat ramps owned, operated, or constructed by the Army Corps of Engineers where the maintenance is not the responsibility of a non-federal entity. (10 minutes)
25. McCormick (GA): Prohibits funds provided by this Act from closing campgrounds operated by the Army Corps of Engineers that are located at Lake Sidney Lanier, Georgia. (10 minutes)
26. Miller (WV), Mooney (WV): Increases and decreases funding for Fossil Energy and Carbon Management to ensure parity for the National Energy Technology Lab and allow subcontracts of site support prime



contractors to be counted towards the Department of Energy's small business procurement goals. (10 minutes)

27. Molinaro (NY): Increases the flood control and costal emergencies account by \$2.5 million. Takes from DOE administrative funds. (10 minutes)
28. Molinaro (NY): Increases funding for the Appalachian Regional Commission by \$5 million, takes from DOE administrative funds. (10 minutes)
29. Moylan (GU): Increases and decreases the Corps of Engineers- Civil Department of the Army, Construction account to urge the U.S. Army Corps of Engineers to provide necessary funding to WRDA projects and studies in Guam. (10 minutes)

5. Beyer (VA), Zinke (MT), Buchanan (FL): Increases and decreases funding for U.S. Geological Survey by \$1 million to support a wildlife corridors mapping team. (10 minutes)

6. Bice (OK): Prohibits federal funding for drag shows at the Smithsonian Institution. (10 minutes)
7. Boebert (CO): Reduces the salary of Michael S. Regan, Administrator of the EPA, to \$1. (10 minutes)
