

Minutes of Commission Meeting

Monday 8 May 2023

The fourth meeting of the Commission of 2023 took place at 11:00 am via MS Teams.

1. MEMBERS PRESENT

2. CHANGE IN MEMBERSHIP OF COMMISSION

The Ceann Comhairle welcomed Deputy Michael Ring, who was attending the Commission meeting for the first time since his appointment to the Commission, and thanked Deputy Joe Carey who had resigned his position on the Commission.

3. MINUTES OF PREVIOUS MEETINGS

The Minutes of the meeting of 27 March 2023 were agreed by the Commission.

4. FINANCE COMMITTEE MEMBERSHIP

The Commission appointed Deputy Michael Ring to serve on the Commission's Finance Committee to fill the vacancy arising as a consequence of the resignation of Deputy Joe Carey from the Commission.

5. AUDIT COMMITTEE MEMBERSHIP

The Commission appointed Deputy Rose Conway Walsh to serve on the Commission's Audit Committee to fill the vacancy arising as a consequence of the resignation of Deputy Mairéad Farrell from the Committee.

6. PRINT USERS' COUNCIL MEMBERSHIP

The Commission appointed Deputy Jennifer Murnane O'Connor and Senator Paddy Burke to serve on the Print Users' Council to fill vacancies arising as a consequence of changes in the membership of the Commission.

11. STRATEGIC PLAN 2022-2024

Annual Progress Report 2022

The Secretary General presented the first annual progress report on implementation of the Strategic Plan for 2022-2024 to the Commission pursuant to section 16 of the Houses of the Oireachtas Commission Acts (Commission Acts).

The Commission noted progress on implementation of the strategy in 2022.

The Commission and the Secretary General expressed appreciation to staff of the Service for their work and achievements over the past year.

12. TAOISEACH'S APPOINTMENT OF THE SUPERINTENDENT, HOUSES OF THE OIREACHTAS:

Statutory consultation pursuant to section 7 of the Staff of the Houses of the Oireachtas Act 1959, as amended.

The Commission was briefed on the recruitment and selection process conducted for appointment by the Taoiseach to the post of Superintendent, Houses of the Oireachtas, the outcome of the open recruitment competition and the candidate identified as the preferred candidate by the interview board for appointment to the position.

Pursuant to section 7 of the Staff of the Houses of the Oireachtas Act 1959, as amended, the Ceann Comhairle and the Cathaoirleach consulted with the Commission on the proposed appointment to the post by the Taoiseach.

13. SENIOR PUBLIC SERVICE APPOINTMENT:

Recommendation of the Top Level Appointments Committee to the Commission on Appointment of Assistant Secretary, Corporate and Members' Services, Houses of the Oireachtas Service

The Commission appointed Ms Rosemary Keogh to the post of Assistant Secretary, Corporate and Members' Services, Houses of the Oireachtas Service, in accordance with the letter of recommendation of the Top Level Appointments Committee (TLAC) to the Ceann Comhairle dated 10 March 2023, pursuant to the *Staff of the Houses of the Oireachtas Act 1959*, as amended, the *Houses of the Oireachtas Commission Acts 2003 to 2021* and TLAC Competition Number 753.

The Commission congratulated Ms Keogh on her appointment.
