**Vóta 16 — Tailte Éireann (Meastachán Athbhreithnithe Breise).**

Go ndeonófar suim nach mó ná €85,637,000 chun fotha an mhuirir a thiocfaidh chun bheith iniochta i rith na bliana dar críoch an 31ú lá de Nollaig, 2024, le haghaidh thuarastail agus chostais Thailte Éireann agus mionseirbhísí áirithe.

**Vóta 23 — An Coimisiún Toghcháin (Meastachán Athbhreithnithe).**

Go ndeonófar suim nach mó ná €11,719,000 chun fotha an mhuirir a thiocfaidh chun bheith iniochta i rith na bliana dar críoch an 31ú lá de Nollaig, 2024, le haghaidh thuarastail agus chostais an Choimisíúin Toghcháin.

**Vóta 34 — Tithíocht, Rialtas Áitiúil agus Oidhreacht (Meastachán Athbhreithnithe Breise).**

Go ndeonófar suim nach mó ná €6,846,571,000 chun fotha an mhuirir a thiocfaidh chun bheith iniochta i rith na bliana dar críoch an 31ú lá de Nollaig, 2024, le haghaidh thuarastail agus chostais Oifig an Aire Tithíochta, Rialtais Áitiúil agus Oidhreachta, lena n-áirtear deontais d'Údarás Áitiúla, deontais agus costais eile i ndáil le tithíocht, seirbhísí uisce, scéimeanna ilghnéitheacha, fóirdheontais, deontais agus chun deontais áirithe faoi scéimeanna airgead-teoranta a foc, agus go ndeonófar suim nach mó ná €141,000,000 trí leithreasai nár caitheadh agus a bhféadfarr a dtabhairt suas a iarchur faoi Alt 91 den Acht Airgeadais, 2004 a chur chun feidhme le haghaidh seirbhísí soláthair chaipitiúil.

**Estimates for Public Services [2024]:**

**Vote 16 — Tailte Éireann (Further Revised Estimate).**

That a sum not exceeding €85,637,000 be granted to defray the charge which will come in course of payment during the year ending on the 31st day of December, 2024, for the salaries and expenses of Tailte Éireann and certain minor services.

**Vote 23 — An Coimisiún Toghcháin (Revised Estimate).**

That a sum not exceeding €11,719,000 be granted to defray the charge which will come in course of payment during the year ending on the 31st day of December, 2024, for the salaries and expenses of an Coimisiún Toghcháin.

**Vote 34 — Housing, Local Government and Heritage (Further Revised Estimate).**

That a sum not exceeding €6,846,571,000 be granted to defray the charge which will come in course of payment during the year ending on the 31st day of December, 2024, for the salaries and expenses of the Office of the Minister for Housing, Local Government and Heritage including grants to Local Authorities, grants and other expenses in connection with housing, water services, miscellaneous schemes, subsidies, grants and payment of certain grants under cash limited schemes and that a sum not exceeding €141,000,000 be granted by way of the application for capital supply services of unspent appropriations, the surrender of which may be deferred under Section 91 of the Finance Act 2004.
