Chairman's Foreword

On behalf of the Committee of Public Accounts, I am pleased to present its Annual Report for 2020, which sets out the work undertaken by the Committee in 2020.

The Committee is a standing committee of Dáil Éireann. It has a key role to play in ensuring that there is accountability and transparency in the way Government agencies allocate, spend and manage their finances and in guaranteeing that the taxpayer receives value for money for monies spent. It is responsible for examining and reporting on reports of the Comptroller and Auditor General which deal with the accountability of departments and offices in respect of their administration of public funds. It also considers the Comptroller and Auditor General's reports on his or her examinations of economy, efficiency, effectiveness evaluation systems, procedures and practices.

The Committee held its first meeting on 17 September and held a total of 23 meetings in 2020, sitting for a total of 43.25 hours in public session. The Committee investigated issues regarding the governance and management of public finances.

The Committee agreed to publish concise recommendation focused reports setting out who the Committee engaged with and when, what the focus of the engagement was, with links to the transcript and relevant recommendations of the C&AG. It was agreed reports would also include the recommendations of the Committee with as much context as necessary for the recommendations to stand on their own.

The Committee's first report was published in December 2020. It sets out a number of conclusions arising from its engagement with the National Asset Management Agency:

1. Content and Format of Report

This report has been prepared pursuant to Standing Order 218 (9) (Dáil Éireann) as follows: "The Committee shall present an annual progress report to Dáil Éireann on its activities and plans."

2. Establishment and Functions

The Committee of Public Accounts is a standing committee of Dáil Éireann and is responsible for examining and reporting on reports of the Comptroller and Auditor General on departmental expenditure and certain other accounts. It also considers the Comptroller and Auditor General's reports on his or her examinations of economy, efficiency, effectiveness evaluation systems, procedures and practices.

The Committee has a key role to play in ensuring that there is accountability and transparency in the way Government agencies allocate, spend and manage their finances and in guaranteeing that the taxpayer receives value for money for monies spent.

2.1. Establishment of the Committee

Dáil Éireann Standing Orders provides the Orders of Reference for the Committee of Public Accounts which is a standing Committee. The Orders of Reference for the Committee were amended under Standing Order 218 on 28 July 2020.

Please see Appendix 1 on page seven for the relevant extract from Dáil Éireann Standing Orders relative to Public Business 2021.

3. Chairman, Vice-Chairman and Membership

Dáil Éireann Standing Order 104(2) provides for a proportion of Chairs to be allocated to each group by means of the D'Hondt System. Deputy Brian Stanley was appointed as Chairman of the Committee on 3 September 2020 by an Order of Dáil Éireann. Deputy Catherine Murphy was elected as Vice-Chairman of the Committee on 24 September 2020.

Membership of the Committee, including any changes within the reported period, is listed at Appendix 2 on page 10.

4. Meetings, Attendance and Recording

In 2020, Committee meetings took on a new format having regard to relevant public health guidelines on safe working (physical distancing etc.). The length of meetings was restricted to two hours and additional arrangements were made for witnesses to connect either (i) via

video link from outside the Leinster House complex (ii) via video link from a location onsite. Public meetings of the Committee took place in the Committee rooms in Leinster House 2000. Meetings were in public unless otherwise ordered by the Committee.

Committee proceedings were broadcast live within Leinster House and also made available to RTÉ, Virgin Media and TG4. Proceedings were also webcast making them available worldwide on the internet. The proceedings of Committees in public session are broadcast on the dedicated parliamentary channel Oireachtas TV which is available on these channels:

8. Travel

The Committee did not travel in 2020.

9. Report on Functions and Powers

The formal remit of the Committee is defined by Standing Order 218. The Committee is of the opinion that Standing Order 218 is unduly limiting and needs to be amended to allow the Committee to effectively scrutinise public accounts.

The Committee takes serious issue with the consequences of the changes to Standing Orders arising from the decision of the Supreme Court in Kerins v McGuinness, which it believes have given rise to an overly restrictive interpretation of the Committee's remit.

The Committee is of the view that it is in the public interest that the Committee of Public Accounts has the authority to consider matters related to public accounts as they arise.

While the Committee is clear that it must be cognisant of the 'Kerins' judgment and work accordingly, the Committee believes that Standing Order 218 needs to be amended to strike a better balance between the 'Kerins' judgment and the ability of the Committee to carry out its role effectively.

APPENDIX 1: Establishment of the Committee

Dáil Éireann Standing Orders provides the Orders of Reference for the Committee of Public Accounts. The adoption of Dáil Éireann Standing Order 218 established the Committee of Public Accounts, which is a standing Committee of Dáil Éireann. The Orders of Reference for the Committee were amended under Standing Order 218 on 28 July 2020.

Extract from Dáil Éireann Standing Orders Relative To Public Business 2021 (consolidated version)

Dáil Standing Order 218 — Committee of Public Accounts

- (1) There shall stand established, following the reassembly of the Dáil subsequent to a General Election, a Standing Committee, to be known as the Committee of Public Accounts, to examine and report to the Dáil upon—
 - (a) the accounts showing the appropriation of the sums granted by the Dáil each year to meet the public expenditure and such other accounts as they see fit (not being accounts of persons included in the Second Schedule of the Comptroller and Auditor General (Amendment) Act 1993) which are audited by the Comptroller and Auditor General and presented to the Dáil on an annual basis, together with any reports by the Comptroller and Auditor General thereon;
 - (b) the Comptroller and Auditor General's reports on his or her examinations of economy, efficiency, effectiveness evaluation systems, procedures and practices; and
 - (c) other reports carried out by the Comptroller and Auditor General under the Act.
- (2) In considering particular accounts pursuant to paragraph (1)(a), the Committee shall examine whether, having regard to changes in—
 - (a) the volume or quality of services or other outputs delivered, and
 - (b) associated expenditure, over time,

it can be demonstrated that value for money has or has not been achieved.

(3) The Committee shall bring conclusions and recommendations reported to the Dáil pursuant to paragraph (1)(a) in relation to particular accounts to the attention of the relevant Committee established pursuant to Standing Order 95.

- (4) The Committee may suggest alterations and improvements in the form of the Estimates submitted to the Dáil and shall bring any such suggestions as reported to the Dáil to the attention of the Committee on Budgetary Oversight.
- (5) The Committee may proceed with its examination of an account or a report of the Comptroller and Auditor General at any time after that account or report is presented to Dáil Éireann.
- (6) The Committee shall have the power to send for persons, papers and records.
- (7) Paragraphs (4) to (9) inclusive of Standing Order 96 shall not apply to the Committee.
- (8) Every report which the Committee proposes to make shall, on adoption by the Committee, be laid before the Dáil forthwith whereupon the Committee shall be empowered to print and publish such report together with such related documents as it thinks fit.
- (9) The Committee shall present an annual progress report to Dáil Éireann on its activities and plans.
- (10) Notwithstanding the provisions of paragraph (1) of this Standing Order, the Committee shall have the power to examine and report upon a specific matter of general public interest relating to the appropriation of public moneys, which is not comprehended by appropriation accounts or reports of the Comptroller and Auditor General within the meaning of paragraph (1), subject to—
 - (a) a positive determination having been made by the Committee on Remit Oversight under Standing Order 93A pursuant to a request by the Committee of Public Accounts under Standing Order 93B for an extension to its orders of reference for the purpose of examining the matter; and
 - (b) the approval of the Dáil by way of an appropriate motion under Standing Order 93B to instruct the Committee in conducting its examination of the matter.
- (11) The Committee shall refrain from—
 - (a) enquiring into in public session, or publishing, confidential information regarding the activities and plans of a Government Department or office, or of a body which is subject to audit, examination or inspection by the Comptroller and Auditor General, if so requested either by a member of the Government, or the body concerned; or

- (b) enquiring into the merits of a policy or policies of the Government or a member of the Government or the merits of the objectives of such policies.
- (12) The Committee may, without prejudice to the independence of the Comptroller and Auditor General in determining the work to be carried out by his or her Office or the manner in which it is carried out, in private communication, make such suggestions to the Comptroller and Auditor General regarding that work as it sees fit.
- (13) The Committee shall consist of thirteen members, none of whom shall be a member of the Government or a Minister of State, and four of whom shall constitute a quorum. The Committee and any sub-Committee which it may appoint shall be constituted so as to be impartially representative of the Dáil.
