SEC and CSE Continue Investor Education Campaign with the Latest Forum Held in Matara.

Educating investors on the role of the SEC in the market, as well as diving into the intricacies of investor protection, Manager - External Relations, SEC, Mr. Nimal Kumarasinghe, addressed the gathering as well.

Following this, Ms. Shanika Ramanayake, Senior Executive - Digital Products at the Colombo Stock Exchange, conducted a session to raise awareness about the CSE Mobile App.

Furthermore, an analysis of the sectoral performance and market opportunities was presented by the Chief Investment Officer of JB Securities (Pvt) Ltd, Mr. Sashika Wickramaratne.
