## **ADMISSION TO TRADING OF SHARES OF EDPR**

**Lisbon, March 7**<sup>th</sup> **2023**: EDP - Energias de Portugal, S.A. ("EDP") hereby informs: EDP's 71.20% owned subsidiary EDP Renováveis, S.A. ("EDPR" or the "Company") announced that on this date 50,968,400 ordinary and book-entry shares representing EDPR's share capital (i) have been created in the Central de Valores Mobiliários; and (ii) such shares were admitted to trading on the Euronext Lisbon regulated market, by virtue of the capital increase resolved by EDPR's board of directors on 2 March, 2023 and registered with the Registro Mercantil de Asturias on 3 March, 2023.

The new shares are fungible with EDPR's other shares and will confer on their holders, as from the date of the respective issue, the same rights as the other shares existing prior to the capital increase.

The 50,968,400 new shares issued are admitted to trading on the Euronext Lisbon Regulated Market under the ISIN code ES0127797019.
