Executive Summary

- CEIX recorded adjusted EBITDA⁽¹⁾ of \$179MM and free cash flow⁽¹⁾ of \$122MM for 3Q24.
- PAMC produced 7.2MM tons and sold 6.8MM tons in the quarter, both of which were third quarter records.
 - Sold 1.1MM PAMC crossover tons to the met market.
- Near the end of 3Q24, the Itmann Mine began retreat mining and by the end of October 2024, a deep cut plan was approved for two of the sections.
- PAMC has approximately 18MM tons contracted for 2025.
- Total CEIX Liquidity⁽¹⁾ of \$649MM as of 9/30/2024.
- Improving the midpoint of all 2024 PAMC guidance ranges.
- In October, we finalized agreements with the PA DEP to form a Global Water Treatment Trust Fund.
 - Expected to reduce our surety exposure by \$58MM in the next 3-6 months.
- Announced dividend of \$0.25/share, payable on November 26, 2024.
- Remain on track for a 1Q25 closing of the proposed merger to create Core Natural Resources.










Diversifying Our Revenue Mix and End Use Markets

(% of total revenue from contracts with customers)




Short-term trend reversal in the LTM period versus 2023 mostly due to reduced export pricing.



CEIX Balance Sheet Legacy Liabilities

Significant legacy liability reductions over the past three years

- Cash payments related to legacy liabilities are declining over time.
- Approximately 55% of all CEIX employee liabilities are likely "closed" as of 12/31/2023.
- CEIX's Qualified Pension Plan was funded at 110% as of 9/30/24, compared to 107% for the average S&P 1500 DB plan.
 - Plan became fully funded in 2021 with no company contributions made to the plan in over a decade, asset strategy is set to protect the surplus position.
- Actively managing ARO liabilities through discretionary project development and funding.


CEIX legacy liabilities


