It represents a 9.5% increase over the prior quarter dividend of \$0.21 per share. The dividend produces an annualized rate of \$0.92 per common share and is payable on September 23, 2024 to shareowners of record as of September 9, 2024. The annualized dividend yield is 2.67% based on a closing stock price of \$34.40 on August 28, 2024.
