


Sales and Gross Margin

(\$ millions)




EBITDA and EBITDA Margin

(\$ millions)




Diluted Earnings Per Share

(\$ actuals)




Return on Invested Capital ROIC%

Return on invested capital is defined as tax-effected LTM EBITDA / average total net operating assets.




Q2'19 SEGMENT PERFORMANCE




KEY INDICATOR PERFORMANCE




