Enhanced Debit Card Management App Launched

Upgraded card management and spend tracking features were added to the Personal Mobile Banking App. New features include the ability to add travel authorizations for upcoming travel plans; immediately turn off a lost or stolen card from a cell phone; view merchant name, logo, map location, and contact information; and contact merchants directly based on transactions.
