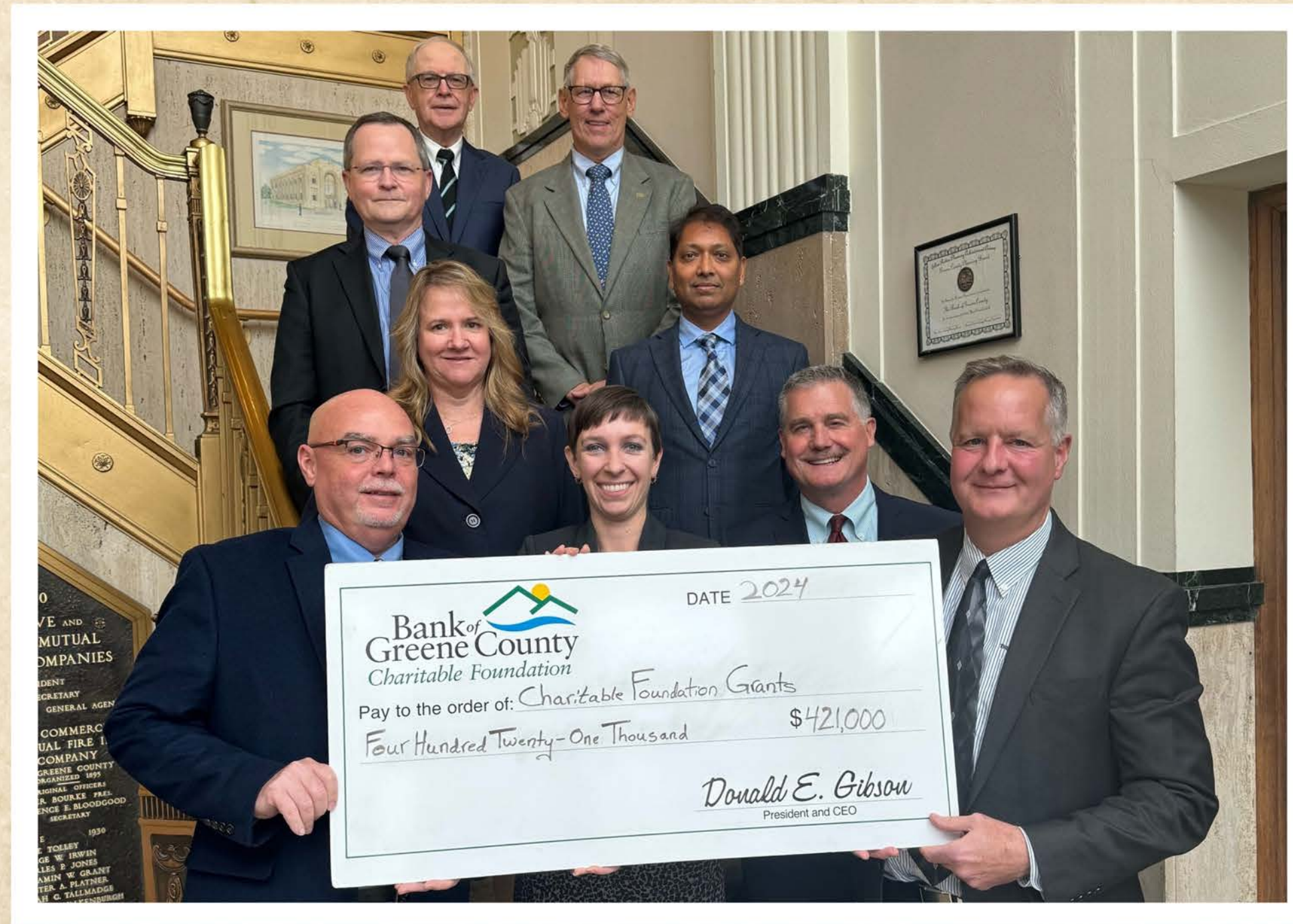

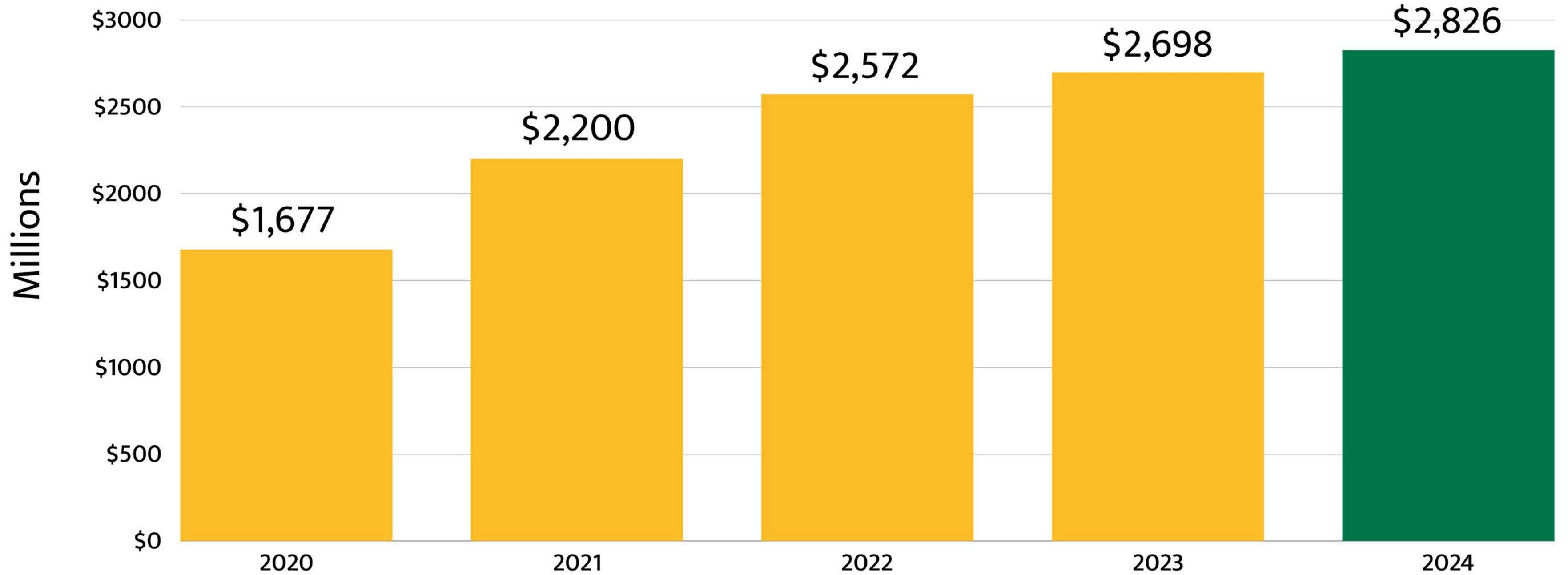

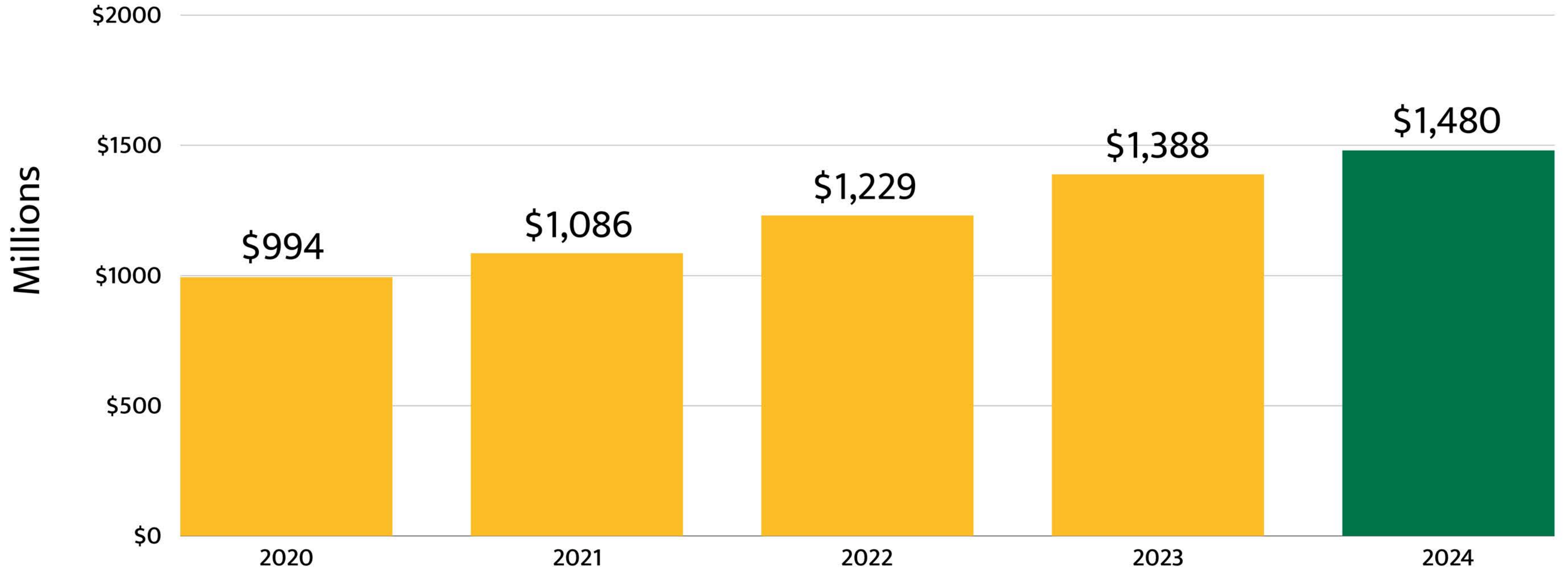

Total Assets



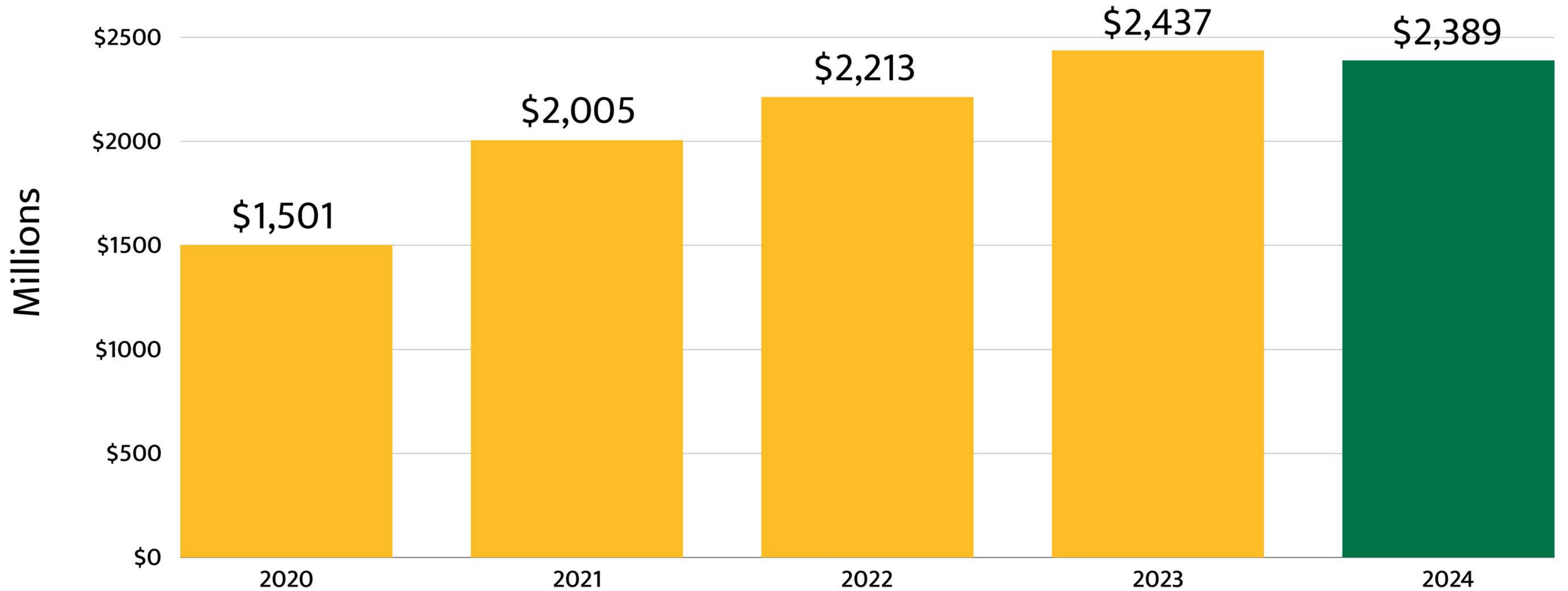
June 2020 - June 2024

Total Net Loans



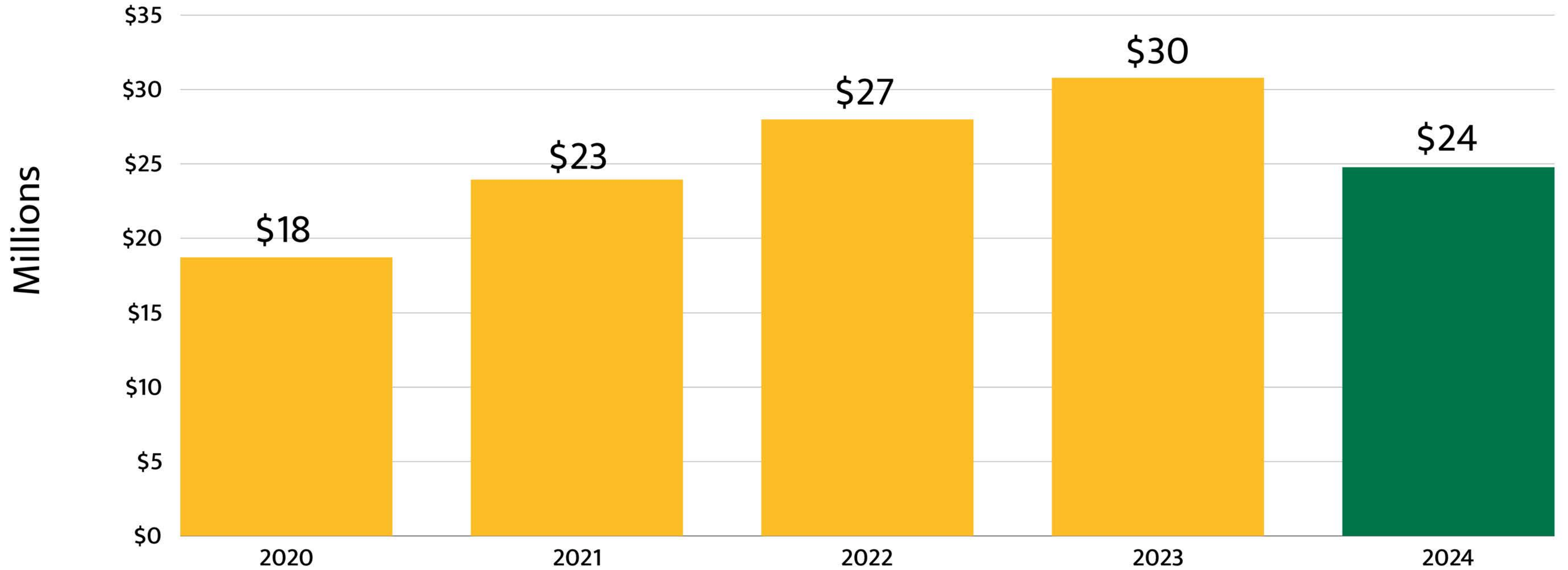

Consolidated Deposits



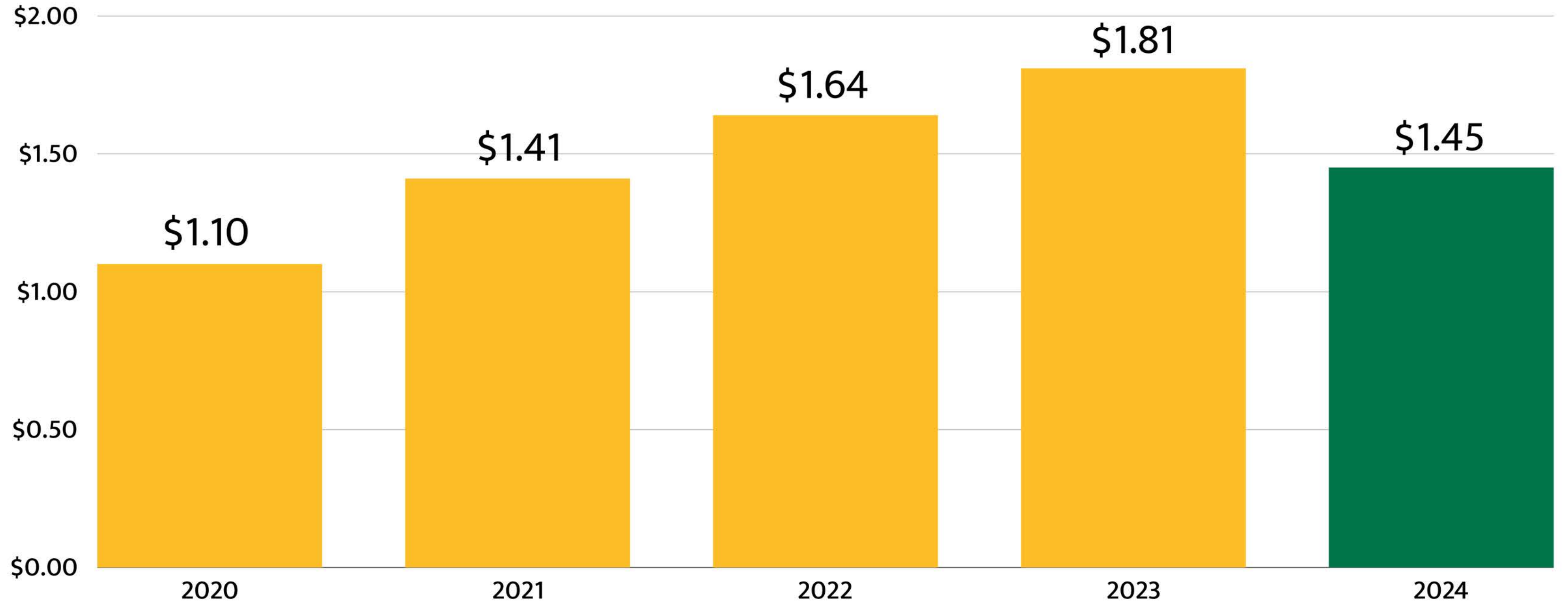

Net Income



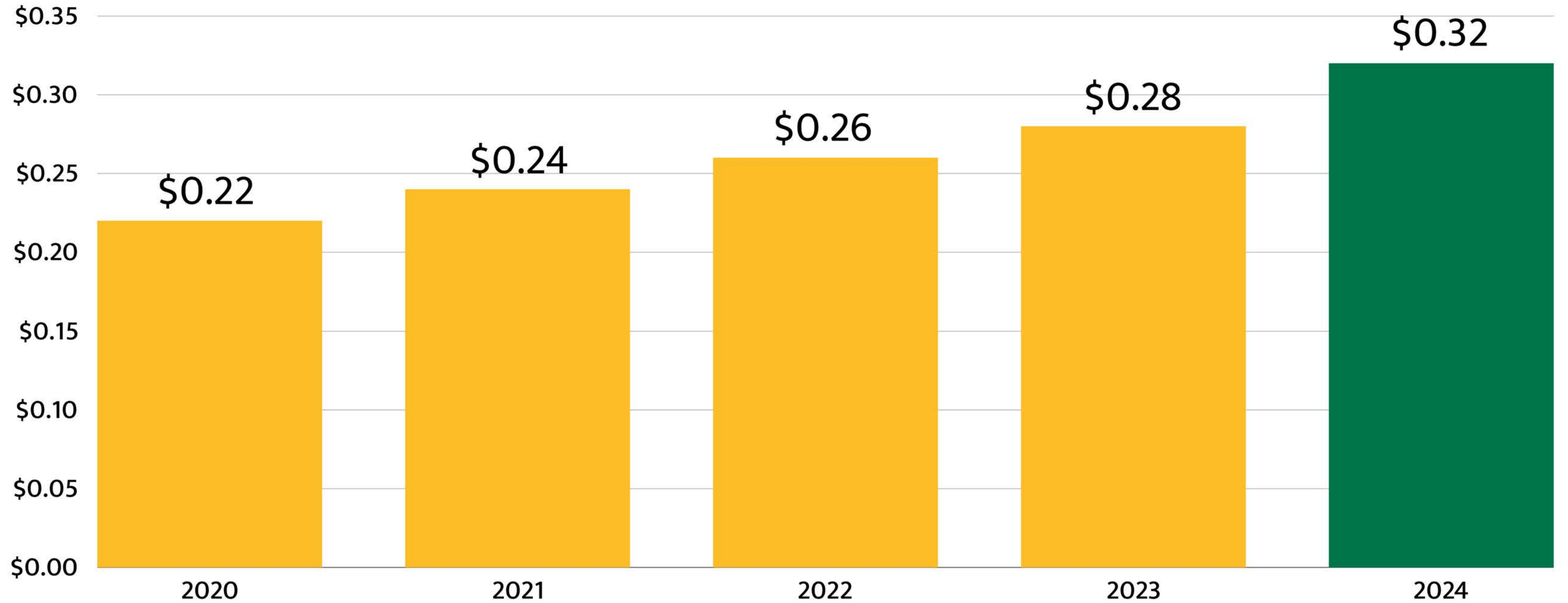

Earnings Per Share



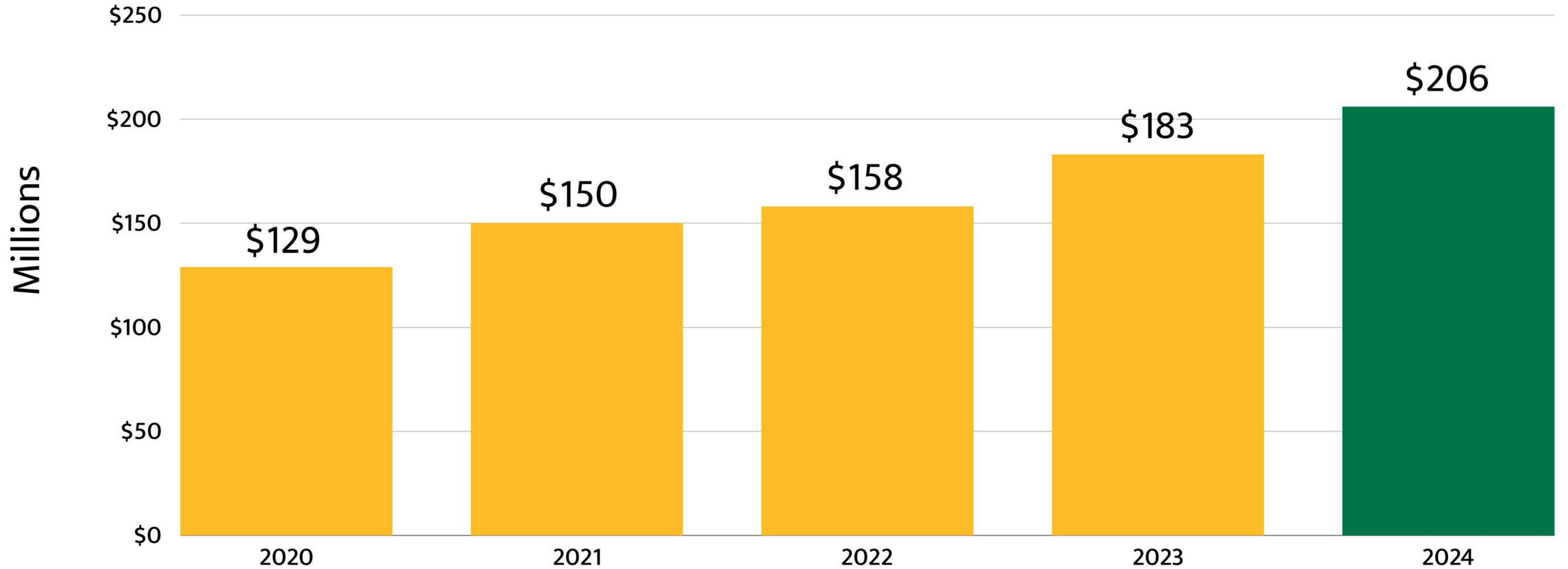

Dividend Per Share



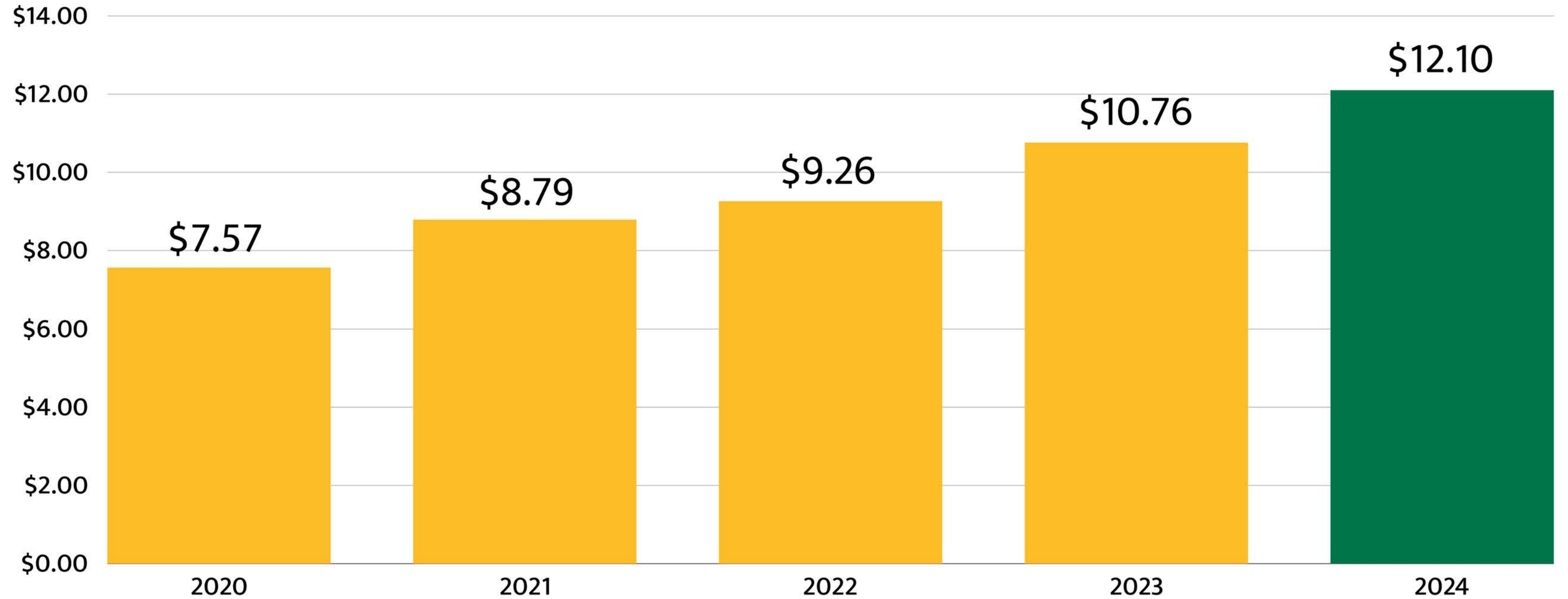

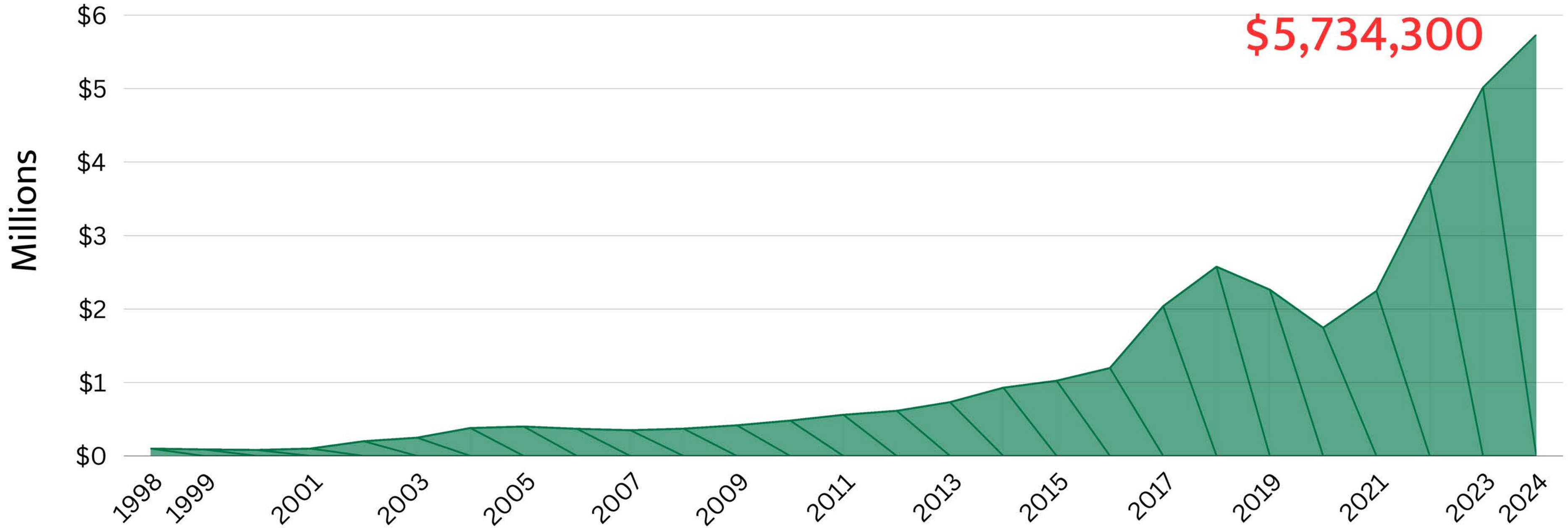

Total Return on Investment

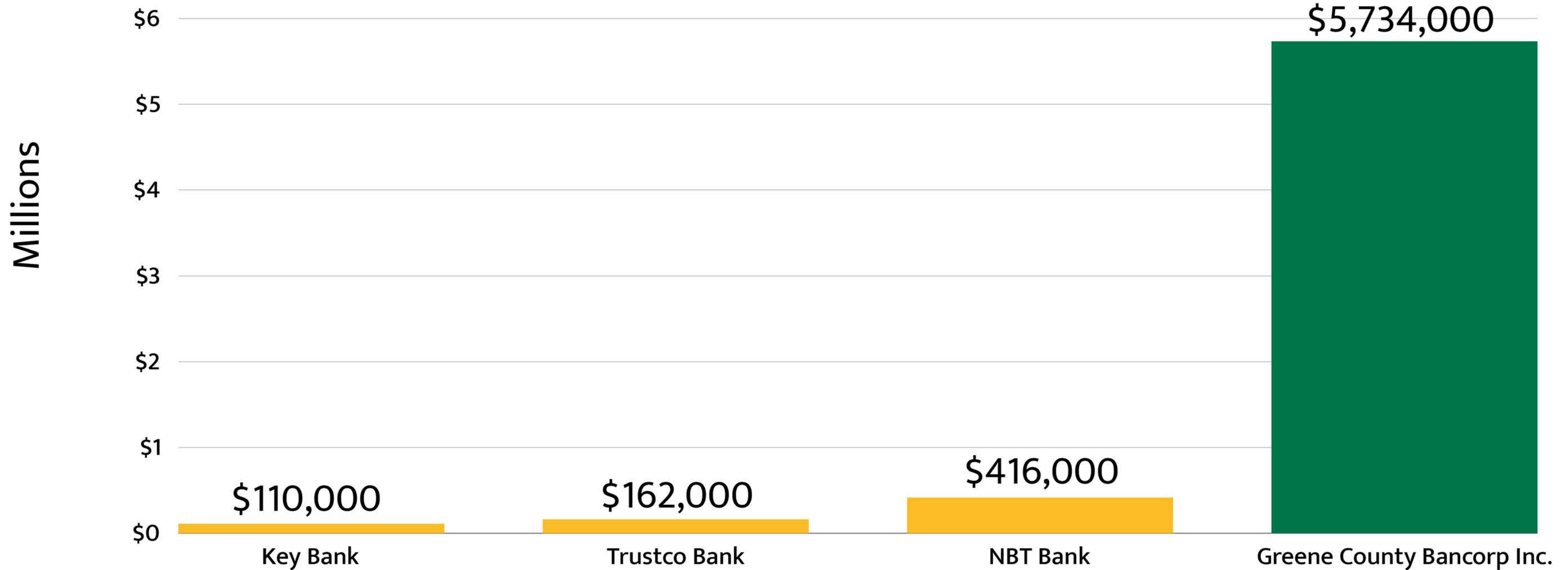
Investment of \$100,000 at 1998 IPO to 6/30/2024

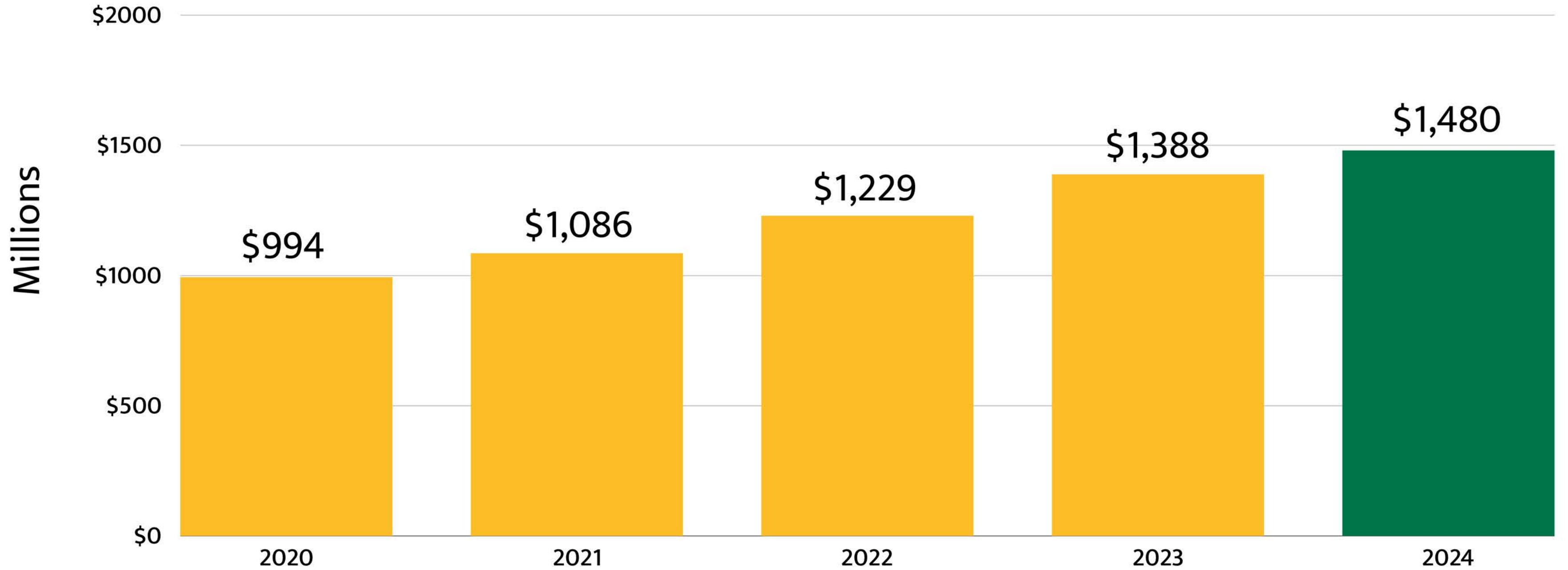

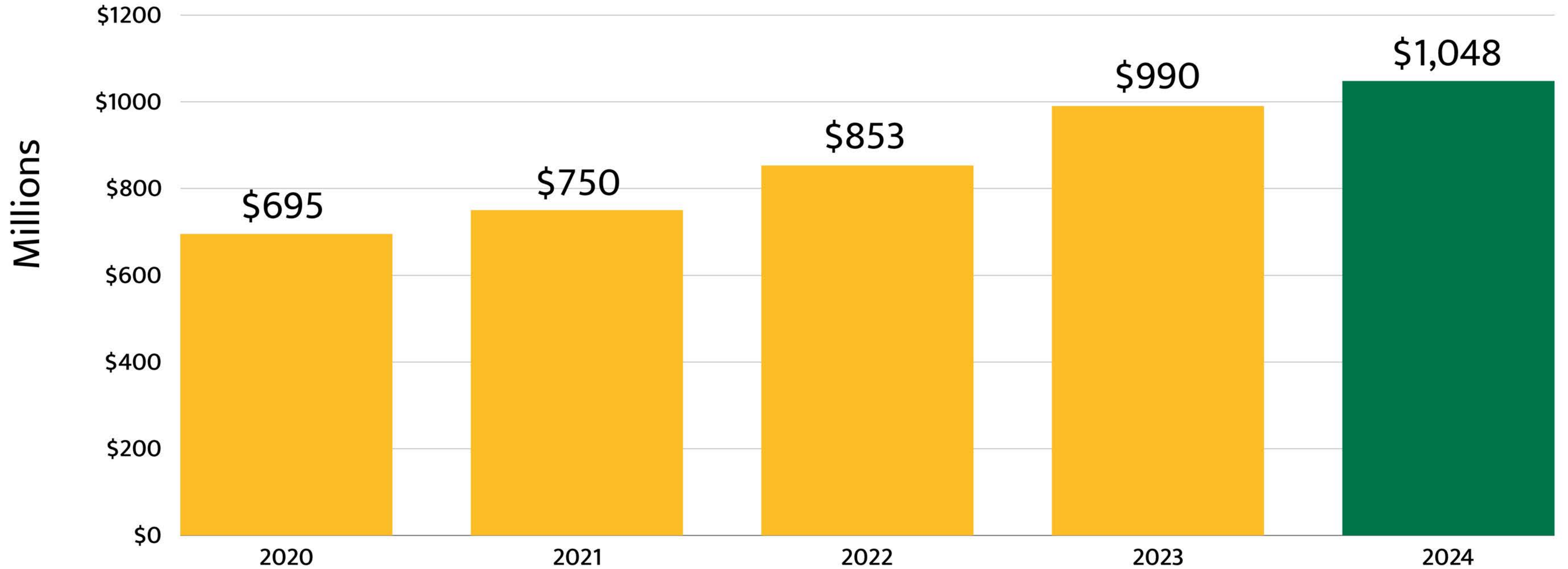
Total Net Loans



June 2020 - June 2024

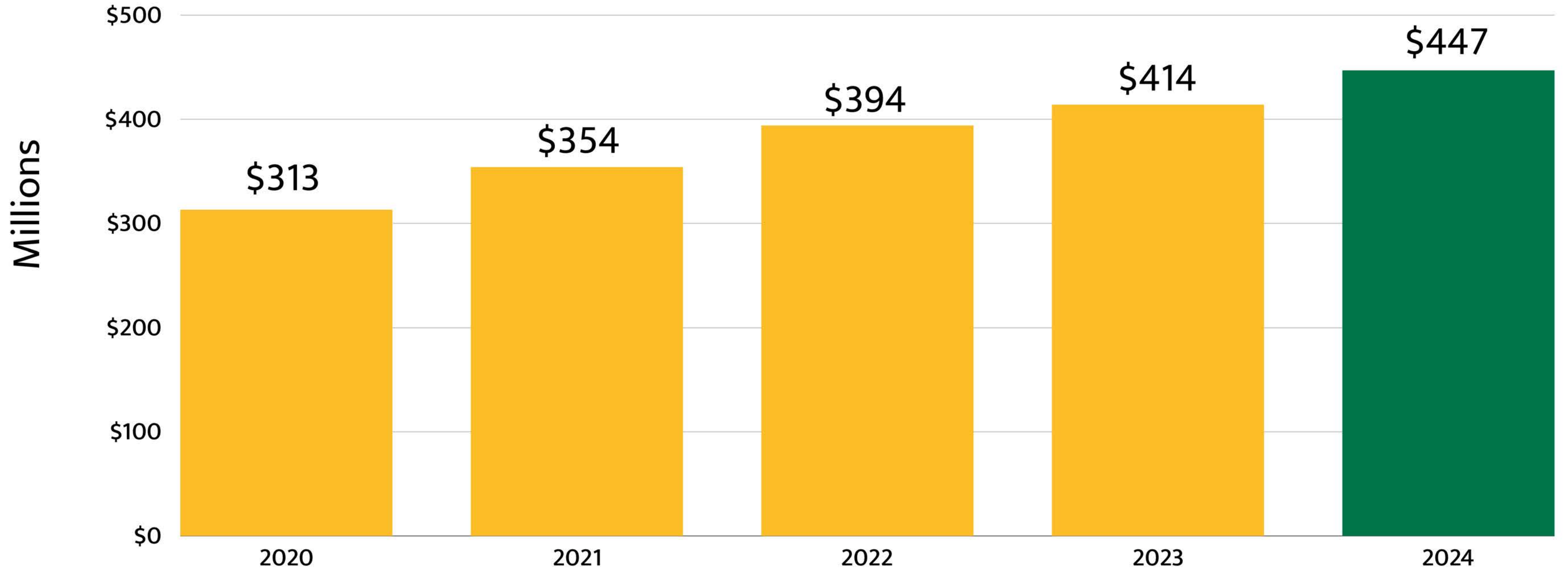
Total Commercial Loans

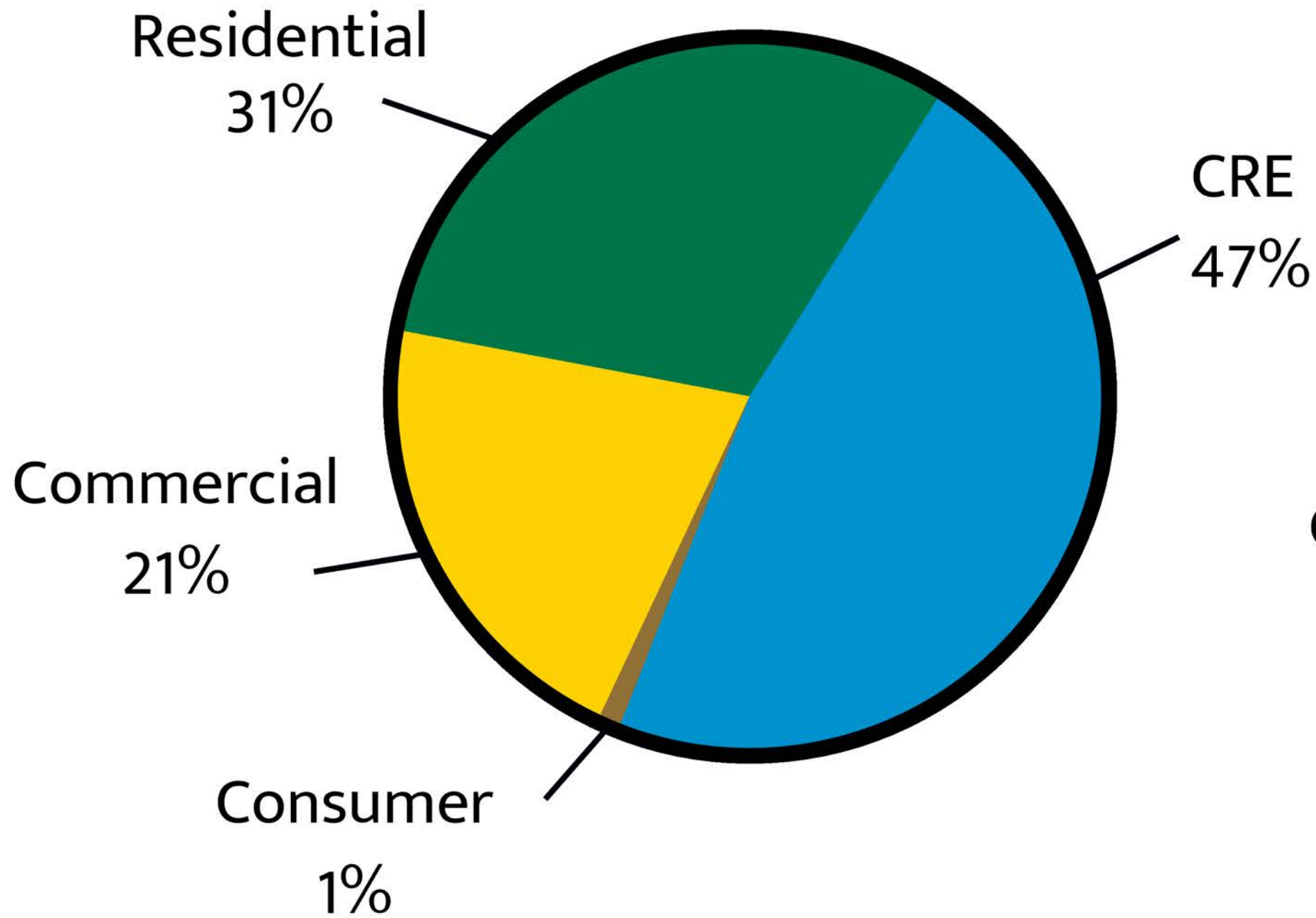
Total Residential Loans



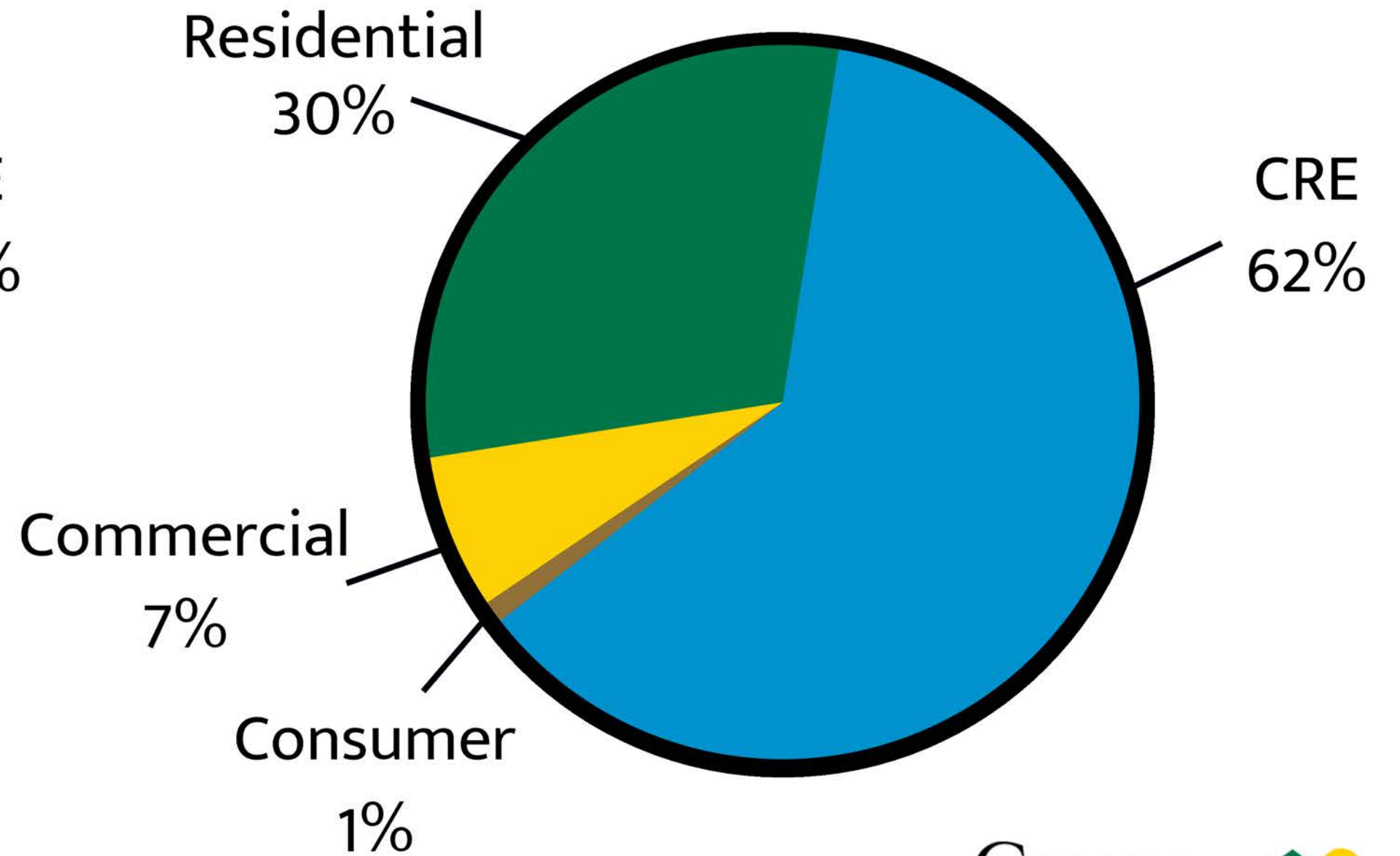

June 30, 2020

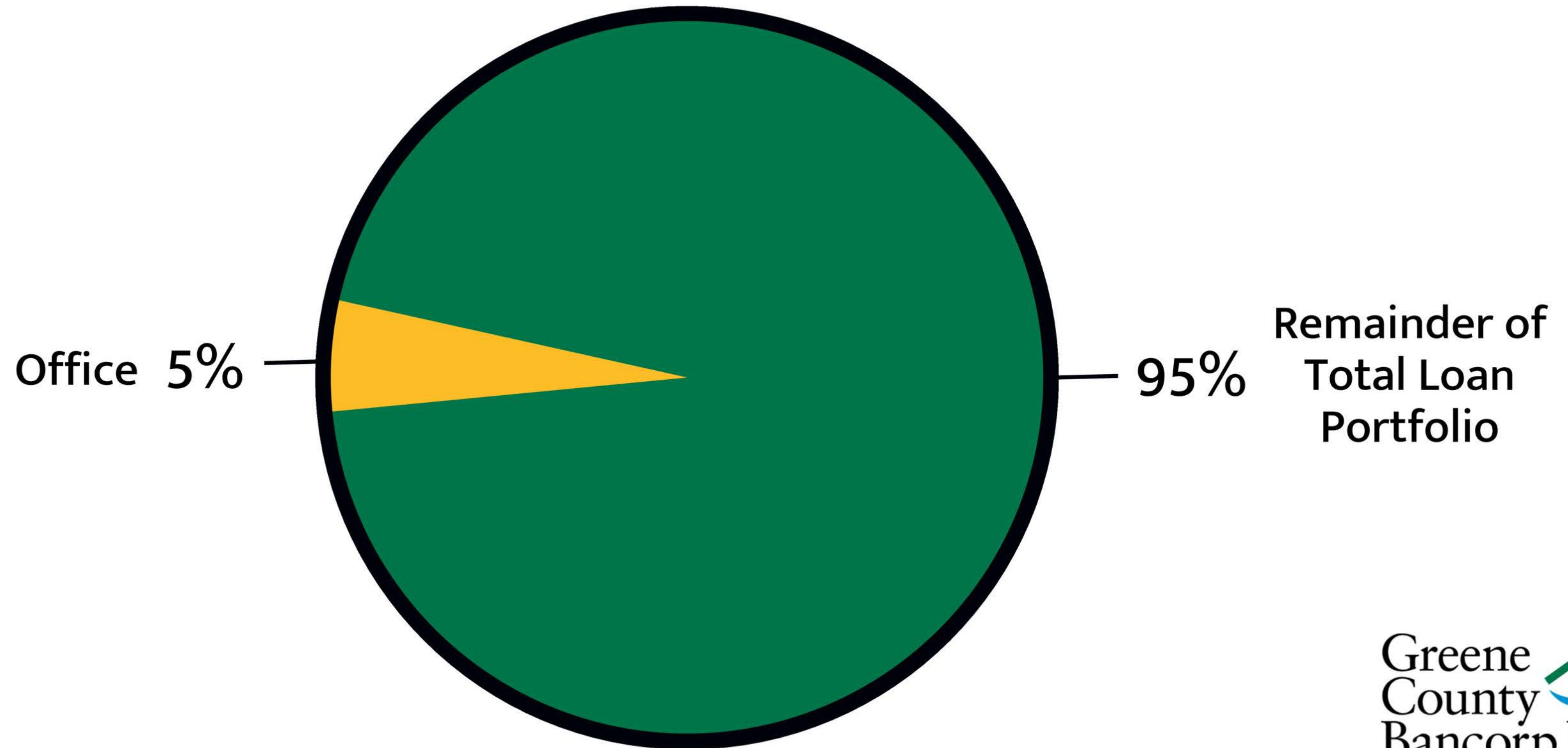

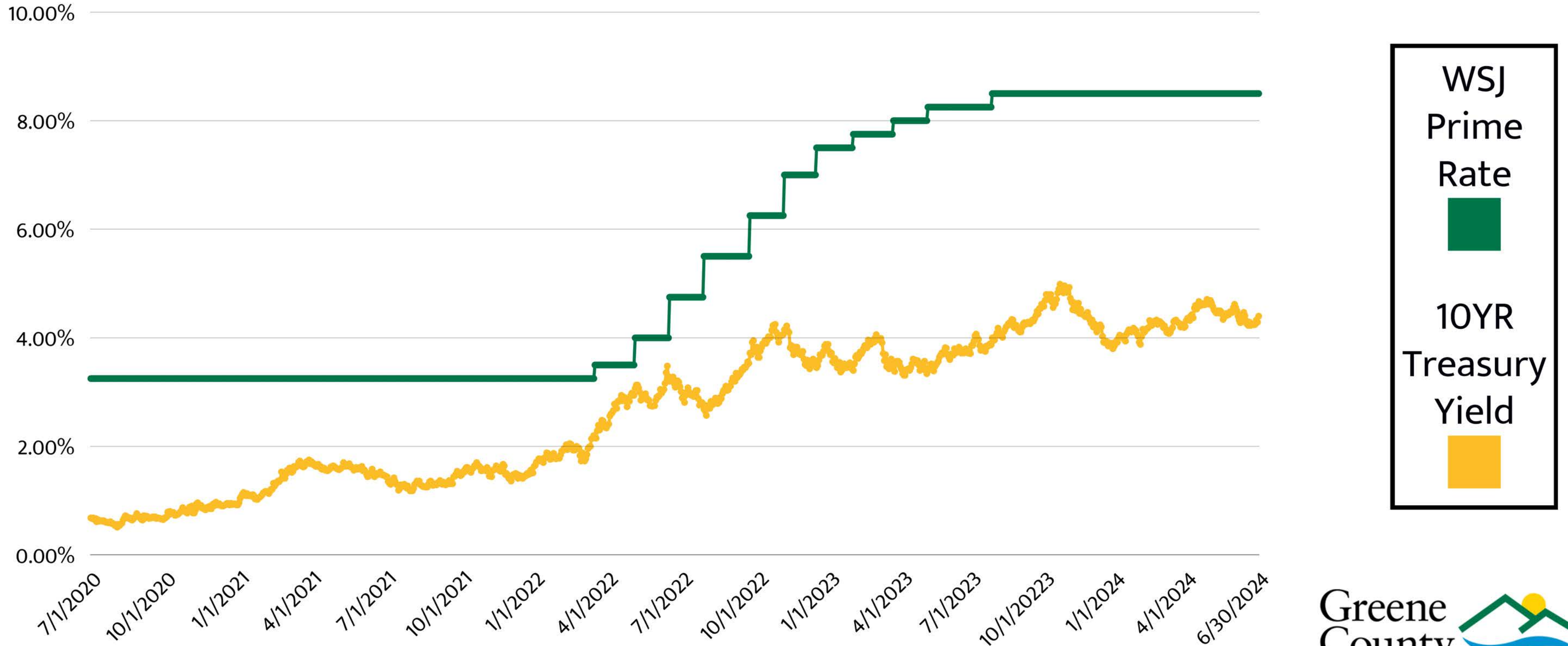


Office vs Total Loan Portfolio

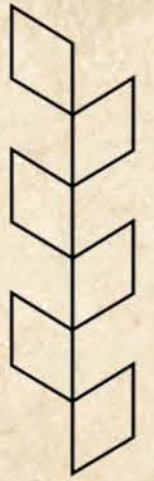
