HBI-PAC, Huntington’s political action committee, makes bipartisan campaign contributions in compliance with local, state, and federal election laws. All HBI-PAC funds are voluntary donations from eligible colleagues.

HBI-PAC supports political candidates and committees that believe in, and encourage, a thriving business environment in which Huntington can strengthen our communities, serve our customers, and support our colleagues and shareholders.

The company’s political action committees are overseen by a PAC board of directors – a steering committee comprised of colleagues representing various regions and business segments across the company – are administered by Government Relations department staff, and are managed in compliance with applicable local, state and federal laws, as well as Huntington’s mission, vision and values. HBI-PAC contributions are publicly available at www.fec.gov (Committee ID C00165589) and on the websites of respective state election authorities.

No corporate funds are contributed to HBI-PAC, and Huntington does not use corporate funds, either directly or indirectly, for election-related contributions to political candidates, political parties, or candidate committees, including super PACs or independent expenditure committees.
