Notes to Condensed Consolidated Financial Statements September 30, 2024 (unaudited)

(1) Basis of Presentation

VodafoneZiggo Group B.V. (VodafoneZiggo) provides fixed, mobile and integrated communication and entertainment services to consumers and businesses in the Netherlands. In these notes, the terms "we," "our," "our company" and "us" may refer, as the context requires, to VodafoneZiggo or collectively to VodafoneZiggo and its subsidiaries.

VodafoneZiggo is a wholly-owned subsidiary of VodafoneZiggo Group Holding B.V. (VodafoneZiggo Group Holding). VodafoneZiggo Group Holding is a 50:50 joint venture (the VodafoneZiggo JV) between Vodafone Group Plc (Vodafone) and Liberty Global Ltd. (Liberty Global) (each a "Shareholder").

Our unaudited condensed consolidated financial statements have been prepared in accordance with accounting principles generally accepted in the United States (GAAP) and do not include all of the information required by GAAP for complete financial statements. In the opinion of management, these financial statements reflect all adjustments (consisting of normal recurring adjustments) necessary for a fair presentation of the results of operations for the interim periods presented. The results of operations for any interim period are not necessarily indicative of results for the full year. These unaudited condensed consolidated financial statements should be read in conjunction with our GAAP 2023 consolidated financial statements and notes thereto included in our 2023 annual report.

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Estimates and assumptions are used in accounting for, among other things, the valuation of allowances for uncollectible accounts, certain components of revenue, programming and copyright expenses, deferred income taxes and related valuation allowances, loss contingencies, fair value measurements, impairment assessments, capitalization of internal costs associated with construction and installation activities and the development of internal-use software and useful lives of long-lived assets. Actual results could differ from those estimates.

Our functional currency is the euro (€). Unless otherwise indicated, convenience translations into euros are calculated as of September 30, 2024.

Certain prior period amounts have been reclassified to conform to the current period presentation.

These unaudited condensed consolidated financial statements reflect our consideration of the accounting and disclosure implications of subsequent events through November 11, 2024, the date of issuance.

(2) Recent Accounting Pronouncements

ASU 2023-09

In December 2023, the Financial Accounting Standards Board (the **FASB**) issued Accounting Standards Update (**ASU**) No. 2023-09, *Improvements to Income Tax Disclosures* (**ASU 2023-09**), which is intended to enhance the transparency of income tax matters within financial statements, providing stakeholders with a clearer understanding of tax positions and their associated risks and uncertainties. ASU 2023-09 requires public business entities to disclose, on an annual basis, specific categories in the rate reconciliation and provide additional information for reconciling items that meet a specific quantitative threshold. There is a further requirement that public business entities will need to disclose a tabular reconciliation, using both percentages and reporting currency amounts. ASU 2023-09 is effective for fiscal years beginning after December 15, 2024. We are currently evaluating the impact of ASU 2023-09 on our consolidated financial statements and disclosures.

(3) Revenue Recognition and Related Costs

Contract Balances

The timing of our recognition of revenue may differ from the timing of invoicing our customers. We record a trade receivable when we have transferred goods or services to a customer but have not yet received payment. Our trade receivables are reported net of an allowance for doubtful accounts. Such allowance aggregated &29.0 million and &26.6 million at September 30, 2024 and December 31, 2023, respectively.

Notes to Condensed Consolidated Financial Statements — (Continued) September 30, 2024 (unaudited)

If we transfer goods or services to a customer but do not have an unconditional right to payment, we record a contract asset. Contract assets typically arise from the delivery of a handset that is paid for over the duration of the contract period or the uniform recognition of introductory promotional discounts over the contract period. Our contract assets were €240.1 million and €234.1 million as of September 30, 2024 and December 31, 2023, respectively, and are reported net of an allowance for doubtful accounts. Such allowance aggregated €5.6 million and €5.4 million at September 30, 2024 and December 31, 2023, respectively. The long-term portions of our contract asset balances are included within other assets, net, on our condensed consolidated balance sheets.

We record deferred revenue when we receive payment prior to transferring goods or services to a customer. We primarily defer revenue for (i) services that are invoiced prior to when they are provided and (ii) installation and other upfront services. Our deferred revenue balances were &215.7 million and &214.5 million as of September 30, 2024 and December 31, 2023, respectively. The long-term portions of our deferred revenue balances are included within other long-term liabilities on our condensed consolidated balance sheets.

Contract Costs

Our aggregate assets associated with incremental costs to obtain and fulfill our contracts were \in 81.7 million and \in 76.3 million at September 30, 2024 and December 31, 2023, respectively. The current and long-term portions of our assets related to contract costs are included within other current assets, net, and other assets, net, respectively, on our condensed consolidated balance sheets. We amortized \in 27.5 million and \in 76.2 million during the three and nine months ended September 30, 2024, respectively, and \in 20.6 million and \in 60.1 million during the three and nine months ended September 30, 2023, respectively, to operating costs and expenses related to these assets.

Unsatisfied Performance Obligations

A large portion of our revenue is derived from customers whose initial contracts have been extended and now have a one month notice period. Revenue from customers who are subject to initial contracts is recognized over the term of such contracts, which is generally 12-24 months for our residential contracts and one to five years for our business-to-business (**B2B**) service contracts.

(4) <u>Derivative Instruments</u>

In general, we enter into derivative instruments to protect against (i) increases in the interest rates on our variable-rate debt and (ii) foreign currency movements with respect to borrowings that are denominated in a currency other than our functional currency. In this regard, we have entered into various derivative instruments to manage interest rate exposure and foreign currency exposure with respect to the United States (U.S.) dollar (\$).

In all cases, the adjustments take into account offsetting liability or asset positions. The changes in the credit risk valuation adjustments associated with our cross-currency and interest rate derivative contracts resulted in net gains (losses) of €3.4 million and (€8.7 million) during the three months ended September 30, 2024 and 2023, respectively, and (€9.7 million) and €9.5 million during the nine months ended September 30, 2024 and 2023, respectively. These amounts are included in realized and unrealized gains (losses) on derivative instruments, net, in our condensed consolidated statements of operations. Counterparty Credit Risk

We are exposed to the risk that the counterparties to our derivative instruments will default on their obligations to us. We manage these credit risks through the evaluation and monitoring of the creditworthiness of, and concentration of risk with, the respective counterparties. In this regard, credit risk associated with our derivative instruments is spread across a relatively broad counterparty base of banks and financial institutions, however notwithstanding, given the size of our derivative portfolio, the default of certain counterparties could have a significant impact on our consolidated statements of operations. Collateral is generally not posted by either party under our derivative instruments. At September 30, 2024, our exposure to counterparty credit risk included derivative assets with an aggregate fair value of €475.4 million.

Details of our Derivative Instruments

Cross-currency Derivative Contracts

We generally match the denomination of our borrowings with the functional currency of the supporting operations or, when it is more cost effective, we provide for an economic hedge against foreign currency exchange rate movements by using derivative instruments to synthetically convert unmatched debt into the applicable underlying currency. At September 30, 2024, substantially all of our debt was either directly or synthetically matched to our functional currency. The following table sets forth the total notional amounts and the related weighted average remaining contractual life of our cross-currency derivative contracts at September 30, 2024:

⁽a) Includes certain derivative instruments that do not involve the exchange of notional amounts at the inception and maturity of the instruments. Accordingly, the only cash flows associated with these derivative instruments are interest-related payments and receipts. At September 30, 2024, the total euro equivalent of the notional amounts due from counterparties of these derivative instruments was €1,432.7 million.

Interest Rate Swap Contracts

As noted above, we enter into interest rate swap contracts to protect against increases in the interest rates on our variablerate debt. Pursuant to these derivative instruments, we typically pay fixed interest rates and receive variable interest rates on

specified notional amounts. At September 30, 2024, the notional amounts due from counterparties was €3,142.4 million and the related weighted average remaining contractual life of our interest rate swap contracts was 4.1 years.

Basis Swaps

Our basis swaps involve the exchange of attributes used to calculate our floating interest rates, including (i) the benchmark rate, (ii) the underlying currency and/or (iii) the borrowing period. We typically enter into these swaps to optimize our interest rate profile based on our current evaluations of yield curves, our risk management policies and other factors. At September 30, 2024, the euro equivalent of the notional amount due from our counterparties was €4,514.9 million and the related weighted average remaining contractual life of our interest basis swap contracts was 0.2 years.

Interest Rate Options

From time to time, we enter into interest rate cap, floor and collar agreements. Purchased interest rate caps and collars lock in a maximum interest rate if variable rates rise, but also allow our company to benefit, to a limited extent in the case of collars, from declines in market rates. Purchased interest rate floors protect us from interest rates falling below a certain level, generally to match a floating rate floor on a debt instrument. At September 30, 2024, we had no interest rate collar agreements, and the total euro equivalent of notional amounts of our interest rate caps and floors were &205.0 million and &2,250.0 million, respectively.

Impact of Derivative Instruments on Borrowing Costs

The impact of the derivative instruments that mitigate our foreign currency and interest rate risk, as described above, was a decrease of 160 basis points to our borrowing costs as of September 30, 2024.

Foreign Currency Forwards and Swaps

We enter into foreign currency forward contracts and foreign currency swap contracts with respect to non-functional currency exposure. At September 30, 2024, the euro equivalent of the notional amount of our foreign currency forward contracts and foreign currency swap contracts was €28.6 million.

(5) Fair Value Measurements

We use the fair value method to account for our derivative instruments. The reported fair values of these derivative instruments as of September 30, 2024 are unlikely to represent the value that will be paid or received upon the ultimate settlement or disposition of these assets and liabilities.

GAAP provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels. Level 1 inputs are quoted market prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date. Level 2 inputs are inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Level 3 inputs are unobservable inputs for the asset or liability. We record transfers of assets or liabilities into or out of Levels 1, 2 or 3 at the beginning of the quarter during which the transfer occurred. During the nine months ended September 30, 2024, no such transfers were made.

We use a Monte Carlo based approach to incorporate a credit risk valuation adjustment in our fair value measurements to estimate the impact of both our own non-performance risk and the non-performance risk of our counterparties. Our credit risk valuation adjustments with respect to our cross-currency and interest rate swap contracts are quantified and further explained in note 4.

Fair value measurements are also used for non-recurring valuations performed in connection with impairment assessments and acquisition accounting. During the nine months ended September 30, 2024 and 2023, we did not perform any significant non-recurring fair value measurements.

For additional information concerning our fair value measurements, see note 6 to the consolidated financial statements included in our 2023 annual report.

Unused borrowing capacity represents the maximum availability under the Credit Facilities at September 30, 2024 without regard to covenant compliance calculations or other conditions precedent to borrowing. At September 30, 2024, based on the most restrictive applicable leverage covenants and leverage-based restricted payment tests, the full €800.0 million of unused borrowing capacity was available to be borrowed and there were no additional restrictions on our ability to make loans or distributions from this availability. Upon completion of the relevant September 30, 2024 compliance reporting requirements and based on the most restrictive applicable leverage covenants and leverage-based restricted payment tests, we expect that the full amount of unused borrowing capacity will continue to be available to be borrowed and that there will be no additional restrictions with respect to loans or distributions from this availability. Our above expectations do not consider any actual or potential changes in our borrowing levels or any amounts loaned or distributed subsequent to September 30, 2024, or the impact of additional amounts that may be available to borrow, loan or distribute under certain defined baskets under the Credit Facilities.

The VodafoneZiggo Fiscal Unity, established on the level of VodafoneZiggo Group Holding, is one taxpayer for Dutch tax purposes. The VodafoneZiggo Fiscal Unity has a tax-sharing agreement in place to formalize our policy of recording income taxes at the level of VodafoneZiggo on a separate return basis. In accordance with this agreement, VodafoneZiggo has assumed the liability of the VodafoneZiggo Fiscal Unity with respect to income taxes payable to the Dutch tax authorities. Accordingly, current income taxes payable or receivable, if any, are presented as current positions with the tax authorities. No settlements will be made between VodafoneZiggo Group Holding, VodafoneZiggo or its subsidiaries related to Dutch tax liabilities or tax attributes.

To stimulate innovation in the Netherlands, Dutch income tax law includes a facility under which profits attributable to qualifying innovative activities are taxed at a reduced tax rate of 9.0% (the **Innovation Box Regime**). We have entered into discussions with the Dutch tax authority regarding the applicability of the Innovation Box Regime to VodafoneZiggo. As the outcome of these discussions is pending, we have not accrued any potential tax benefits.

In December 2021, the Organization for Economic Co-Operation and Development (OECD)/G20 Inclusive Framework on Base Erosion and Profit Shifting (BEPS) released Model Global Anti-Base Erosion (GLoBE) rules under Pillar Two. These rules provide for the taxation of certain large multinational corporations at a minimum rate of 15.0%, calculated on a jurisdictional basis. The Netherlands has enacted legislation to implement many aspects of the Pillar Two rules beginning on January 1, 2024, with certain remaining impacts to be effective from January 1, 2025. We do not currently anticipate that Pillar Two legislation will have a material impact on our consolidated financial statements, but we will continue to monitor future legislation and any additional guidance that is issued.

Related-party Debt

Liberty Global Notes Payable

The Liberty Global Notes Payable comprise (i) a euro-denominated note payable to a subsidiary of Liberty Global with a principal amount of €700.0 million at September 30, 2024 (the **Liberty Global Note Payable I**) and (ii) a euro-denominated note payable to a subsidiary of Liberty Global with a principal amount of €207.9 million at September 30, 2024 (the **Liberty Global Note Payable II**, and, together with the Liberty Global Note Payable I, the **Liberty Global Notes Payable**). The Liberty Global Notes Payable bear interest at a fixed rate of 5.55% and have a final maturity date of December 31, 2030. During the nine months ended September 30, 2024, interest accrued on the Liberty Global Notes Payable was €38.4 million, all of which has been cash settled.

Vodafone Notes Payable

The Vodafone Notes Payable comprise (i) a euro-denominated note payable to a subsidiary of Vodafone with a principal amount of €700.0 million at September 30, 2024 (the **Vodafone Note Payable I**) and (ii) a euro-denominated note payable to a subsidiary of Vodafone with a principal amount of €207.9 million at September 30, 2024 (the **Vodafone Note Payable II**, and, together with the Vodafone Note Payable I, the **Vodafone Notes Payable**). The Vodafone Notes Payable bear interest at a fixed rate of 5.55% and have a final maturity date of December 31, 2030. During the nine months ended September 30, 2024, interest accrued on the Vodafone Notes Payable was €38.4 million, all of which has been cash settled.

Shareholders Agreement

In connection with the JV Transaction, on December 31, 2016, Liberty Global and Vodafone entered into a shareholders agreement (the **Shareholders Agreement**) with VodafoneZiggo Group Holding in respect of the VodafoneZiggo JV. Each Shareholder holds 50% of the issued share capital of VodafoneZiggo Group Holding. The Shareholders Agreement contains customary provisions for the governance of a 50:50 joint venture that result in Liberty Global and Vodafone having joint control over decision making with respect to the VodafoneZiggo JV. Furthermore, each Shareholder has the right to initiate an initial public offering (**IPO**) of the VodafoneZiggo JV with the opportunity for the other Shareholder to sell shares in the IPO on a pro rata basis. Starting January 1, 2021, each Shareholder has the right to initiate a sale of all of its interest in the VodafoneZiggo JV to a third party and, under certain circumstances, initiate a sale of the entire VodafoneZiggo JV, subject, in each case, to a right of first offer in favor of the other Shareholder.

The Shareholders Agreement also provides (i) for a dividend policy that requires the VodafoneZiggo JV to distribute all unrestricted cash to the Shareholders as soon as reasonably practicable following each three month period (subject to the VodafoneZiggo JV maintaining a minimum amount of cash and complying with the terms of financing arrangements of its subsidiaries) and (ii) that the VodafoneZiggo JV will be managed with a leverage ratio of between 4.5 and 5.0 times Covenant EBITDA (as calculated pursuant to existing financing arrangements of its subsidiaries) with the VodafoneZiggo JV undertaking periodic recapitalizations and/or refinancings accordingly.

Programming commitments consist of obligations associated with certain of our programming contracts that are enforceable and legally binding on us as we have agreed to pay minimum fees without regard to (i) the actual number of subscribers to the programming services or (ii) whether we terminate service to a portion of our subscribers or dispose of a portion of our distribution systems. Programming commitments do not include increases in future periods associated with contractual inflation or other price adjustments that are not fixed. Accordingly, the amounts reflected in the above table with respect to these contracts are significantly less than the amounts we expect to pay in these periods under these contracts. Historically, payments to programming vendors have represented a significant portion of our operating costs, and we expect that this will continue to be the case in future periods. In this regard, during the nine months ended September 30, 2024 and 2023, the programming and copyright costs incurred by our operations aggregated €226.4 million and €212.6 million, respectively.

Purchase commitments include unconditional and legally binding obligations related to the purchase of CPE, other equipment and mobile handsets.

Other commitments primarily include sponsorships and certain fixed minimum contractual commitments.

In addition to the commitments set forth in the table above, we have commitments under (i) derivative instruments and (ii) multi-employer defined benefit plans, pursuant to which we expect to make payments in future periods. For information regarding our derivative instruments, including the net cash paid or received in connection with these instruments, see note 4.

Guarantees and Other Credit Enhancements

In the ordinary course of business, we may provide (i) indemnifications to our lenders, our vendors and certain other parties and (ii) performance and/or financial guarantees to local municipalities, our customers and vendors. Historically, these arrangements have not resulted in our company making any material payments and we do not believe that they will result in material payments in the future.

Regulations and Contingencies

VAT. Our application of VAT with respect to certain mobile revenue generating activities has been challenged by the Dutch tax authorities in two different court cases. The Dutch tax authorities challenged the multipurpose character of certain mobile subscriptions that we entered into during 2017 and 2018. The initial verdict in both cases was in favor of the tax authorities. We appealed these decisions to the higher court and the hearing of both cases was held in February 2023. In May 2023, the higher court ruled in favor of the Dutch tax authorities in both cases. Accordingly, in 2023, we recorded a provision for litigation of €33.4 million and related interest expense. As of September 30, 2024, the accrual for related interest expense totaled €3.8 million. We have filed an appeal in cassation, the timing and the final outcome of which remains uncertain.

Other regulatory matters. Broadband internet, video distribution, fixed-line telephony, mobile and content businesses are subject to significant regulation and supervision by various regulatory bodies in the Netherlands, including Dutch and European Union (E.U.) authorities. Adverse regulatory developments could subject our business to a number of risks. Regulation, including conditions imposed on us by competition or other authorities as a requirement to close acquisitions or dispositions, could limit growth, revenue and the number and types of services offered and could lead to increased operating costs and property and equipment additions. In addition, regulation may restrict our operations and subject them to further competitive pressure, including pricing restrictions, interconnect and other access obligations, and restrictions or controls on content, including content provided by third parties. Failure to comply with current or future regulation could expose our business to various penalties.

In addition to the foregoing items, we have contingent liabilities related to matters arising in the ordinary course of business, including (i) legal proceedings, (ii) issues involving VAT and wage, property, withholding and other tax issues and (iii) disputes over interconnection, programming, copyright and channel carriage fees. While we generally expect that the amounts required to satisfy these contingencies will not materially differ from any estimated amounts we have accrued, no assurance can be given that the resolution of one or more of these contingencies will not result in a material impact on our results of operations, cash flows or financial position in any given period. Due, in general, to the complexity of the issues involved and, in certain cases, the lack of a clear basis for predicting outcomes, we cannot provide a meaningful range of potential losses or cash outflows that might result from any unfavorable outcomes.

(13) Subsequent Event

In October 2024, we issued €575.0 million principal amount of 6.125% senior notes (the **2032 Euro Senior Notes**) at an issue price of par, in accordance with our Green Finance Framework (**Green Finance Framework**), part of the Sustainable Finance Framework, and maturing on November 15, 2032. Our Green Finance Framework enables us to issue green and sustainable financing and aligns our Corporate Social Responsibility strategy with our capital structure.

The proceeds of the 2032 Euro Senior Notes will be used to refinance the 2027 Senior Notes, which may occur over a period of time, by way of open market purchases, privately negotiated transactions, tender offers, repayments, redemptions or otherwise.

Subject to certain exceptions as specified in the indenture, the 2032 Euro Senior Notes are non-callable prior to November 15, 2027. At any time prior to November 15, 2027, we may redeem some or all of the 2032 Euro Senior Notes by paying a "make-whole" premium, which is the present value of all remaining scheduled interest payments through November 15, 2027, using the discount rate (as specified in the indenture) as of the redemption date plus 50 basis points.

On or after November 15, 2027, we may redeem some or all of the 2032 Euro Senior Notes at the following redemption prices (expressed as a percentage of the principal amount) plus accrued and unpaid interest and additional amounts (as specified in the indenture), if any, up to but excluding the redemption date (subject to the rights of holders of record on the relevant record date to receive interest due on the relevant interest payment date), as set forth below:

Overview

General

VodafoneZiggo provides fixed, mobile and integrated communication and entertainment services to consumers and businesses in the Netherlands.

Operations

At September 30, 2024, we owned and operated networks that passed 7,558,100 homes and served 7,885,800 revenue generating units (**RGUs**), consisting of 3,426,100 video subscribers, 3,137,600 broadband internet subscribers and 1,322,100 fixed-line telephony subscribers. In addition, at September 30, 2024, we served 5,580,500 mobile subscribers, which includes 5,298,400 postpaid subscribers.

Competition and Other External Factors

The Dutch market for mobile and fixed services is highly competitive and rapidly evolving. Within our mobile operations we continue to experience pressure on pricing, characterized by aggressive promotion campaigns, heavy marketing spend and increasing or unlimited data bundles. Furthermore, there is growing competition from MVNOs that focus on certain niche segments such as no frill, youth or ethnic markets. Within our fixed operations we experience increased competition, primarily due to competitors' additional promotional activities related to fiber rollout. This significant competition, together with the macroeconomic factors, has adversely impacted our revenue, RGU and average monthly subscription revenue per average fixed RGU or mobile subscriber, as applicable (ARPU). For additional information regarding the revenue impact of changes in the RGUs and ARPU, see *Material Changes in Results of Operations* below.

Our revenue is earned in the Netherlands and is subject to applicable VAT. Any increases in these taxes could have an adverse impact on our ability to maintain or increase our revenue to the extent that we are unable to pass such tax increases onto our customers.

We are subject to inflationary pressures with respect to labor, programming and other costs. While we attempt to increase our revenue to offset increases in costs, there is no assurance that we will be able to do so. Therefore, costs could rise faster than associated revenue, thereby resulting in a negative impact on our operating results, cash flows and liquidity. The economic environment in the Netherlands is a function of government, economic, fiscal and monetary policies and various other factors beyond our control that could lead to inflation. We are unable to predict the extent that price levels might be impacted in future periods by the current state of the economy in the Netherlands.

Material Changes in Results of Operations

This section provides an analysis of our results of operations for the three and nine months ended September 30, 2024 and 2023.

Adjusted EBITDA

Adjusted EBITDA, which is a non-GAAP measure, is the primary measure used by our management to evaluate the operating performance of our business. It is also a key factor that is used by our management and our Supervisory Board to evaluate the effectiveness of our management for purposes of annual and other incentive compensation plans. As we use the term, "Adjusted EBITDA" is defined as operating income before depreciation and amortization, share-based compensation, provisions and provision releases related to significant litigation and impairment, restructuring and other operating items. Other operating items include (i) gains and losses on the disposition of long-lived assets, (ii) third-party costs directly associated with successful and unsuccessful acquisitions and dispositions, including legal, advisory and due diligence fees, as applicable, and (iii) other acquisition-related items, such as gains and losses on the settlement of contingent consideration. Our management believes Adjusted EBITDA is a meaningful measure because it represents a transparent view of our recurring operating performance that is unaffected by our capital structure and allows management to (a) readily view operating trends, (b) perform analytical comparisons and benchmarking between entities and (c) identify strategies to improve operating performance. We believe our Adjusted EBITDA measure is useful to investors because it is one of the bases for comparing our performance with the performance of other companies in the same or similar industries, although our measure may not be directly comparable to similar measures used by other companies. Investors should view Adjusted EBITDA as a supplement to, and not a substitute for, GAAP measures of performance included in our condensed consolidated statements of operations.

Revenue

We earn revenue from (i) subscribers to our consumer broadband communications and mobile services and (ii) B2B services, interconnect fees, channel carriage fees, installation fees and late fees. Consistent with the presentation of our revenue categories in note 12 to our condensed consolidated financial statements, we use the term "subscription revenue" in the following discussion to refer to amounts received from subscribers for ongoing services. In the below tables, mobile subscription revenue excludes the related interconnect revenue.

Variances in the subscription revenue from our customers are a function of (i) changes in the number of fixed-line customers or mobile subscribers outstanding during the period and (ii) changes in ARPU. Changes in ARPU can be attributable to (a) changes in prices, (b) changes in bundling or promotional discounts, (c) changes in the tier of services selected, (d)

variances in subscriber usage patterns and (e) the overall mix of fixed and mobile products during the period. In the following discussion, we provide the net impact of the above factors on the ARPU that is derived from our video, broadband internet, fixed-line telephony and mobile products.

- (a) The decreases in consumer fixed subscription revenue related to a change in the average number of RGUs are mainly attributable to decreases in the average number of internet, fixed-line telephony and video RGUs.
- (b) The increases in consumer fixed subscription revenue related to a change in ARPU are primarily attributable to the net effect of (i) the annual price indexations implemented on July 1, 2023 and July 1, 2024, (ii) decreases in ARPU from changes in RGU mix, (iii) lower add-on usage and (iv) lower telephony usage.

Programming and other direct costs of services

Programming and other direct costs of services include programming and copyright costs, mobile access and interconnect costs, costs of mobile handsets and other devices and other direct costs related to our operations. Programming and copyright costs represent a significant portion of our operating costs and are subject to increase in future periods due to various factors,

including (i) higher costs associated with the expansion of our digital video content, including rights associated with ancillary product offerings and rights that provide for the broadcast of live sporting events, and (ii) rate increases.

Our programming and other direct costs of services increased by €13.7 million or 6.7% during the three months ended September 30, 2024 and were relatively flat for the nine months ended September 30, 2024, as compared to the corresponding periods in 2023. These increases include the following factors:

- Increases in programming costs of €14.6 million or 20.7% and €13.8 million or 6.5%, respectively, primarily attributable to the net effect of (i) higher costs for premium sport content, (ii) higher production costs, (iii) higher copyright costs and (iv) lower linear programming costs;
- Decreases in interconnect costs of €4.7 million or 10.9% and €10.4 million or 9.7%, respectively, primarily attributable to (i) lower mobile termination rates and (ii) lower freephone usage; and
- An increase (decrease) in equipment costs of €3.9 million or 4.4% and (€2.9 million) or (1.0%), respectively, primarily attributable to the net effect of (i) decreases in cost of other equipment and (ii) increases in sales volumes of mobile handsets and accessories.

Other operating expenses

Other operating expenses include network operations, customer operations, customer care and other costs related to our operations.

Our other operating expenses decreased by ≤ 11.7 million or 8.9% and ≤ 37.2 million or 9.1%, during the three and nine months ended September 30, 2024, respectively, as compared to the corresponding periods in 2023. These decreases include the following factors:

- Decreases in business service costs of €11.2 million or 38.3% and €39.8 million or 41.3%, respectively, primarily due to (i) lower energy prices and (ii) lower consultancy costs; and
- Increases in core network and information technology-related costs of €1.8 million or 13.4% and €2.7 million or 7.2%, respectively, primarily driven by the net effect of (i) higher network maintenance costs and (ii) decreases in framework agreement recharges.

SG&A expenses

SG&A expenses include human resources, information technology, general services, management, finance, legal, external sales and marketing costs, share-based compensation and other general expenses.

Our SG&A expenses decreased by \in 4.2 million or 2.4% and \in 1.2 million or 0.2%, during the three and nine months ended September 30, 2024, respectively, as compared to the corresponding periods in 2023. These decreases include the following factors:

- Increases in sales and marketing costs of €1.8 million or 3.3% and €8.6 million or 5.4%, respectively, primarily due to

 (i) higher third-party sales commissions and (ii) increases in expenditures for marketing campaigns;
- Decreases in business service costs of €0.5 million or 2.9% and €6.8 million or 10.6%, respectively, primarily due to (i) lower consulting costs and (ii) lower energy prices;
- Decreases in other indirect costs of €6.1 million or 52.8% and €5.6 million or 22.9%, respectively, primarily due to (i) lower costs as a result of office closures and (ii) lower legal costs; and
- Increases in core network and information technology-related costs of €1.8 million or 13.9% and €4.6 million or 12.7%, respectively, primarily due to the net effect of (i) higher framework agreement recharges, (ii) higher information technology-related project spend and (iii) lower consulting costs.

Charges for JV Services

We recorded charges for JV Services of \in 45.1 million and \in 141.1 million during the three and nine months ended September 30, 2024, respectively, as compared to \in 51.5 million and \in 155.5 million during the three and nine months ended September 30, 2023, respectively. For additional information regarding charges for JV Services, see note 10 to our condensed consolidated financial statements.

Depreciation and amortization expense

Our depreciation and amortization expense increased by €4.7 million or 1.2% and €12.2 million or 1.1% during the three and nine months ended September 30, 2024, respectively, as compared to the corresponding periods in 2023. These increases are primarily driven by higher average balances of depreciable tangible assets.

Impairment, restructuring and other operating items, net

We recognized impairment, restructuring and other operating items, net, of $\in 0.2$ million and $\in 4.5$ million during the three and nine months ended September 30, 2024, respectively, including (i) restructuring charges of $\in 2.2$ million and $\in 7.8$ million, respectively, (ii) gains from the disposal of assets of $\in 2.5$ million and $\in 4.6$ million, respectively, and (iii) impairment charges related to tangible assets of $\in 0.4$ million and $\in 1.3$ million, respectively.

We recognized impairment, restructuring and other operating items, net, of $\[\in \]$ 5.3 million and $\[\in \]$ 41.3 million during the three and nine months ended September 30, 2023, respectively, including (i) the recognition of a provision for litigation of $\[\in \]$ 33.4 million during the second quarter of 2023 associated with a VAT dispute with the Dutch tax authorities relating to 2017-2018 periods, (ii) restructuring charges of $\[\in \]$ 3.6 million and $\[\in \]$ 6.6 million, respectively, (iii) impairment charges related to long lived assets of $\[\in \]$ 2.1 million and $\[\in \]$ 2.6 million, respectively, and (iv) gains from the disposition of assets of $\[\in \]$ 0.4 million and $\[\in \]$ 1.3 million, respectively.

Interest expense–third-party

Our third-party interest expense increased by €2.9 million or 1.8% and €32.8 million or 7.1% during the three and nine months ended September 30, 2024, respectively, as compared to the corresponding periods in 2023, primarily due to higher interest rates on variable-rate debt.

For additional information regarding our third-party debt, see note 7 to our condensed consolidated financial statements.

It is possible that the interest rates on (i) any new borrowings could be higher than the current interest rates on our existing indebtedness and (ii) our variable-rate indebtedness could increase in future periods. As further discussed in note 4 to our condensed consolidated financial statements, we use derivative instruments to manage our interest rate risks.

Interest expense-related-party

We recorded related-party interest expense of $\[mathebox{\ensuremath{$\epsilon$}}25.8$ million and $\[mathebox{\ensuremath{$\epsilon$}}76.7$ million during the three and nine months ended September 30, 2024, respectively, as compared to $\[mathebox{\ensuremath{$\epsilon$}}25.7$ million and $\[mathebox{\ensuremath{$\epsilon$}}76.4$ million during the three and nine months ended September 30, 2023, respectively. For additional information regarding our related-party debt, see note 10 to our condensed consolidated financial statements.

Realized and unrealized gains (losses) on derivative instruments, net

Our realized and unrealized gains or losses on derivative instruments include (i) unrealized changes in the fair values of our derivative instruments that are non-cash in nature until such time as the derivative contracts are fully or partially settled and (ii) realized gains upon the full or partial settlement of the derivative contracts.

Income tax benefit

We recognized an income tax benefit of $\in 30.7$ million and $\in 36.7$ million during the three and nine months ended September 30, 2024, respectively, and $\in 17.1$ million and $\in 49.1$ million during the three and nine months ended September 30, 2023, respectively.

The income tax benefit for the three and nine months ended September 30, 2024 differs from the expected income tax benefit of \in 39.3 million and \in 47.8 million, respectively, and the income tax benefit for the three and nine months ended September 30, 2023, differs from the expected income tax benefit of \in 19.5 million and \in 79.2 million, respectively, primarily due to the negative impact of increases in the valuation allowance associated with interest deduction limitations.

Net loss

During the three months ended September 30, 2024 and 2023, we reported net loss of $\in 121.7$ million and $\in 58.3$ million, respectively, including (i) operating income of $\in 85.4$ million and $\in 81.2$ million, respectively, (ii) net non-operating expense of $\in 237.8$ million and $\in 156.6$ million, respectively, and (iii) income tax benefit of $\in 30.7$ million and $\in 17.1$ million, respectively.

During the nine months ended September 30, 2024 and 2023, we reported net loss of \in 148.7 million and \in 257.7 million, respectively, including (i) operating income of \in 269.0 million and \in 165.6 million, respectively, (ii) net non-operating expense of \in 454.4 million and \in 472.4 million, respectively, and (iii) income tax benefit of \in 36.7 million and \in 49.1 million, respectively.

Gains or losses associated with (i) changes in the fair values of derivative instruments, (ii) movements in foreign currency exchange rates and (iii) the disposition of assets are subject to a high degree of volatility and, as such, any gains from these sources do not represent a reliable source of income. In the absence of significant gains in the future from these sources or from other non-operating items, our ability to achieve earnings from operations is largely dependent on our ability to increase our operating income to a level that more than offsets the aggregate amount of our (a) interest expense, (b) other non-operating expenses and (c) income tax expense.

Subject to the limitations included in our various debt instruments, we expect to maintain our debt at current levels relative to our Covenant EBITDA. As a result, we expect that we will continue to report significant levels of interest expense for the foreseeable future. For information concerning our expectations with respect to trends that may affect our operating results in future periods, see the discussion under *Overview* above.

Material Changes in Financial Condition

Sources and Uses of Cash

As a holding company, VodafoneZiggo's primary assets are its investments in consolidated subsidiaries. As further described in note 7 to our condensed consolidated financial statements, the terms of the instruments governing the indebtedness of certain of these subsidiaries may restrict our ability to access the assets of these subsidiaries. The ability to access the liquidity of our subsidiaries may also be limited by tax and legal considerations and other factors. At September 30, 2024, we had cash and cash equivalents of Θ 4.7 million, of which Θ 5.3 million was held by our subsidiaries.

Liquidity of VodafoneZiggo

Our sources of liquidity at the parent level include, subject to the restrictions noted above, proceeds in the form of distributions or loans from our subsidiaries. It is the intention of the Shareholders of the VodafoneZiggo JV, that VodafoneZiggo will be a self-funding company capable of financing its activities on a stand-alone basis without recourse to either Shareholder. No assurance can be given that funding from our subsidiaries or external sources would be available on favorable terms, or at all.

VodafoneZiggo's corporate liquidity requirements include corporate general and administrative expenses and fees associated with the JV Service Agreements. From time to time, VodafoneZiggo may also require cash in connection with (i) the repayment of its related-party debt and interest, (ii) the funding of dividends or distributions by VodafoneZiggo Group Holding pursuant to the Shareholders Agreement, (iii) the satisfaction of contingent liabilities, (iv) acquisitions and other investment opportunities, including the acquisition of spectrum licenses, and (v) income tax payments.

Liquidity of our Subsidiaries

In addition to cash, the primary sources of liquidity of our operating subsidiaries are cash provided by operations and, in the case of Ziggo B.V. and certain of its subsidiaries, any borrowing availability under the revolving facilities.

The liquidity of our operating subsidiaries generally is used to fund (i) property and equipment additions and (ii) debt service requirements, as well as to settle certain obligations that are not included on our September 30, 2024 condensed consolidated balance sheet. In this regard, we have significant commitments related to (a) programming contracts, (b) the JV Service Agreements and (c) purchase obligations associated with mobile handsets, CPE and other equipment. These obligations are expected to represent a significant liquidity requirement, the majority of which is due over the next 12 to 36 months. For additional information regarding our commitments, see note 11 to our condensed consolidated financial statements.

From time to time, our operating subsidiaries may also require liquidity in connection with (i) acquisitions and other investment opportunities, including the acquisition of spectrum licenses, (ii) distributions or loans to VodafoneZiggo (and ultimately to the Shareholders of the VodafoneZiggo JV) or (iii) the satisfaction of contingencies. No assurance can be given that any external funding would be available to our subsidiaries on favorable terms, or at all.

For additional information regarding our consolidated cash flows, see the discussion under Condensed Consolidated Statements of Cash Flows below.

Capitalization

All of our third-party debt and finance lease obligations at September 30, 2024 have been borrowed or incurred by our subsidiaries. At September 30, 2024, the outstanding principal amount of our third-party debt and finance lease obligations aggregated \in 11.1 billion, including \in 1.1 billion that is classified as current on our condensed consolidated balance sheet and \in 4.9 billion that is not due until 2030 or thereafter.

As further discussed in note 4 to our condensed consolidated financial statements, we use derivative instruments to mitigate foreign currency and interest rate risk associated with our debt instruments.

Our ability to service or refinance our debt and to maintain compliance with the leverage covenants in our credit agreements and indentures is dependent primarily on our ability to maintain or increase our Covenant EBITDA and to achieve adequate returns on our property and equipment additions. Pursuant to the Shareholders Agreement, we expect to maintain a leverage ratio between 4.5 and 5.0 times Covenant EBITDA. In addition, our ability to obtain additional debt financing is limited by the leverage covenants contained in the various debt instruments of our subsidiaries. In this regard, if our Covenant EBITDA were to decline, we could be required to repay or limit our borrowings under the Credit Facility in order to maintain compliance with applicable covenants. No assurance can be given that we would have sufficient sources of liquidity, or that any external funding would be available on favorable terms, or at all, to fund any such required repayment. We do not anticipate any instances of non-compliance with respect to any of our subsidiaries' debt covenants that would have a material adverse impact on our liquidity during the next 12 months.

Notwithstanding our negative working capital position at September 30, 2024, we believe that we have sufficient resources to repay or refinance the current portion of our debt and finance lease obligations and to fund our foreseeable liquidity requirements during the next 12 months. However, as our maturing debt grows in later years, we anticipate that we will seek to refinance or otherwise extend our debt maturities. No assurance can be given that we will be able to complete these refinancing transactions or otherwise extend our debt maturities. In this regard, it is not possible to predict how political and economic conditions, sovereign debt concerns or any adverse regulatory developments could impact the credit markets we access and, accordingly, our future liquidity and financial position. Our ability to access debt financing at favorable terms, or at all, could be adversely impacted by (i) the financial failure of any of our counterparties, which could (a) reduce amounts available under committed credit facilities and (b) adversely impact our ability to access cash deposited with any failed financial institution and (ii) tightening of the credit markets. In addition, sustained or increased competition, particularly in combination with adverse economic or regulatory developments, could have an unfavorable impact on our cash flows and liquidity.

Operating Activities. The decrease in net cash provided by our operating activities is primarily attributable to the net effect of (i) a decrease in cash provided due to higher payments of interest, (ii) an increase in cash provided due to higher net cash receipts related to derivative instruments, (iii) an increase in cash provided due to lower payments for corporate income taxes and (iv) an increase in cash provided by our Adjusted EBITDA and related working capital items. Adjusted EBITDA is a non-GAAP measure, which investors should view as a supplement to, and not a substitute for, GAAP measures of performance included in our condensed consolidated statements of operations.

Investing Activities. The increase in net cash used by our investing activities is primarily attributable to (i) an increase in cash used of \in 57.6 million for the acquisition of spectrum licenses, (ii) a decrease in cash used of \in 25.5 million associated with lower cash paid for liabilities related to capital expenditures and (iii) a decrease in cash used of \in 23.0 million associated with lower property and equipment additions.

The capital expenditures that we report in our condensed consolidated statements of cash flows do not include amounts that our company has financed under vendor financing or finance lease arrangements. Instead, these amounts are reflected as non-cash additions to our property and equipment when the underlying assets are delivered, and as repayments of debt when the principal is repaid. In this discussion, we refer to (i) our capital expenditures as reported in our condensed consolidated statements of cash flows, which exclude amounts financed under vendor financing or finance lease arrangements, and (ii) our total property and equipment additions, which include our capital expenditures on an accrual basis and amounts financed under capital-related vendor financing or finance lease arrangements. For additional information concerning capital additions financed under vendor financing and finance lease arrangements, see notes 6 and 8, respectively, to our condensed consolidated financial statements.

The net decrease in our property and equipment additions during the nine months ended September 30, 2024, as compared to the corresponding period in 2023, is primarily attributable to the net effect of (i) a decrease in expenditures to support new customer products and operational efficiency initiatives, (ii) a decrease in baseline expenditures, (iii) an increase in spending on

information technology-related transformation projects, (iv) a decrease in CPE additions and (v) an increase in expenditures for capacity and coverage expansion in both mobile and fixed networks.

We paid €57.6 million in July 2024 related to the acquisition of spectrum licenses during the 3.5Ghz spectrum license auction that was held in June 2024.

Financing Activities. The decrease in net cash used by our financing activities is primarily attributable to the net effect of (i) a decrease in net cash used of €14.3 million due to higher net borrowings of third-party debt and (ii) an increase in cash used of €3.0 million due to higher payments of financing costs.
