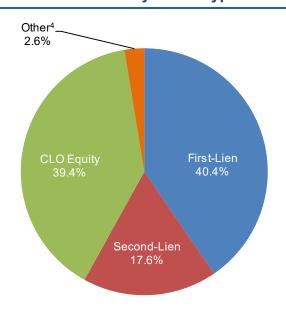


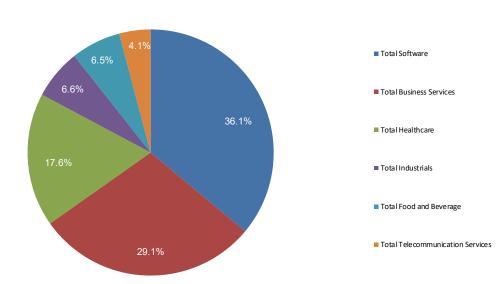

Corporate Loan Portfolio by Industry^{1,6}





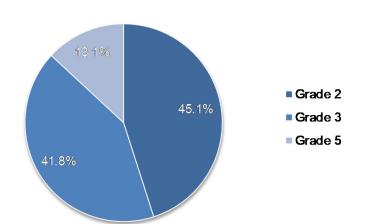

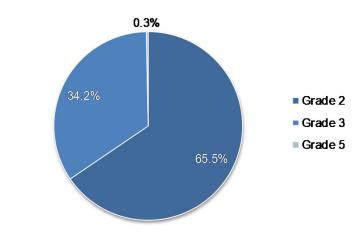


Portfolio Grading
