The Integrated Report provides an overview of the Group's business activities and outlines its medium-to-long-term strategies. This information provides the basis for our series of discussions with our stakeholders, intended to enhance our corporate value.

In accordance with these objectives, we have prepared our Integrated Report for the fiscal year ended March 31, 2024 by referring to the IFRS Foundation's "The International Integrated Reporting Framework" and the Ministry of Economy, Trade and Industry's "Value Co-Creation Guidance".

The value creation process for realizing the vision of the Fuji Oil Group Constitution was reviewed this year, and the report was edited with an emphasis on clearly expressing the vision and process for medium-term growth based on this process, and on organizing the entire report with a structure centered on the value creation process.

We will use this report to deepen mutual understanding with stakeholders through dialogue and create a virtuous cycle that will promote management improvement.
