## **Notice Concerning Issuance of First INPEX Green Bond**

**TOKYO, JAPAN** - <u>INPEX CORPORATION</u> (INPEX) announced today that the issuance conditions of the first INPEX Green Bond (hereinafter "the green bond") have been determined as outlined below.

This follows INPEX's <u>announcement on September 13, 2021</u> that it will issue its inaugural green bonds to promote the company's initiatives toward the realization of a net zero carbon society by 2050 and to diversify its financing sources, wherein the use of funds are restricted to businesses and operations that help improve the state of the environment, such as the development of renewable energies.

INPEX, as outlined in its "Business Development Strategy - Towards a Net Zero Carbon Society by 2050," has set goals to achieve its own net zero carbon emissions by 2050 and will proactively engage in energy structure reforms towards the realization of a net zero carbon society.
