PERANGKAAAN PERDAGANGAN LUAR NEGERI MALAYSIA OKTOBER 2024

Perdagangan Malaysia berkembang kepada RM244.3 bilion pada Oktober 2024, didorong oleh peningkatan eksport (+1.6%) dan import (+2.6%)

PUTRAJAYA, 19 NOVEMBER 2024 – Prestasi perdagangan Malaysia menunjukkan pertumbuhan berterusan pada Oktober 2024, dengan peningkatan dalam eksport dan import yang mencerminkan trajektori ekonomi yang positif. Jumlah dagangan meningkat 2.1 peratus daripada RM239.3 bilion pada tahun sebelumnya kepada RM244.3 bilion. Prestasi ini didorong oleh pertumbuhan eksport 1.6 peratus atau RM2.0 bilion dan import 2.6 peratus, mencapai RM116.1 bilion. Namun begitu, imbalan dagangan turun 7.6 peratus kepada RM12.0 bilion pada Oktober 2024 seperti yang dilaporkan hari ini dalam **BULETIN PERANGKAAAN PERDAGANGAN LUAR NEGERI MALAYSIA, OKTOBER 2024**. Buletin ini juga membentangkan prestasi produk untuk eksport dan import serta rakan dagangannya.

Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin menjelaskan prestasi eksport Malaysia meningkat selaras dengan kenaikan eksport domestik pada Oktober 2024. Eksport domestik (77.6% daripada jumlah eksport) meningkat 3.1 peratus berbanding Oktober 2023, dengan nilai RM99.4 bilion, manakala eksport semula (22.4% daripada jumlah eksport) jatuh 3.5 peratus kepada

RM28.7 bilion. Di samping itu, import bernilai RM116.1 bilion, meningkat 2.6 peratus. Lebihan dagangan menurun 7.6 peratus kepada RM12.0 bilion, lebihan bulan ke-54 berturut-turut sejak Mei 2020. Berbanding September 2024, eksport, import dan jumlah dagangan masing-masing mencatatkan peningkatan 3.7 peratus, 4.8 peratus dan 4.2 peratus. Sebaliknya, imbalan dagangan mencatatkan penurunan 6.2 peratus.

Melihat dari sudut kumpulan barangan, 129 daripada 259 kumpulan eksport dan 151 daripada 259 kumpulan import menunjukkan peningkatan berbanding bulan yang sama pada tahun sebelumnya.

Ketua Perangkawan Malaysia turut menekankan bahawa eksport yang lebih tinggi disumbangkan terutamanya ke Amerika Syarikat (+RM4.6 bilion), diikuti oleh Taiwan (+RM1.9 bilion), Singapura (+RM998.3 juta), India (+RM921.5 juta), Turkiye (+RM757.7 juta), Kesatuan Eropah (+RM748.0 juta) dan Indonesia (+RM618.3 juta). Selain itu, peningkatan import pula disumbangkan terutamanya dari Amerika Syarikat (+RM3.1 bilion), diikuti oleh Taiwan (+RM2.1 bilion), Mexico (+RM1.1 bilion), Angola (+RM707.4 juta), Kesatuan Eropah (+RM399.2 juta), Kuwait (+RM274.7 juta) dan Afrika Selatan (+RM244.3 juta).

Mengulas lebih lanjut mengenai eksport, kenaikan ini sejajar dengan peningkatan dalam barangan elektrik & elektronik (+RM3.8 bilion); barangan perkilangan lain (+RM991.1 juta); minyak kelapa sawit & keluaran pertanian berasaskan kelapa sawit (+RM785.3 juta); produk getah (+RM610.8 juta); makanan diproses (+RM554.0 juta); jentera, kelengkapan & peralatan (+RM549.4 juta); dan barangan perkilangan berasaskan kelapa sawit (+RM487.2 juta). Selain itu, peningkatan import dicatatkan bagi barangan elektrik & elektronik (+RM9.0 bilion); jentera, kelengkapan & peralatan (+RM2.0 bilion);

pertanian lain (+RM830.6 juta); petroleum mentah (+RM547.1 juta); gas asli cecair (+RM523.7 juta); dan minyak sayuran lain (+RM249.5 juta).

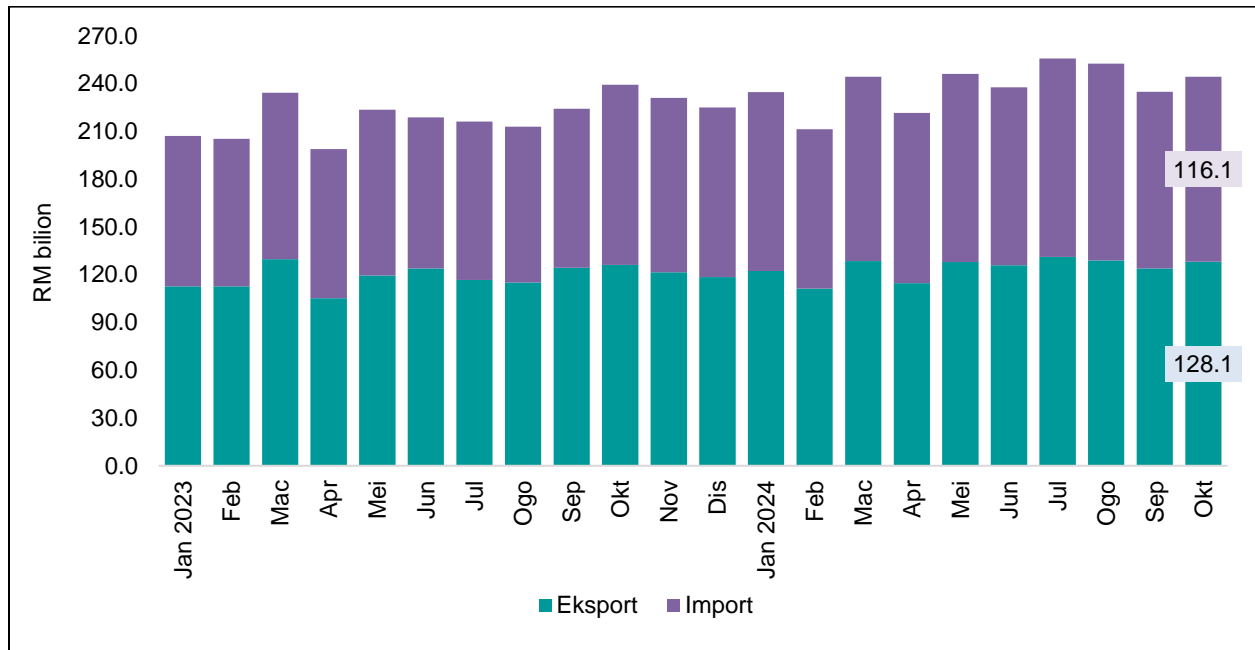
Selanjutnya, Ketua Perangkawan Malaysia juga memaklumkan pertambahan import mengikut Penggunaan Akhir adalah seiring dengan permintaan yang lebih tinggi bagi barangan perantaraan dan barangan penggunaan. Import barangan perantaraan (53.9% daripada jumlah import), bernilai RM62.6 bilion, mencatatkan peningkatan 12.3 peratus atau RM6.8 bilion berbanding Oktober 2023. Barangan penggunaan (8.3% daripada jumlah import), meningkat 3.0 peratus atau RM276.4 juta mencapai RM9.6 bilion. Sebaliknya, barangan modal (10.6% daripada jumlah import) dengan nilai RM12.4 bilion, menurun 2.7 peratus atau RM344.2 juta

Jumlah dagangan, eksport dan import bagi tempoh Januari hingga Oktober 2024 mencatatkan peningkatan. Jumlah dagangan meningkat 9.3 peratus, daripada RM2.2 trilion kepada RM2.4 trilion, sejajar dengan kenaikan eksport (+4.8%) serta import (+14.6%). Sebaliknya, lebih dagangan berkurang 46.3 peratus berbanding tempoh yang sama pada 2023 mencatatkan nilai RM102.8 bilion.

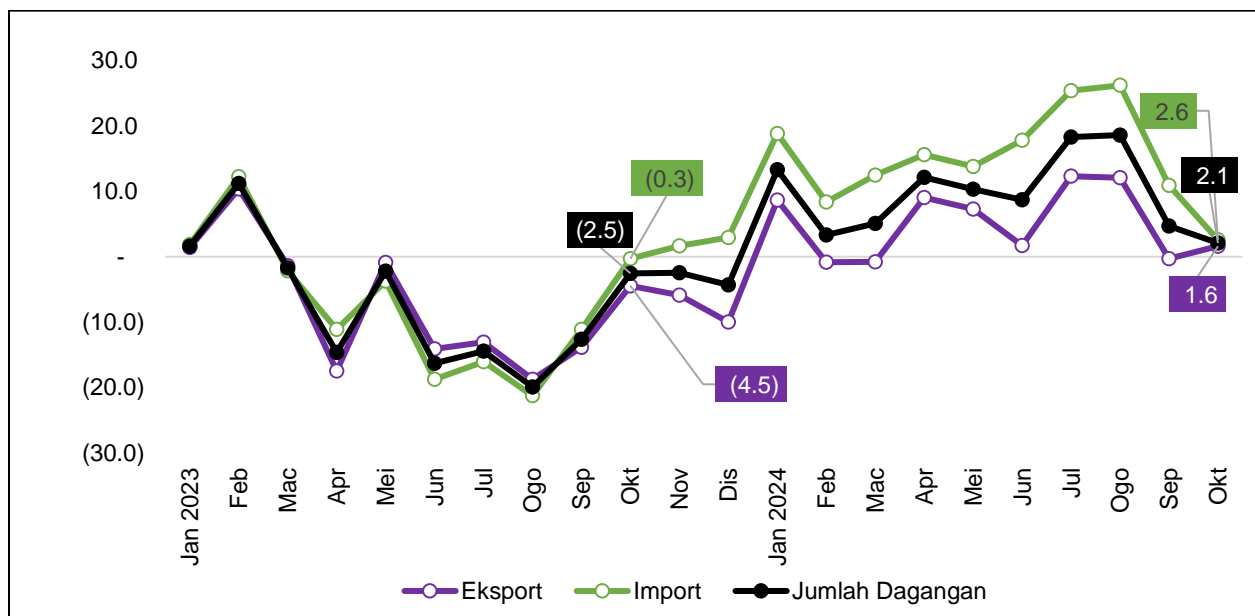

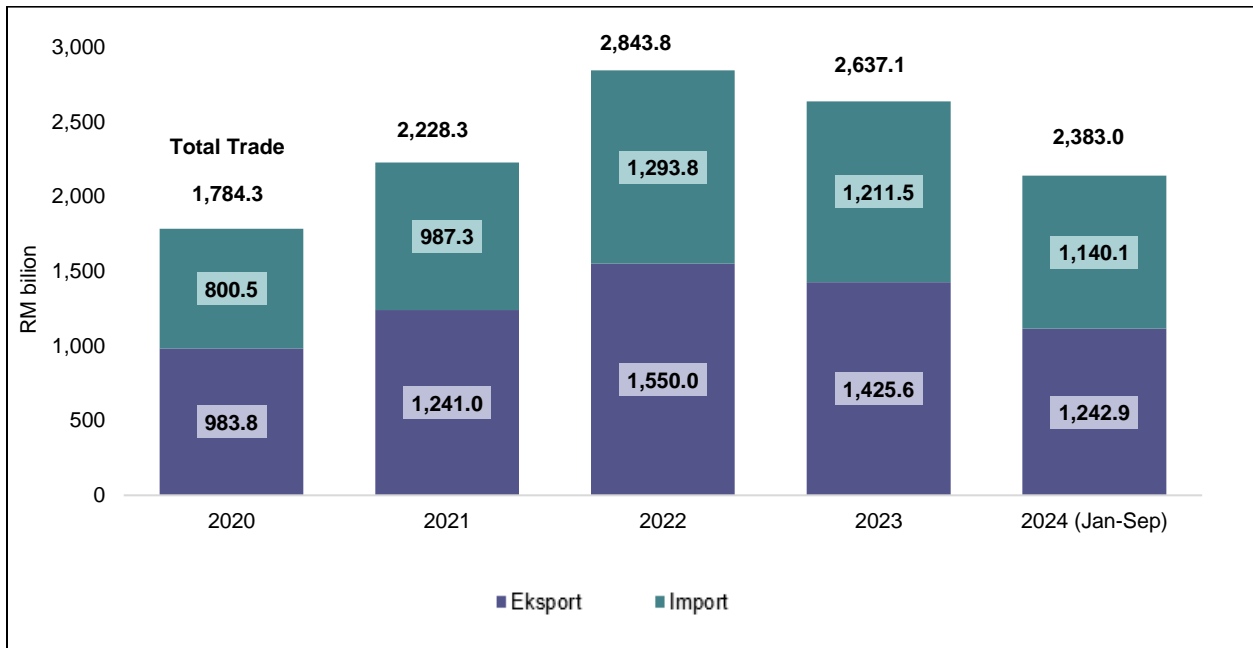
Carta 1: Perangkaan Perdagangan Luar Negeri, Jan 2023 – Okt 2024 (Nilai)



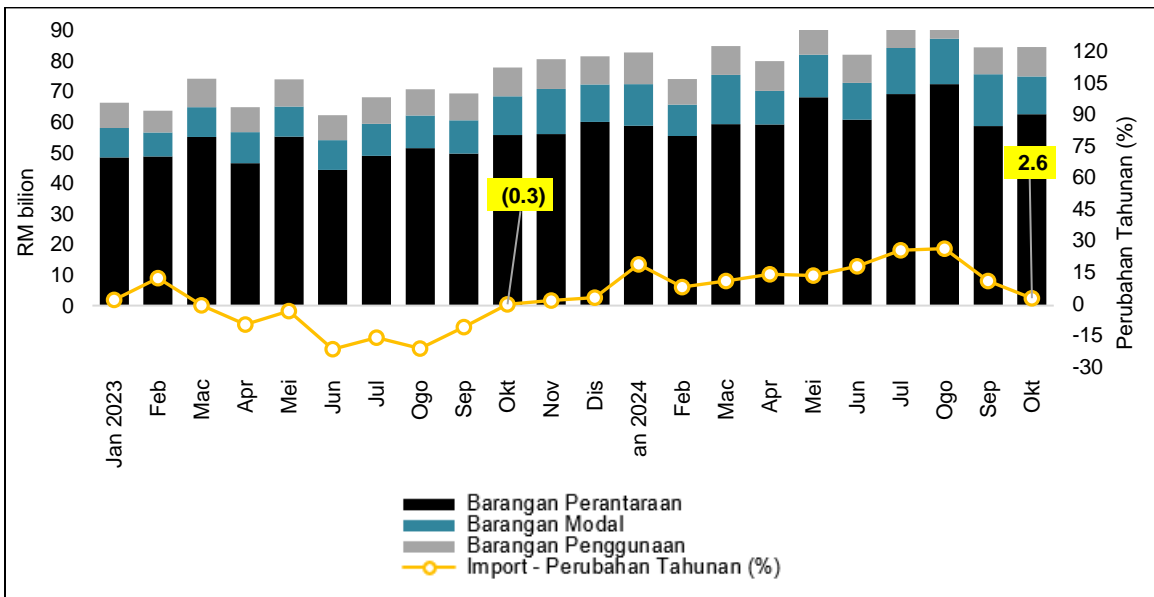
Carta 2: Perangkaan Perdagangan Luar Negeri, Jan 2023 – Okt 2024 (Peratus Perubahan Tahunan)



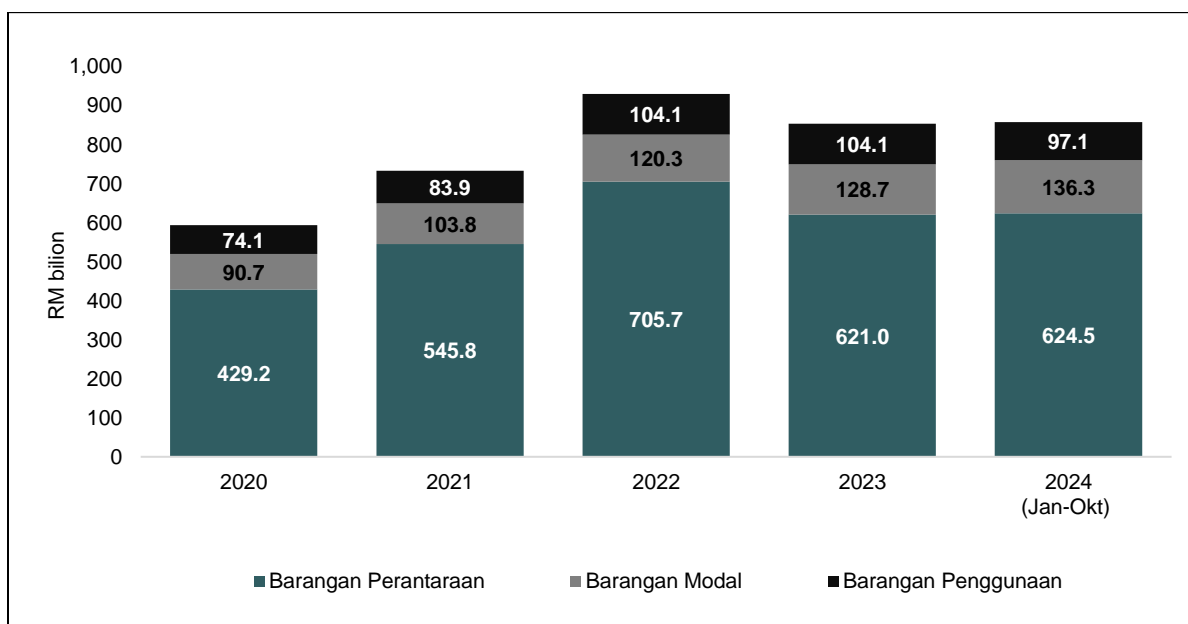
Carta 3: Perangkaan Perdagangan Luar Negeri, 2020 – 2024 (Jan-Okt)

MALAYSIA EXTERNAL TRADE STATISTICS OCTOBER 2024

Malaysia's trade thrived at RM244.3 billion in October 2024, driven by growth in exports (+1.6%) and imports (+2.6%)

PUTRAJAYA, 19 NOVEMBER 2024 – Malaysia's trade performance showed sustained growth in October 2024, with gains in both exports and imports reflecting a positive economic trajectory. Total trade exhibited an increase of 2.1 per cent from RM239.3 billion in the previous year to RM244.3 billion. This performance was driven by growth in exports by 1.6 per cent or RM2.0 billion and imports by 2.6 per cent, reaching RM116.1 billion. On the contrary, trade balance fell by 7.6 per cent to RM12.0 billion in October 2024 as reported today in **MALAYSIA EXTERNAL TRADE STATISTICS BULLETIN, OCTOBER 2024**. This bulletin also presents the performance of export and import products with its trading partners.

Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin highlighted Malaysia's exports increased in line with the rise in domestic exports in October 2024. Domestic exports (77.6% of total exports) was up by 3.1 per cent as compared to October 2023, worth RM99.4 billion while re-exports (22.4% of total exports), down by 3.5 per cent to RM28.7 billion. Moreover, imports worth RM116.1 billion, increased by 2.6 per cent. Trade surplus down by 7.6 per cent to reach RM12.0 billion, 54th consecutive month of surplus since May 2020. Comparing with

September 2024, exports, imports and total trade recorded an increase of 3.7 per cent, 4.8 per cent and 4.2 per cent, respectively. On the contrary, trade balance recorded a decrease of 6.2 per cent.

From the perspective of the commodity group, 129 out of 259 export groups and 151 out of 259 import groups showed an increase as compared to the same month of the previous year along.

Chief Statistician Malaysia further explained higher exports was attributable mainly to the United States (+RM4.6 billion), followed by Taiwan (+RM1.9 billion), Singapore (+RM998.3 million), India (+RM921.5 million), Turkiye (+RM757.7 million), the European Union (+RM748.0 million) and Indonesia (+RM618.3 million). Moreover, higher imports were mainly contributed from the United States (+RM3.1 billion), followed by Taiwan (+RM2.1 billion), Mexico (+RM1.1 billion), Angola (+RM707.4 million), the European Union (+RM399.2 million), Kuwait (+RM274.7 million) and South Africa (+RM244.3 million).

Commenting further on exports, the increase was in line with the rise in electrical & electronic products (+RM3.8 billion); other manufactures (+RM991.1 million); palm oil and palm-based agriculture products (+RM785.3 million); rubber products (+RM610.8 million); processed food (+RM554.0 million); machinery, equipment & parts (+RM549.4 million); and palm oil-based manufactured products (+RM487.2 million). In addition, the increase in imports was logged for electrical & electronic products (+RM9.0 billion); machinery, equipment & parts (+RM2.0 billion); other agriculture (+RM830.6 million); crude petroleum (+RM547.1 million); liquefied natural gas (+RM523.7 million); and other vegetables oil (+RM249.5 million).

Adding to this, the Chief Statistician Malaysia also emphasised the upsurge in imports by End Use which was in accordance with higher demand for intermediate goods and consumption goods. Imports of intermediate goods (53.9% of total imports), valued at RM62.6 billion, registered an increase of 12.3 per cent or RM6.8 billion as compared to October 2023. Consumption goods (8.3% of total imports), grew by 3.0 per cent or RM276.4 million to reach RM9.6 billion. On the contrary, capital goods (10.6% of total imports) with a value of RM12.4 billion, decrease by 2.7 per cent or RM344.2 million.

Total trade, exports and imports for the period of January to October 2024 registered an increase. Total trade grew by 9.3 per cent, from RM2.2 trillion to RM2.4 trillion, in line with the rise in exports (+4.8%) as well as imports (+14.6%). On the contrary, trade surplus decreased by 46.3 per cent as compared to the same period in 2023 to post a value of RM102.8 billion.

The Government of Malaysia has declared National Statistics Day (MyStats Day) on October 20th. MyStats Day theme is "Statistics is the Essence of Life". DOSM commemorates its 75th Diamond Jubilee in 2024.

Chart 1: External Trade Statistics, Jan 2023 – Oct 2024 (Value)

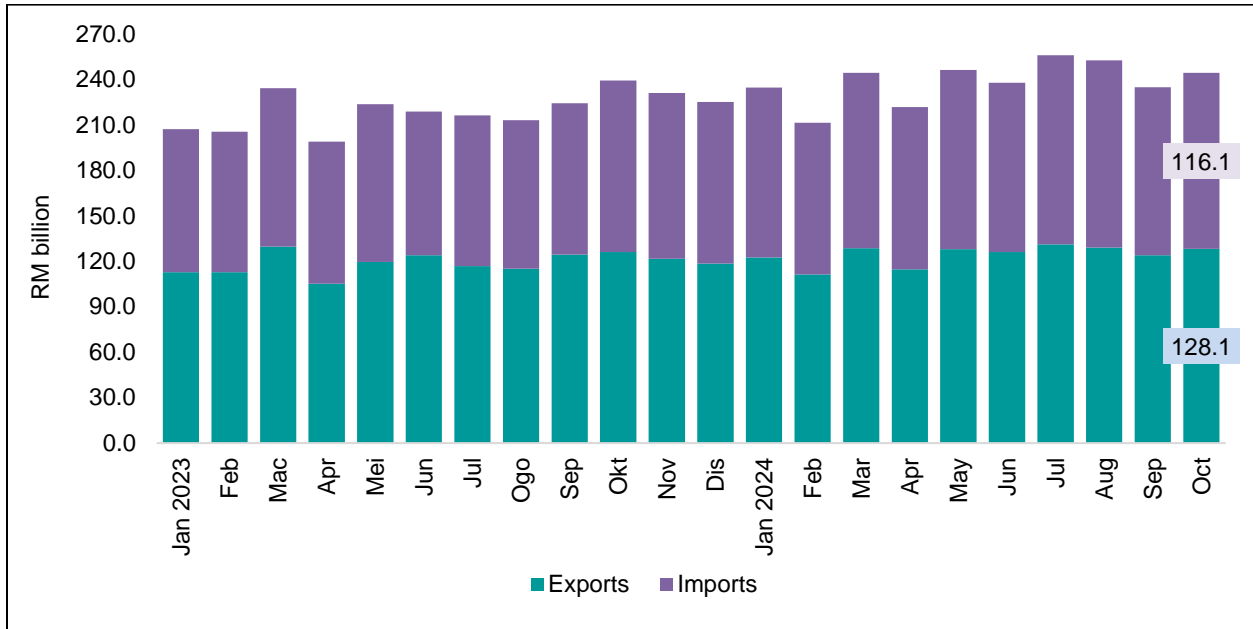


Chart 2: External Trade Statistics, Jan 2023 – Oct 2024 (Annual Percentage Change)

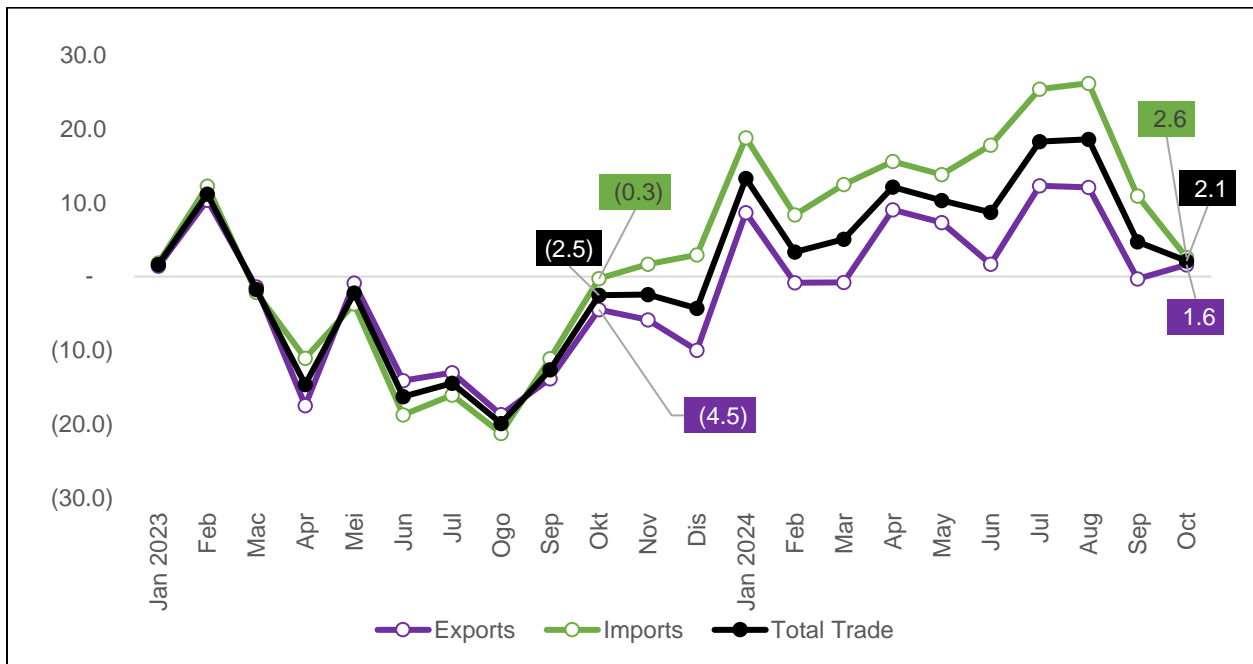


Chart 3: External Trade Statistics, 2020 – 2024 (Jan-Oct)

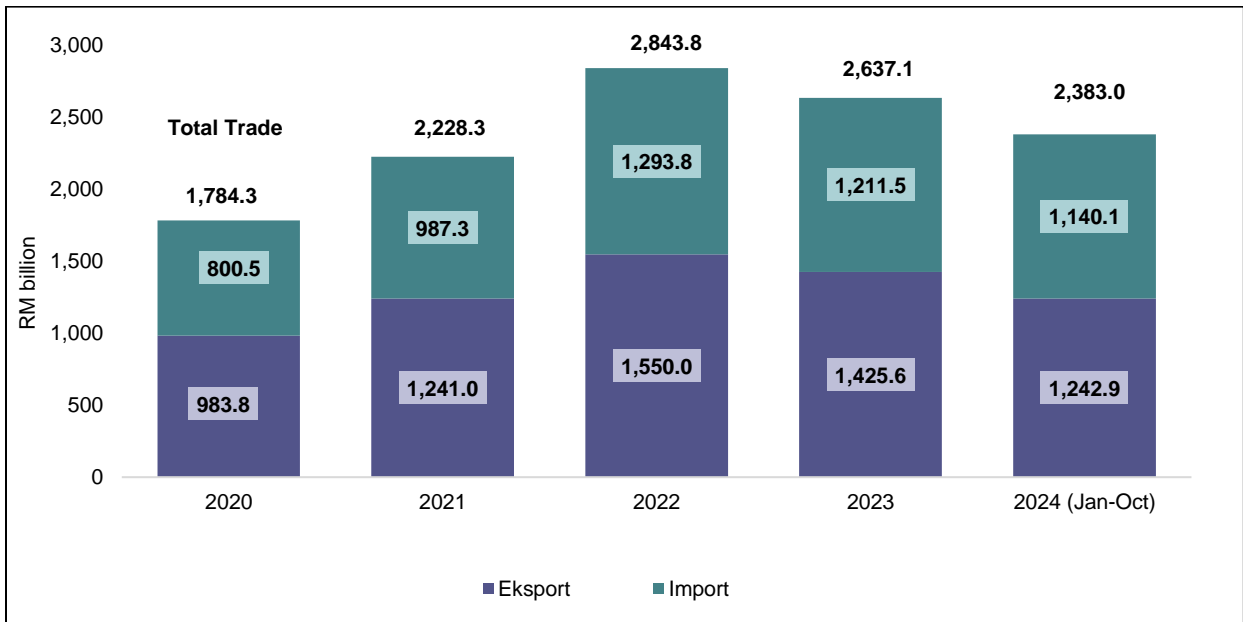


Chart 4: Imports for End Use & Broad Economic Categories (BEC) Classification, Jan 2023 – Oct 2024
(Value and Annual Percentage Change)

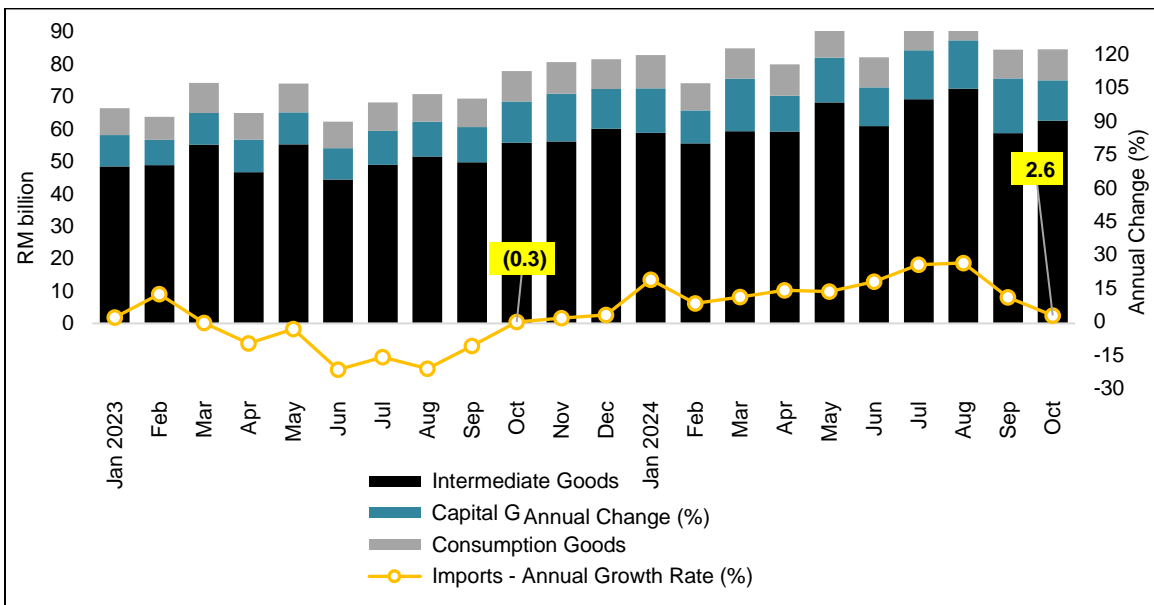


Chart 5: Imports for End Use & Broad Economic Categories (BEC) Classification, 2020 – 2024 (Jan-Oct)

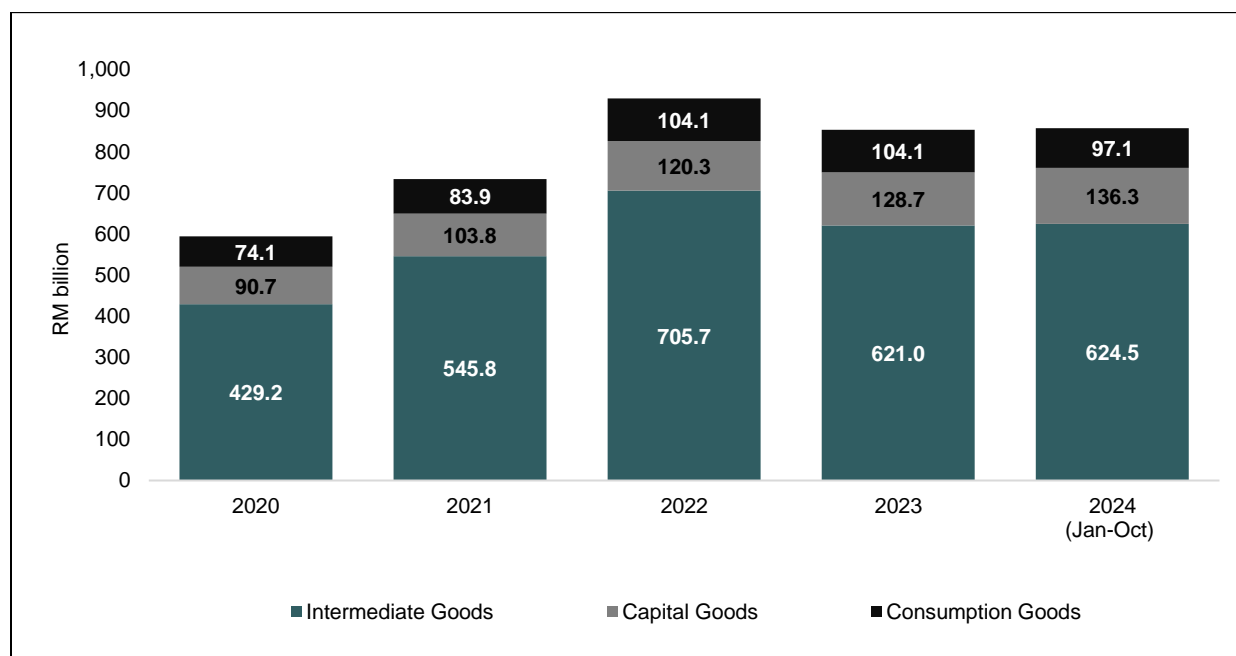
