



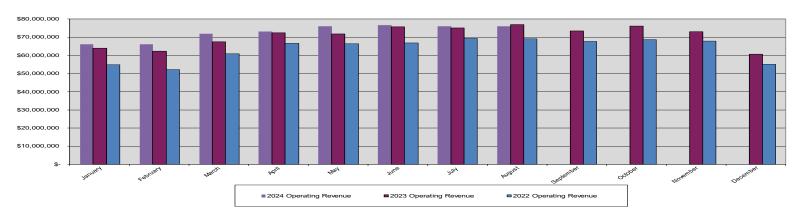

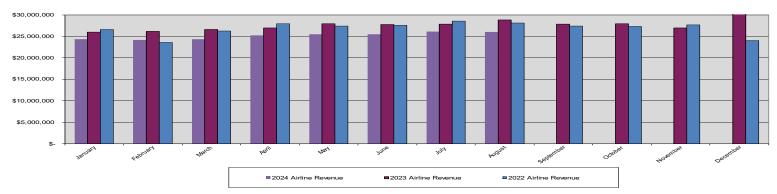

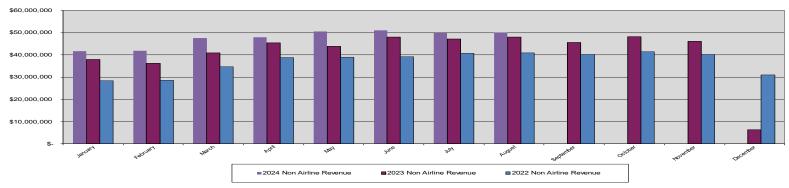

Metropolitan Washington Airports Authority Financial Statements August 2024 Aviation Enterprise Fund – Highlights in Brief

- Total operating revenues for the Aviation Enterprise Fund for August 2024 were \$76.0 million, which is relatively the same as July 2024.
- Operating revenues of \$582.0 million through August 2024 were an increase of \$16.2 million from 2023 totals primarily due to increases in concessions of \$28.8 million, other revenues of \$1.5 million, utility sales of \$0.3 million and passenger conveyance fees of \$0.3 million offset by decreases in landing fees of \$8.1 million, international arrival fees of \$4.8 million, rents of \$1.6 million and security fees of \$0.3 million.
- Total operating expenses for the Aviation Enterprise Fund during the month of August 2024 were \$62.0 million, which is \$5.2 million lower than July 2024 mostly due to decreases in services of \$3.8 million, salaries and related benefits of \$0.8 million, materials and supplies of \$0.4 million, utilities of \$0.3 million and depreciation and amortization of \$0.2 million offset by an increase of \$0.3 million in insurance.
- Operating expenses of \$504.5 million through August 2024 were \$42.6 million higher than 2023 primarily due to increases in salaries and related benefits of \$21.8 million, services of \$16.4 million, materials and supplies of \$2.7 million, utilities of \$2.5 million, travel of \$0.2 million, and lease from U.S. government of \$0.1 million offset by decreases of \$0.9 million in depreciation and amortization and telecommunications of \$0.3 million.
- Operating income for the Aviation Enterprise Fund in August 2024 was \$14.0 million compared to operating income of \$8.8 million in July 2024.
- Year-to-date operating income through August 2024 was \$77.5 million compared to operating income of \$103.9 million through August 2023.

- In August 2024 there were net non-operating revenues of \$11.7 million compared to net non-operating revenues in July 2024 of \$15.8 million primarily due to an increase in interest expense of \$2.9 million, a decrease in investment gain of \$2.3 million offset by an increase in passenger facility charges of \$1.0 million and a decrease in contributions to other governments of \$0.1 million.
- Net non-operating revenues through August 2024 were \$125.7 million compared to net non-operating revenues of \$97.3 million through August 2023 primarily due to increases in investment gain of \$30.9 million, federal, state and local grants of \$5.4 million, passenger facility charges of \$5.1 million and a decrease in contributions to other governments of \$0.5 million offset by an increase in interest expense of \$7.4 million and a decrease in fair value gain on swaps of \$6.0 million.
- Total capital contributions for the Aviation Enterprise Fund for the month of August 2024 were \$1.4 million compared to \$0.2 million in July 2024.
- Year-to-date capital contributions were \$9.8 million compared to \$26.7 million in 2023 due to a decrease in federal, state and local grants of \$16.9 million.
- There is an increase in net position for the Aviation Enterprise Fund for the month of August 2024 of \$27.1 million compared to an increase of \$24.8 million for the prior month.
- The year-to-date increase in net position through August 2024 was \$213.0 million compared to a year-to-date increase of \$227.9 million through August 2023.
