





Enhancing Skills in South Asia: Workshop on Adapting ITIs to Future Work Demands in New Delhi

In a co-organising initiative, the International Organisation of Employers (IOE), the Confederation of Indian Industry (CII), the Employers Federation of India (EFI), and the Global Apprenticeship Network (GAN) hosted the "Workshop on Developing and Upgrading Skills in South Asia for the Manufacturing and Industrial Sectors" from 27 to 28 June 2024, in New Delhi, India.

With the objective of raising awareness on the need for Industrial Training Institutions (ITIs) to adapt to the future of work and the necessity for higherlevel skills through Work-Based Learning (WBL) and apprenticeships, the workshop showcased best practices from India. It analysed and discussed case studies and success stories of apprenticeship initiatives and WBL programs, while also sharing recommendations for upgrading ITIs and Technical and Vocational Education and Training (TVET) institutions. Private sector initiatives were underscored as vital in promoting quality apprenticeships and the shift from lifetime employment to lifetime employability. Furthermore, the sessions covered, inter alia, the identification of key challenges, linkages, and opportunities, as well as tools for advocating for increased funding for vocational programs in the manufacturing and industrial sectors to support continuous retraining in companies, TVET, and educational institutions.

Recognising the importance of adapting to job market needs, responding to skill shortages, and embracing a multistakeholder approach, the workshop brought together over 47 people, including government officials, employer associations, and private companies from India, neighbouring countries, and beyond. Panellists included Mr Atul Kumar Tiwari, Secretary, Ministry of Skills Development & Entrepreneurship, Government of India; Mr Ravi Peiris, Officer-in-Charge & Senior Specialist – Employers Activities, ILO Decent Work Technical Support Team (DWT) for South Asia and Country Office for India; Mr Ved Mani Tiwari, CEO & Managing Director, National Skills Development Corporation – Government of India, Captain Amitabh, Head Skill Development,

Tata Steel; Mr Sunil Chemmankotil, Country Manager, Adecco India; as well as representatives from Bühler, dsm-Firmenich, and Nestlé.

With the support of co-funding by the European Union, the workshop provided an excellent opportunity for peer-to-peer learning while fostering collaboration between government, TVET institutions, businesses, and other stakeholders in skills development. It offered participants a platform for exchanging insights on challenges faced in their respective contexts and collaborating on finding solutions to issues such as the need for adaptation of vocational trainings, WBL, and skills development initiatives related to the evolving labour market in the manufacturing and industrial sectors. It also featured an industry visit to the Hero MotoCorp Ltd manufacturing plant in Gurugram.

The workshop also informed the drafting process of a policy review on the future of the workforce in the industrial sector, including apprenticeship and workbased learning best practices from India and/or other countries in Southeast Asia, which will be published by IOE and GAN in the second half of 2024.
