Foreword

T-Mobile US, Inc. set out to change the game as America's supercharged Un-carrier. We have built America's largest and fastest 5G network to serve everyone, delivering transformational nationwide connectivity with more coverage, faster speeds, and greater capacity. Our 100% customer commitment has changed the wireless industry for good, fostering competition and innovation while relieving customer pain points. It's what makes us the Un-carrier, and we won't stop.

We are the wireless team leading 5G innovation, and 2023 was another record-breaking year for T-Mobile. We achieved a massive 1.3 million postpaid net account additions and added over 2.1 million high-speed internet customers, the highest in company history. Thanks to the passage of the 5G Sale Act, T-Mobile was able to light up new spectrum covering nearly 300,000 square miles and serving 60 million customers after gaining access to 7,000 2.5 GHz licenses it purchased via auction in 2022. With a bold outlook in 2024 that includes supercharging our 5G innovation, continuing to invest in 5G infrastructure and connectivity, and a laser-like focus on our customer base, we look to position ourselves as the wireless leader for the foreseeable future.

T-Mobile works hard to set our industry up for success. T-Mobile engages in the political process through corporate political contributions, employee political action committee (PAC) contributions, direct lobbying, contributions to tax-exempt organizations, and our memberships in trade associations and coalitions. Because public policy shapes the way the telecommunications industry is regulated and has a large impact on our business, engaging in the political process helps us ensure our industry grows more competitive, resilient, and responsive alongside us. Through our political activities, we use our brand and scale to deliver more for shareholders, consumers, and employees.

T-Mobile is transparent in disclosing the issues and candidates we advocate for. This Report lists our 2023 PAC contributions, corporate political contributions, and independent expenditures. It also lists memberships in major trade associations and issue-advocacy organizations. The Report links to our <u>federal lobbying reports</u> and lists organizations that use a portion of our contributions to lobby. Past support for a candidate or an organization does not entail current or future support. Corporate and political action committee contributions are bipartisan and transparent, and all transactions are vetted and approved by the Vice President of Government Affairs.

A few core principles guide our political activities. We act in the best interests of our customers and employees; we are strictly compliant with local, state, and federal laws; our political contributions are bipartisan in nature; and we strictly adhere to our <u>Code of Business Conduct</u> and our <u>Corporate Responsibility Report</u>.

We strive to supercharge access and innovation through public policy by:

- Expanding access to wireless spectrum so we can continue leading the industry in 5G;
- Promoting spectrum policies that allow for new services, advance innovation, and the additional spectrum we need to power an increasingly interconnected world;
- Maintaining fiscal and tax policies that encourage us to invest in people and infrastructure; and
- Expanding affordable access to broadband services to unserved and underserved communities.

We advocate for our shareholders, employees, and customers in the following ways:

Political Giving Overview

T-Mobile participates in the political giving process at the federal and state levels. Candidates who are considered for PAC or corporate political contributions meet one or more of the following criteria:

- The candidate shares T-Mobile's views on important issues directly related to our business goals;
- The candidate is amenable to learn and understand more about public policy issues that affect our business;
- The candidate represents geographical areas where we have a large employee concentration; and/or
- The candidate demonstrates leadership, potential for leadership, and/or has key committee assignments within Congress or state government.

T-Mobile's political giving is bipartisan, and the resources are comparably spent between both political parties. This includes supporting both Democratic and Republican national party committees and organizations. T-Mobile does not make contributions to independent expenditure-only committees (i.e., super PAC's) and does not contribute to ballot initiatives. Our political giving is not based upon party affiliation, positions taken on non-company related issues, or in anticipation of, in recognition of, or in return for, an official act. In addition, political giving is made without regard for the private political preferences of company executives. All T-PAC contributions are approved by the Vice President of Government Affairs and contributions are properly reported monthly with the Federal Election Commission (FEC), within applicable limits, and consistent with all other laws.

Political Action Committee (PAC)

T-PAC is T-Mobile's federal political action committee, a separate, segregated fund established by T-Mobile, but funded entirely by voluntary contributions from eligible employees. Federal election law prohibits corporations from using corporate dollars to make political contributions to candidates running to federal office. T-PAC allows the company to financially contribute to the federal election campaigns of candidates and in some states where applicable by law.

As the Un-carrier, we're in the business of amplifying voices – which T-PAC helps us do. T-PAC gives individual donors who might not otherwise be involved in the political process an opportunity to connect with policymakers who set the nation's agenda on topics relevant to T-Mobile's business and the wireless industry. T-PAC gives its members a way to collectively weigh in on the democratic process.

State Political Giving

Although federal law bars political contributions to federal candidates and their parties directly from corporate treasuries, some states allow corporate funds to be spent on political races. All 50 state capitals and the District of Columbia are important areas where laws, policy, and regulations are made, often adjusting floors or setting ceilings to existing federal laws. We give directly to state office candidates when doing so is permitted under state law and where it makes sense for our company priorities. All contributions are approved by the Vice President of Government Affairs and no matter the state, we ensure that our donations are properly reported, within applicable limits, and consistent with all other laws. This report reflects all state giving in 2023.

Trade Associations and Other Tax-Exempt Organizations

T-Mobile actively participates in trade associations, coalitions, and other tax-exempt organizations. Trade association members are often several companies in a similar industry that band together to make their industry's voice heard in government. For the wireless industry, trade associations are able to explain wireless networks, advocate for wireless services, and, at times, contribute through their PACs to candidates and officials who want the industry to succeed. Sometimes policy issues affect T-Mobile alone but oftentimes new rules can challenge the entire industry. Trade organizations coordinate the work, comingling the voices of many. Coalitions and other tax-exempt advocacy organizations are similar in that they are a group of stakeholders that work together around a common goal, issue, and/or policy change.

This Report identifies T-Mobile's significant donations to trade associations and coalitions (501(c)(4) and 501(c)(6) organizations) where we give over \$25,000 annually. Just like with our PAC and state giving, we value accountability in our memberships. We also value our independence. Donating to trade associations or coalitions does not make our competitive instincts any less fierce, but collaborating with these groups allows us to team up with like-minded companies on ways to improve business conditions for the wireless sector as a whole.

Lobbying

Good public policy rests on relationships and storytelling. Lobbying gives us the opportunity to do both. T-Mobile engages in lobbying with its own employees on the state and federal government affairs teams and through the use of outside consultants. They are viewed as the liaisons between government officials and the company. Relationships built with policymakers afford our advocates additional avenues of communication to help ensure the nation's laws are written and interpreted to allow T-Mobile to continue to innovate in the ways that have made us the largest, fastest, and most reliable 5G wireless operator in the nation. By explaining how wireless connectivity can transform lives, T-Mobile helps officeholders understand the real story of our company, our customers, and our employees. T-Mobile complies with all lobbying laws and requirements at both the federal and state levels for registration and reporting as applicable by law.
