## ORDER REVISING HEARING SCHEDULE

Issued: November 14, 2024 Released: November 14, 2024

1. Discovery was suspended in the above-captioned hearing proceeding from July 23, 2024,

to November 4, 2024, to allow for resolution of a potential attorney conflict issue.<sup>1</sup> As the Presiding Judge requested, the parties have proposed updated hearing schedules.<sup>2</sup> Those proposals are the same with respect to preliminary matters not directly related to the in-person hearing portion of the case and those dates are adopted herein. Beginning with the date for exchanging exhibits, witness lists, and written direct testimony, however, the proposed schedules diverge significantly. The most recent hearing schedule, adopted by the Presiding Judge on April 16, 2024, allotted just over six weeks between the deadline for the parties' responses to any motion for summary decision and the deadline for the parties' exchange of exhibits, witness lists, and written direct testimony.<sup>3</sup> Antonio Cesar Guel, through counsel Dan J. Alpert, proposes a 10-day period between those two deadlines and just over two months between the deadline for filing objections to that anticipated evidence and the start of the in-person hearing. The FCC's Enforcement Bureau's proposed schedule calls for three-and-a-half months between the date the summary decision response is due and the deadline for exchange of exhibits, witness lists, and written direct testimony. Its schedule would have the hearing begin approximately one month after that.

- 2. Mr. Guel filed a motion for summary decision earlier in this proceeding, which was denied by the Presiding Judge.<sup>4</sup> In the event that additional motions for summary decision are filed, which is foreseeable, Mr. Guel's proposed schedule does not allow sufficient time for resolution of those motions before the parties would be required to exchange information in preparation for the in-person hearing.<sup>5</sup> Both parties have requested scheduling accommodations participating Bureau counsel has military service obligations at the beginning of June, and Mr. Alpert has indicated that he will be unavailable from April 14, 2025, through June 16, 2025, due to his upcoming wedding and honeymoon trip. Taking those requests into consideration, the Presiding Judge believes that the schedule proposed by the Enforcement Bureau is the most efficient way to proceed. It provides time for consideration of any motions for summary judgement and represents the most logical breaking point in the pre-hearing process to allow for counsels' requested outside activities. In the end, the in-person hearing would begin less than a month later than the date proposed by Mr. Guel, which does not represent unreasonable delay under the circumstances.
- 3. Accordingly, the Presiding Judge modifies the hearing schedule for the above-captioned proceeding as follows:

Deadline for Completion of Discovery December 6, 2024

Deadline to Request Hearing on a Written Record<sup>6</sup> January 6, 2025

Deadline to File Motion for Summary Decision February 7, 2025
