## ORDER SCHEDULING STATUS CONFERENCE

Issued: August 9, 2024 Released: August 9, 2024

1. On July 22, 2024, the FCC's Enforcement Bureau filed an Emergency Motion for a Status Conference in the above-captioned proceeding. The Bureau raised concerns that counsel for Antonio Cesar Guel indicated that he planned to simultaneously represent Jennifer Juarez and Maria Guel

in upcoming depositions in this proceeding that had been scheduled to begin on July 29, 2024.<sup>1</sup> On July 23, the Presiding Judge issued an order suspending discovery in this proceeding, which had been scheduled to close on July 30, 2024.<sup>2</sup> Mr. Guel filed a response to the Bureau's Emergency Motion on July 26, 2024.<sup>3</sup> On July 30, the Enforcement Bureau submitted a Motion for Leave to File a Reply to Mr. Guel's response to the Emergency Motion. The Bureau contends that Mr. Guel's response does not accurately reflect the record of this proceeding or the proper legal standard of review.<sup>4</sup>

- 2. The question of whether counsel for Mr. Guel may simultaneously represent Mr. Guel, Jennifer Juarez, and Maria Guel in this proceeding must be resolved before their depositions can go forward. Due to the importance of this issue, the Presiding Judge grants the Enforcement Bureau's Motion for Leave and accepts its Reply, also filed on July 30.<sup>5</sup> For the same reason, she grants the Enforcement Bureau's request for a status conference to discuss the proposed representation.
- 3. Accordingly, **IT IS ORDERED** that a status conference in the above-captioned proceeding will be held on **Wednesday**, **August 14**, **2024**, **at 10:00 AM** at FCC Headquarters, Room 1.400, 45 L Street, N.E., Washington, DC.<sup>6</sup>
- 4. **IT IS FURTHER ORDERED** that the Enforcement Bureau's Emergency Motion for a Status Conference, filed on July 22, 2024, **IS GRANTED** to the extent indicated herein.
- 5. **IT IS FURTHER ORDERED** that the Enforcement Bureau's Motion for Leave to File a Reply, filed on July 30, 2024, **IS GRANTED**, and the Enforcement Bureau's Reply, filed on July 30, 2024, **IS ACCEPTED** into the record of this proceeding.
