**WIRELINE COMPETITION BUREAU AND OFFICE OF ECONOMICS AND
ANALYTICS REVISE PUBLIC RELEASE VERSION OF TECHNICAL APPENDICES
FOR INCARCERATED PEOPLE'S COMMUNICATIONS SERVICES DRAFT
REPORT AND ORDER, ORDER ON RECONSIDERATION, CLARIFICATION AND
WAIVER AND FURTHER NOTICE OF PROPOSED RULEMAKING**

WC Docket Nos. 23-62 and 12-375

By this Public Notice, the Wireline Competition Bureau and Office of Economics and Analytics announce the availability of revised public release versions of the technical appendices in connection with the draft circulated Report and Order, Order on Reconsideration, Clarification and Waiver, and Further Notice of Proposed Rulemaking. The circulated draft was released to the public on June 27, 2024 and is scheduled for consideration by the Commission at its July open meeting scheduled for Thursday, July 18, 2024.¹ The revised technical appendices remove redaction of certain information deemed non-confidential subsequent to public release.²
