ERRATUM

WIRELINE COMPETITION BUREAU ANNOUNCES ADDITIONAL 120 RATE-OF-RETURN CARRIER STUDY AREAS ELECTING INCENTIVE REGULATION FOR THEIR BUSINESS DATA SERVICES

WC Docket No. 17-144

On July 11, 2024, the Wireline Competition Bureau released a *Public Notice*, DA 24-667, in the above captioned proceeding.¹ To correct the total number of rate-of-return carrier study areas have elected BDS incentive regulation as a result of the 2019, 2020, and 2024 elections, this Erratum amends the second page of the *Public Notice*, in the third paragraph, by replacing the number “347” with “348.”² To correct the listing of “Rate-of-Return Carriers Electing Incentive Regulation for Business Data Services Effective July 2, 2024,” this Erratum also amends the Appendix of the *Public Notice* by adding the entry of Blue Valley Tele-Communications, Inc., KS, Study Area Code (SAC) 411746,³ in alphabetical order, and deleting the entry of Buckland Telephone Company, OH, SAC 300589.⁴
