PUBLIC SAFETY AND HOMELAND SECURITY BUREAU REMINDS PUBLIC SAFETY LICENSEES WITH MULTIPLE LICENSES TO UPDATE CONTACT INFORMATION WITH AN EMAIL ADDRESS

WT Docket 19-212

By this Public Notice, the Public Safety and Homeland Security Bureau (PSHSB or the Bureau) reminds part 90 and part 101 public safety licensees to update their license contact information with an email address. To promote customer service to public safety licensees, and as a supplement to the current courtesy email process, the Bureau will send a reminder email to licensees associated with multiple licenses to update this vital piece of information for each of their licenses. Licensees without valid or updated email addresses will not receive courtesy electronic reminders regarding license expiration or construction deadlines.¹ Failure to timely file renewal applications and construction notifications may lead to license cancellation, regardless of whether the licensee has received a courtesy reminder.²

Background. In 2020, the Federal Communications Commission (Commission) issued rules to finalize the transition to electronic interactions for licenses in the Wireless Radio Services.³ In particular, the Commission eliminated the mailing of paper courtesy reminder notices and other Universal Licensing System (ULS) correspondence to licensees and adopted rules mandating electronic delivery for all ULS compulsory and courtesy correspondence.⁴ On June 29, 2021, electronic filing for all Wireless Radio Service applications began.⁵ On January 20, 2022, the Bureau encouraged licensees without a valid email address to update their email address in ULS and reminded licensees to file timely renewal applications and construction notifications.⁶

Outreach. Currently, the Bureau emails public safety licensees on an individual license basis. To supplement that process, the Bureau will email current licensees with multiple licenses or associated licenses a courtesy reminder to update all licenses with an email address. In addition, the Bureau encourages

licensees to use an email address associated with an agency title in lieu of a personal email, as job duties and personnel changes can lead to outdated or invalid email addresses.

Licensees Without A Valid Email Address. For licenses without a valid or updated email address, the Bureau reminds such licensees that they will not receive courtesy electronic reminders regarding license expiration or construction deadlines.⁷ This is important because failure to timely file renewal applications and construction notifications may lead to license cancellation, regardless of whether the licensee has received a courtesy reminder.⁸
