## WIRELINE COMPETITION BUREAU ANNOUNCES COMMENT DATES FOR ROBOCALL MITIGATION DATABASE NOTICE OF PROPOSED RULEMAKING

GN Docket No. 24-213; MD Docket No. 10-234

**Comment Date: October 15, 2024**

**Reply Comment Date: November 12, 2024**

By this Public Notice, the Wireline Competition Bureau announces that comments in response to the *Robocall Mitigation Database Notice of Proposed Rulemaking*<sup>1</sup> are due no later than October 15, 2024, and reply comments are due no later than November 12, 2024.<sup>2</sup>

In the *Notice*, the Commission seeks comment on additional measures to improve the effectiveness of the Robocall Mitigation Database, a critical tool in the Commission's efforts to ensure compliance with its caller ID authentication and robocall mitigation rules and protect the public from harms caused by illegal robocalling campaigns. The *Notice* seeks comment on procedural measures to promote the highest level of diligence when providers submit required information to the Robocall Mitigation Database, technical validation solutions to identify data discrepancies in filings, and accountability measures to ensure and improve the overall quality of submissions in the Robocall Mitigation Database.<sup>3</sup> The *Notice* and the *Federal Register Notice* contain complete comment filing instructions.<sup>4</sup>
