**PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES
REGION 54 (SOUTHERN LAKE MICHIGAN) 700 MHZ AND 800 MHZ REGIONAL

The Region 54 (Southern Lake Michigan)¹ 700 MHz and 800 MHz Regional Planning Committees (RPCs) will hold virtual planning meetings via Microsoft Teams on Friday, October 21, 2022 at 9:00 a.m. (Central Time). The Region 54 Regional Planning Committee meetings are open to the public. All eligible public safety providers whose sole or principal purpose is to protect the safety of life, health, or property in the Southern Lake Michigan area may utilize these frequencies. ¹ The Region 54 (Southern Lake Michigan) 700 MHz RPC encompasses counties in three states bordering Lake Michigan: Winnebago, McHenry, Cook, Kane, Kendall, Grundy, Boone, Lake, DuPage, DeKalb, Will, and Kankakee Counties, Illinois; Lake, LaPorte, Jasper, Starke, St. Joseph, Porter, Newton, Pulaski, Marshall, and Elkhart Counties, Indiana; and Kenosha, Milwaukee, Washington, Dodge, Walworth, Jefferson, Racine, Rock, Walworth, Washington, and Waukesha Counties, Wisconsin. The Region 54 (Southern Lake Michigan) 800 MHz NPSAC RPC includes the Michigan counties of Kent, Van Buren, Kalamazoo, Barry, Muskegon, Allegan, Berrien, Cass, and St. Joseph, in addition to all of the above-mentioned Illinois, Indiana and Wisconsin counties.

all government, Native American Tribal, and non-governmental organizations eligible under Section 90.523 of the Commission's Rules be represented to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not conversant with telecommunications technology should ensure that their respective agencies are represented by suitably conversant staff.
