NARUC Submits Nominees to New FERC-NARUC Current Issues Collaborative

WASHINGTON (July 22, 2024) — The National Association of Regulatory Utility Commissioners has submitted its list of nominees to the Federal Energy Regulatory Commission to serve on the new Federal and State Current Issues Collaborative. The new Collaborative is intended to expand on the body of work from the last three years of the Joint Federal-State Task Force on Electric Transmission.

As noted in FERC's March 21 statement, the Collaborative "will provide a venue for federal and state regulators to share perspectives, improve understanding and, where appropriate, identify potential solutions regarding challenges and coordination on matters that affect specific state and federal regulatory jurisdictions. Potential topics include exploring where best to coordinate between state and federal regulators on issues ranging from electric reliability and resource adequacy to natural gas-electric coordination, wholesale and retail markets, new technologies and innovations, and infrastructure."

NARUC received nearly 30 applications from state commissioners for 10 positions on the Collaborative. The nominees that follow represent each of the five NARUC regions across the United States:

"This Collaborative is an important and necessary step in continuing constructive dialogues between federal and state regulators," said NARUC President Julie Fedorchak. "Challenging issues such as resource adequacy, natural gas-electric coordination and infrastructure are among the matters facing state commissions."

The next step in the process is for FERC to accept and officially appoint the state commissioner participants from NARUC's list of nominees. Appointed participants will serve one-year terms that can be renewed for a total of three years. FERC plans to convene its first meeting in the fall
