**NOTICE OF TECHNICAL CONFERENCE**

**October 7, 2024**

**FORMAL CASE NO. 1178, IN THE MATTER OF THE PETITION FOR  
INVESTIGATION INTO WASHINGTON GAS LIGHT COMPANY’S SYSTEM LEAK  
REDUCTION PRACTICES**

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that the Commission will hold a second in-person technical conference in *Formal Case No. 1178* on Thursday, October 31, 2024, 10:00 am – 12 pm, in the Commission Hearing Room. The agenda is included in Attachment A.

2. By Order No. 22004, the Commission directed Washington Gas Light Company (“WGL”) to prepare materials to present at a technical conference on the topic “Best Methods for Leak Detection”, including responses to stakeholders’ filed comments.<sup>1</sup> The technical conference shall address “the most effective methods, both in terms of technology and procedures, for detecting natural gas leaks in urban environments,” including “both current practices and innovative approaches that may enhance accuracy and efficiency in leak detection.”<sup>2</sup> A previous technical conference was held on Friday, September 20, 2024, and discussions will be continued at this second conference. All presentations for the technical conference must be filed with the Commission by Monday, October 21, 2024, as outlined in Attachment A.
