## Public Hearing October 9 for 3.0 MW Solar Plant Proposed for Carroll County

(BALTIMORE, MD) – Local residents and other interested members of the public are invited to comment on a proposal by Chaberton Solar Pine Rock LLC to construct a 3.0 MW solar facility in Carroll County. The hearing will take place on **Wednesday, October 9, 2024 at 5:30 p.m.** before Public Utility Law Judge Kristin Case Lawrence, at Exploration Commons, Carroll County Public Library, 50 E. Main Street in Westminster.

In February 2024, Chaberton Solar Pine Rock applied to the Maryland Public Service Commission for what is known as a Certificate of Public Convenience and Necessity (CPCN), which grants an applicant the authority to construct an energy generating station or high-voltage transmission line in Maryland. According to the application, the solar facility, intended as part of Maryland's community solar program, would be built on approximately 18 acres of a 74-acre property located at 1151 Sullivan Road in Westminster.

The hearing will also have a virtual option for those unable to attend in person. Participants will receive an email with the link to join in on the virtual platform. The hearing will include a presentation by the developer, followed by brief statements from the Power Plant Research Program of the Maryland Department of Natural Resources, the Maryland Office of People's Counsel, and the Commission's Technical Staff, and then an opportunity for members of the public to comment on the proposed project.
