BY THE COMMISSION:

Red River Commodities, Inc. ("Red River") of Fargo, North Dakota, seeks authority to renew its grain dealer license pursuant to Neb. Rev. Stat. § 75-903 and 291 Neb. Admin. Code § 8-003. Red River was originally granted a grain dealer license on December 14, 2021, in Commission Docket No. GD-2775.1 Red River's most recent renewal of its license expired on September 30, 2024, at which time, Red River chose to delay renewing its license in order to obtain an outstanding document. Red River filed all outstanding documents with the Nebraska Public Service Commission on October 21, 2024.

Red River has also filed the required security in the form of a Grain Dealer Bond Endorsement with a bond amount of \$150,000 in compliance with 291 Neb. Admin. Code Ch. 8 §§ 003.2(D) and 003.04. Such security is for the benefit of any producer within the state who files a valid claim arising from a sale to a grain dealer. Red River has also filed a financial statement that meets the requirements of 291 Neb. Admin. Code Ch. 8 § 003.03.

Being fully advised on the matter, the Commission finds Red River has met the requirements of Nebraska law and Commission Rules and should therefore be issued a renewal of its grain dealer license.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. GD-2775, be, and is hereby granted,
