On April 5, 2024, Doing Time Transportation, LLC ("Applicant"), Omaha, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers in Open Class service by van between all points in Nebraska over irregular routes. HHS designation: No.

Notice of the Application was published in The Daily Record, Omaha, Nebraska, on May 9, 2024. On June 7, 2024, a timely protest was jointly filed by Camelot Transportation, Inc. and Triumph Transportation Inc. ("Protestants"). On June 18, 2024, the joint protest was granted.

On July 11, 2024, a planning conference was held with the parties in this matter to discuss a procedural schedule and hearing dates. The parties agreed that a hearing in this matter would be scheduled for Tuesday, August 27, 2024 at 1:30 p.m. CST in the Commission hearing room. On July 17, 2024, I entered a Hearing Officer Order approving this procedural schedule.¹

On August 2, 2024, Commission Staff was notified that the Applicant and Protestant in this matter had reached a settlement agreement. Per the agreement, Applicant and Protestants agree to the following proposed authority:

SERVICE AND TERRITORY AUTHORIZED: COMMON: Service by van in open class between all points in Nebraska over irregular routes. HHS: Designation: No.

RESTRICTION: The authority authorized shall be limited to the transportation of passenger originating or terminating at state or county correctional facilities within the State. The transportation of passengers for any other purpose, other than to arrive or depart correctional facilities is expressly prohibited.

Under the settlement agreement, protestants agree to withdraw their protest within 5 business days after Applicant amends its Application and the Commission enters an Order Amending the Application.² The withdrawal of the protest and cancelling the hearing will be determined in a subsequent order, since such withdrawal has been agreed to occur after the date of this order.

After due consideration, I find that Applicant's request to amend their application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Hearing Officer that Doing Time Transportation, LLC's request to amend their application should be, and is hereby, granted.
