OPINION AND FINDINGS

On May 23, 2023, the Nebraska Public Service Commission ("Commission") entered an order granting a suspension of authority for Careem Transportation, LLC. The suspension ended March 1, 2024. Careem Transportation, LLC did not reinstate their suspended authority by March 1, 2024.

On February 13, 2024, the Director of Transportation sent a letter to Careem Transportation, LLC that to resume providing services they must contact the Transportation Department and ensure that the following information was up to date: proof of insurance, vehicle equipment list, and the payment of per-vehicle fees.

On March 6, 2024, the Director of Transportation sent a letter to Careem Transportation, LLC that the suspension period had passed, and they had not completed the steps required to reactivate their transportation authority. The letter stated that failure to contact the Commission by April 8 would result in Commission action.

Careem Transportation, LLC has not taken the necessary steps to reinstate its authority, nor have they contacted the Department to cancel its authority.

After due consideration of the circumstances the Commission finds that Careem Transportation, LLC should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure to take the necessary

steps to reinstate their Certificate of Public Convenience and Necessity by April 8, 2024. Therefore, a hearing on this matter shall be held on **Wednesday**, **October 2**, **2024 at 2:00 p.m. Central Time** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.

IT IS FURTHER ORDERED that a hearing on this matter shall be set for Wednesday, October 2, 2024 at 2:00 p.m. Central Time as provided herein.
