BY THE COMMISSION:

By application filed June 10, 2024, with the Nebraska Public Service Commission ("Commission"), Dehy Alfalfa Mills, Inc. ("Applicant") of Arlington, Nebraska, seeks authority to operate as a grain dealer pursuant to Neb. Rev. Stat. § 75-903 and 291 Neb. Admin. Code § 8-003. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 22, 2024. No protests were filed; therefore, this docket is handled pursuant to the Commission's Rules of Modified Procedure.

Applicant has filed the required application fee and security in the form of a Bond in the amount of \$397,000 in compliance with 291 Neb. Admin. Code Ch. 8 §§ 003.2(D) and 003.04. Such security is for the benefit of any producer within the state who files a valid claim arising from a sale to a grain dealer. Applicant has also filed a financial statement that meets the requirements of 291 Neb. Admin. Code Ch. 8 § 003.03.

O P I N I O N   A N D   F I N D I N G S

Being fully advised on the matter, the Commission finds Applicant has met the requirements of Nebraska law and Commission Rules and should therefore be issued a grain dealer license.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. GD-3085, be and is hereby, granted, and Dehy Alfalfa Mills, Inc., is authorized to operate as a licensed grain dealer in the State of Nebraska.
