BY THE COMMISSION:

On April 25, 2024, Cosmos Coaches, LLC ("Applicant"), Omaha, Nebraska, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by Bus in Charter Service between all points in Nebraska over irregular routes. HHS Designation: No.

The Commission entered an Order granting Application No. B-2104 on July 23, 2024. The July 23rd Order stated that "Applicant shall not be issued the Certificate of Public Convenience and Necessity unless and until Applicant has fully complied, within a reasonable time from the effective date of this Order, with N.R.S. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) and with Commission rules and regulations, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect."

The Commission's Transportation Department sent Applicant a letter, dated July 23, 2024, requiring Applicant to file with the Commission, a Uniform Certificate for BI and PD ("Form E"), a completed copy of a description of vehicles form, and a completed application form for Applicant's proposed rates and charges.

Since the date that Applicant's rates were approved, Commission staff have contacted Applicant multiple times regarding whether Applicant wishes to continue their application and Applicant's need to make the required filings. On September 12, 2024, the Commission was notified that Applicant may be having difficulty obtaining the required insurance. To date Applicant has not filed the required documents.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication with the Commission by Cosmos Coaches, LLC, in Application No. B-2104, be, and is hereby, set for **Tuesday, December 3, 2024**.

IT IS FURTHER ORDERED that if Cosmos Coaches, LLC, fails to take action by **Tuesday, December 3, 2024** in Application No. B-2104, the Commission will exercise its authority to enter an order dismissing the application.
