OPINION AND FINDINGS

On August 20, 2024, the Nebraska Public Service Commission ("Commission"), on its own motion, opened a docket for Executive Coach, LLC ("Applicant"), Paxton, to show cause why its Certificate of Public Convenience and Necessity should not be revoked. A hearing on the matter was scheduled for October 2, 2024.

By application, received September 20, 2024, Applicant informed the Commission that it wished to voluntarily cancel its Certificate of Public Convenience and Necessity issued by the Commission in Application No. B-1822. The Certificate authorized Applicant to provide transportation of passengers (up to 20) by luxury bus/motor home, or van in charter and special party between points in Nebraska over irregular routes. HHS Designation: No.

On September 30, 2024, a hearing officer order cancelled the October 2, 2024, hearing.

Notice of the application for voluntary cancellation was published in The Daily Record, Omaha, Nebraska, on October 3, 2024. No protests were received.

Upon due consideration of this request, the Commission is of the opinion and finds that the request should be granted, and the authority granted to Executive Coach, LLC, Paxton, in Application No. B-1822 should be cancelled.

Further, the Commission finds that no adverse action should be taken against Executive Coach, LLC as part of the show cause proceeding. Therefore, the show cause docket in B-1822.01 should be dismissed.
