O P I N I O N A N D F I N D I N G S

On April 17, 2024, the Nebraska Public Service Commission ("Commission") received a Form K Insurance Cancellation Notice for Executive Coach, LLC, Paxton, which holds a Certificate of Public Convenience and Necessity under Application No. B-1822. The Form K received from Columbia Insurance Company notified the Commission that insurance coverage for Executive Coach, LLC would be cancelled effective May 19, 2024.

Commission regulations require that all carriers meet minimum insurance requirements and keep on file documents with the Commission that show proof of current insurance.<sup>1</sup>

On April 17, 2024, the Commission's Transportation Department informed Executive Coach, LLC via letter of the receipt of the cancellation notice and that they will not be in compliance with Commission regulations once their insurance is cancelled. On July 22, 2024 the Commission sent a second letter to Executive Coach, LLC, requiring that they cease and desist all operation until a new insurance policy is in force.

To date, the Commission has not received the required Form E Uniform Motor Carrier Bodily Injury and Property Damage Liability of Insurance filing from any insurance carrier to inform the Commission that Executive Coach, LLC has obtained the necessary insurance coverage.

After due consideration of the circumstances the Commission finds that Executive Coach, LLC should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure to maintain required liability insurance and provide proof of such insurance to the Commission in accordance with Rule 006.
