ORDER GRANTING MOTION

On August 13, 2024, pursuant to 20 VAC 5-205-10 E ("Rule 10 E") of the State

Corporation Commission's ("Commission") Rules Governing Utility Rate Applications and

Annual Informational Filings of Investor-Owned Gas Utilities ("Rate Case Rules"), Washington

Gas Light Company ("WGL" or "Company") filed a Motion for a Waiver of Requirement to File

Notice of Intent to File an Application ("Motion") requesting that the Commission waive the

requirement of 20 VAC 5-205-10 A ("Rule 10 A") of the Rate Case Rules that directs the

Company to file a notice of intent to file an application pursuant to the Rate Case Rules 60 days

prior to the application filing date.²

In support of its Motion, the Company states that its SAVE Rider for 2025 will be effective from the first billing cycle date of January 2025.³ WGL further states that it intends to file its application for approval of the SAVE Rider for 2025 on or before September 15, 2024.⁴ WGL states that to comply with Rule 10 A, it should have submitted a notice of intent to file an

application on or before July 12, 2024.⁵ The Company states that due to an administrative oversight and lack of familiarity with the new Rules, it did not do so.⁶

Rule 10 E allows the Commission to "waive any part or all of this chapter for good cause shown" and WGL asserts that there is good cause to waive the 60-day notice requirement of Rule 10 A.⁷ The Company represents that it has discussed this request with Commission Staff ("Staff") and is authorized to state that Staff does not oppose the Motion.⁸

NOW THE COMMISSION, upon consideration of the foregoing, is of the opinion and finds that WGL's Motion should be granted.

Accordingly, IT IS ORDERED THAT:

- (1) This matter is docketed and assigned Case No. PUR-2024-00146.
- (2) WGL's Motion is granted.
- (3) WGL shall file its 2025 SAVE filing in this docket.
- (4) This case is continued.
