ORDER FOR REVISION OF CERTIFICATE

On May 30, 2024, the Division of Public Utility Regulation of the State Corporation Commission ("Commission") received letters and a detailed map from Virginia Electric and Power Company ("Dominion") and Shenandoah Valley Electric Cooperative ("SVEC"), requesting a revision to Certificate E-L38 for SVEC and Dominion to change the respective boundary line between their service territories. These documents were filed with the Clerk of the Commission on May 31, 2024, in what is now docketed as Case No. PUR-2024-00099.

SVEC and Dominion have reached an agreement ("Agreement") for the adjustment of the electric utility service territory boundary line between them as it relates to the provision of electric service to Lots 71, 72, 73, and 74 on Morningview Court and Lot 99 on Rebecca Court, Overlook Subdivision, Augusta County, Virginia ("Property"). Pursuant to the Agreement, Dominion would serve the Property. The Agreement states SVEC and Dominion agree that the adjusted boundary line would benefit all and will eliminate operational confusion.

In the interest of time and to avoid further delays in providing electric service to the affected Property, Dominion and SVEC request that the Commission approve the changes discussed herein and revise their respective service territory boundary line accordingly.

NOW THE COMMISSION, having considered Dominion's and SVEC's request, is of the opinion and finds that it is in the public interest to amend Certificate E-L38 to revise the service territory boundary line as requested. We are advised that the Property owner has notice thereof and agrees with the requested revision of this boundary line.

Accordingly, IT IS ORDERED THAT:

- (1) Certificate E-L38 for Dominion is amended as delineated on Map L38.
- (2) Certificate E-L38 for SVEC is amended as delineated on Map L38.
- (3) The amended certificate and map shall be sent to SVEC and Dominion by the Division of Public Utility Regulation forthwith.
 - (4) This matter is dismissed.
