Supplemental Assessment for Taxation of the Public Service Company Property Located Within Bull Run Mountain, Lake Jackson, and Occoquan Forest Sanitary Districts for the Tax Year 2024

SUPPLEMENTAL ASSESSMENT ORDER

Pursuant to §§ 58.1-2680 through 58.1-2683 of the Code of Virginia ("Code"), the State Corporation Commission ("Commission") is required to furnish to the board of supervisors or other governing body and to the commissioner of the revenue or person performing the duty of such officer a certified copy of the assessment made by the Commission of such property or a certified copy of a statement of such assessment where the property reported to the Commission for assessment is subject to local taxation and is in sanitary districts located within Prince William County. As required by Code § 58.1-2681, the assessment, or statement thereof, shall definitely show the character of the property and its value and location for purposes of taxation in each district within the county so that the proper district levies may be laid.

NOW THE COMMISSION, upon consideration of the matter, is of the opinion and finds that public service corporations have reported real or personal property located within the Bull Run Mountain, Lake Jackson, and Occoquan Forest Sanitary Districts in Prince William County that should be subject to Code §§ 58.1-2680 through 58.1-2683.

Accordingly, IT IS ORDERED THAT a certified copy of the assessment showing the equalized value of the aforementioned real or personal property, as assessed by the Commission,

shall be provided to Prince William County in accordance with Code § 58.1-2681. Said statement is attached hereto for each public service corporation that reported property within any sanitary district within Prince William County for the Tax Year 2024.

A COPY of this Order shall be sent by the Clerk of the Commission to Todd H. Andrews, Director of the Commission's Public Service Taxation Division, who shall cause a copy thereof to be provided to the Board of Supervisors and the Director of Finance for the County of Prince William, Virginia; Northern Virginia Electric Cooperative; Virginia Electric and Power Company; Cellco Partnership; New Cingular Wireless PCS, LLC; and Verizon South Inc.
