## **HEARING EXAMINER'S RULING**

## August 14, 2024

On March 29, 2024, Appalachian Power Company ("APCo" or "Company") filed an application ("Application") with the State Corporation Commission ("Commission"), pursuant to § 56-585.8 of the Code of Virginia ("Code") for a biennial review of the Company's rates, terms and conditions for the provision of generation and distribution services.

On April 25, 2024, the Commission issued its Order for Notice and Hearing in which, among other things, the Commission: (i) scheduled a telephonic hearing for September 9, 2024, at 10 a.m. to receive the testimony of public witnesses; (ii) scheduled an in-person public evidentiary hearing for September 10, 2024, at 10 a.m.; (iii) directed the Company to provide notice to the public; (iv) provided interested persons an opportunity to comment on the Company's Application; and (v) appointed a Hearing Examiner to rule on any discovery matters or *pro hac vice* motions that may arise during the course of this proceeding.

On August 13, 2024, APCo filed a Motion for Admission *Pro Hac Vice* ("Motion"). Andrew J. Flavin, Esquire, of Troutman Pepper Hamilton Sanders LLP ("Troutman") and a member of the Virginia State Bar, moved the admission *pro hac vice* of Mary-Kaitlin E. Rigney, Esquire, to practice before the Commission in the captioned proceeding. Mr. Flavin stated Ms. Rigney is associated with Troutman's Charlotte office located at 301 S College Street, Suite 3400, Charlotte, North Carolina 28202. He stated Ms. Rigney is a member in good standing of the State Bars of North Carolina and the District of Columbia. Mr. Flavin further represented Ms. Rigney will abide by the Commission's Rules of Practice and Procedure and will conduct herself as other attorneys admitted to practice before the Commission.

I am of the opinion, and find, the Motion should be granted. Accordingly,

IT IS DIRECTED THAT Mary-Kaitlin E. Rigney, Esquire, is hereby admitted *pro hac vice* in the instant proceeding.
