ORDER EXTENDING TIME FOR REVIEW

On August 2, 2024, Appalachian Natural Gas Distribution Company; ANGD, LLC; Utility Pipeline Holding Company, LLC; and Utility Pipeline, Ltd. (collectively, "Applicants"), filed an application ("Application")<sup>1</sup> with the State Corporation Commission ("Commission") pursuant to Chapters 3 and 4 of Title 56 of the Code of Virginia ("Code").<sup>2</sup> Together with the Application, Applicants filed a Motion For Entry of a Protective Order, pursuant to Rules 110 and 170 of the Commission's Rules of Practice and Procedure.<sup>3</sup>

Pursuant to Code § 56-61, the Commission must act on the Application within 25 days of its filing or the Application shall be deemed in fact and law to have been approved. As an alternative, the Commission may extend this period for up to an additional 30 days.

NOW THE COMMISSION, upon consideration of this matter and having been advised by the Commission Staff, is of the opinion and finds that the issues involved in the Application will require additional time for review. Therefore, it is appropriate, pursuant to Code § 56-61, to extend the 25-day period for an additional 30 days, through October 1, 2024.

Accordingly, IT IS ORDERED THAT:

- (1) This case is docketed and assigned Case No. PUR-2024-00139.
- (2) Pursuant to Code § 56-61, the period of time for review of the issues presented by the captioned Application is extended through October 1, 2024.
- (3) This case is continued.
