For approval to transfer indirect control of the Windstream Licensees and the Uniti Licensees, pursuant to Chapter 5 of Title 56 of the Code of Virginia, Va. Code § 56-88 et seq.

ORDER GRANTING APPROVAL

On June 24, 2024, Windstream Holdings II, LLC ("Windstream Holdings"), on behalf of its ten (10) subsidiaries that hold certificates of public convenience and necessity ("Certificates") issued by the State Corporation Commission ("Commission") (collectively, the "Windstream Licensees"), and New Windstream, LLC (collectively, with Windstream Holdings and the Windstream Licensees, "Windstream"); Uniti Group Inc. ("Uniti"), on behalf of its two

subsidiaries that hold Certificates from the Commission (the "Uniti Licensees");² Windstream Parent, Inc. ("Parent"); Elliott Investment Management L.P., on behalf of its advisory affiliates (collectively, "Elliott") and managed funds (the "Elliott Funds"); and certain funds and accounts managed, advised, or sub-advised by Pacific Investment Management Company LLC ("PIMCO") (such funds and accounts, collectively, the "PIMCO Funds") (Windstream, Uniti, the Uniti Licensees, Parent, Elliott, the Elliott Funds, PIMCO, and the PIMCO Funds are collectively the "Petitioners"),³ filed a Joint Petition ("Petition") with the Commission, pursuant to the Utility Transfers Act, Chapter 5 of Title 56 of the Code of Virginia ("Code"),⁴ requesting approval to transfer indirect control of the Windstream Licensees and the Uniti Licensees (collectively, the "Licensees") to Parent ("Transfer").⁵

The Petitioners also filed a Motion for Protective Order ("Motion") in accordance with Rule 5 VAC 5-20-170 of the Commission's Rules of Practice and Procedure.⁶

The Petitioners represent that the Transfer would be completed through a multi-step transaction that would result in Uniti and Windstream becoming subsidiaries of Parent, and thus the transfer of indirect control of the Licensees to Parent.

The Petitioners represent that the proposed Transfer will not involve any change to the operations of the Licensees. The Petitioners further state that the Licensees would continue to provide services at the same rates, terms, and conditions as currently provided. Lastly, the Petitioners assert that the Licensees would continue to have the financial, managerial, and technical resources to provide telecommunications services in Virginia following the completion of the proposed Transfer.⁷

NOW THE COMMISSION, upon consideration of this matter and having been advised by the Commission Staff in Staff's Action Brief, is of the opinion and finds that the above-described Transfer should be approved. The Commission also finds that the Petitioners' Motion is no longer necessary and, therefore, is moot.⁸

Accordingly, IT IS ORDERED THAT:

- (1) Pursuant to Code §§ 56-88.1 and 56-90, the Petitioners are granted approval of the Transfer as described herein.
- (2) The Petitioners shall file a report of action with the Commission's Document Control Center within thirty (30) days after closing of the Transfer, which shall note the date the Transfer occurred.
