HEARING EXAMINER'S RULING

July 26, 2024

On March 7, 2024, Virginia Electric and Power Company ("Dominion" or "Company") filed the Aspen-Golden Application with the State Corporation Commission ("Commission"). The Commission docketed the Aspen-Golden Application as Case No. PUR-2024-00032.

On March 27, 2024, Dominion filed the Apollo-Twin Creeks Application with the Commission. The Commission docketed the Apollo-Twin Creeks Application as Case No. PUR-2024-00044.

On April 17, 2024, the Commission issued an Order for Notice and Hearing in which, among other things, the Commission appointed a Hearing Examiner to conduct all further proceedings in these cases.


On July 10, 2024, I entered a ruling that a local public hearing in these cases should be scheduled. I noted the date and location of such hearing would be established by a subsequent ruling. The purpose of this ruling is to provide the local public hearing details. Accordingly,

IT IS DIRECTED THAT:

1. A local public witness hearing is scheduled for Thursday, September 5, 2024, commencing at 6:00 p.m. and concluding at 10:00 p.m., at Belmont Ridge Middle School, 19045 Upper Belmont Place, Leesburg, Virginia 20176; and

2. Any person desiring to testify as a public witness in this matter should arrive at least 15 minutes prior to the scheduled hearing and register to testify with the Commission's Bailiff. To promote fairness for all public witnesses, each witness will be allotted approximately five minutes to provide testimony.
