Nine Ardent Health Facilities Earn "A" Hospital Safety Grade From The Leapfrog Group

Leapfrog assigns an "A," "B," "C," "D" or "F" grade to general hospitals across the country based on over 30 performance measures reflecting errors, accidents, injuries and infections, as well as the systems hospitals have in place to prevent them.

"Ardent's commitment to providing exceptional, patient-centered care is our top priority, and we are honored that our hospitals have once again received 'A' grades from The Leapfrog Group," said Ardent President and CEO Marty Bonick. "Our facilities continue to perform above the national average, and this achievement reflects the dedication and expertise of the entire Ardent team, who work tirelessly to ensure safety, quality and compassion in the care we deliver each day."

For fall 2024, 81% of Ardent's eligible facilities earned an "A" or "B" Hospital Safety Grade compared to 56% of eligible hospitals nationally. The nine Ardent facilities that earned an "A" grade include:
